101. <u>Fiscal Year 2017 Regional Park Improvement Funds (RPIF)-Allocation</u> <u>Recommendations</u>

Presenter: Jim Winter, Project officer II, Asset Management Division, Park and Recreation Department

Mr. Winter's presentation to the members outlined the following recommendations:

- Report with Summary, Background and Discussion
- RPIF is derived from Mission Bay Park lease revenue per City Charter Section 55.2
- Prior Year Approved Allocations
- RPIF anticipated to receive \$3.85 million from the lease revenue generated in Mission Bay Park during FY2017
- Prior Year Approved Allocations
- Five-Year Plan Advantages
- Project Prioritization
- Fiscal Year 2017 Recommendations
 - Mohnike Adobe and Hay Barn Restoration (\$1 million)
 - Junipero Serra Museum ADA Improvements (\$5000,000)
 - Coastal Erosion and Access Annual Allocation (\$1 million)
 - West Mesa Comfort Station Replacement, Balboa Park (\$200,000)
 - California Tower Seismic Retrofit (\$650,000)
 - Chollas Lake Improvements (\$500,00)-a new project

Questions/comments from the committee:

- Mr. Kinney inquired if the California Tower Project will impact the Plaza De Panama Project in any way. Mr. Field responded that the two project will go simultaneously.
- Mr. Chavez wanted clarification on the report document as to what was meant by other funding identified. Mr. Winter responded that in many cases, along with the RPIF there may be a grant or another funding source to help. Mr. Chavez congratulated the Park and Recreation Department for the Natural Historical Landmark for the Chicano Park and inquired as to when the comfort station will be completed. Mr. Field respond that the document Mr. Chavez is referring to, is not a project update; this document shows how we intend to add RPIF's to a variety of projects. In the case of Chicano Park, mix of funding sources are being used. The project is very close to going into the construction phase. Mr. Barbrick will check to confirm. Mr. Field stated the project of the comfort station should be completed by the end of 2017.
- Mr. Diehl inquired if solar had been looked at Chollas Lake. Mr. Winter responded that solar will be looked at to see if that is a more economical was to proceed.
- Mr. Diehl wanted to know why we can get a new 4 acre park for \$3.5 million , yet all the improvement project seem to cost more and more than that for the value.

Is it because it's a new project? Or what drives up the price of redoing a park tot lot? Mr. Field responded that a new park you are working around green field development and there are no existing conditions. When dealing with an existing park you are dealing with existing conditions and existing conflicts and that is what drives the park cost up. The cost to do a park per acre is about a million per acres, but when you go into those constrained sites, where you are surround by very busy roads, a lot of underground utilities that have been around for decades and conflict with adjacent property owners, it doe drive the cost up.
