## **COMMITTEE COMMENTS:**

- Mr. Anastapolous asked if we have a centralized tennis facility.
- Mr. Baron thanked Mr. Zosa for his report about pickleball. It is a growing sport and may even become an Olympic sport in coming years. He also thanked Chair Bothwell for inviting the members to the San Diego Parks Foundation, (SDPF) reception at the Undertow. Very nice to participate.
- Mr. Becker thanked Ms. Bothwell for inviting the board to the SDPF reception at the Undertow Some time ago, board discussed Play All Day program with San Diego Unified School District (SDUSD). Asked if anything planned for Poway Unified School District?

• Mr. Zosa shared that the Article in Union-Tribune for a pickleball facility with focus on Peninsula Tennis Club at Robb Field becoming a central pickleball facility. P&R strategy is currently trying to install courts at various locations across the City. This is the fastest growing sport. Mr. Zosa recommended that the department look at the Peninsula Tennis Club and determine if it is being properly utilized and whether there could be other uses, especially with Barnes Tennis Center being so close. He disagreed with the scattering of pickleball into various locations because the players gather in groups, and they are social. They would like to gather in groups to play, and these types of sporting events would really help bring people together even from outside the City.

## • FY 2023 Budget Development and FY 2022 Budget Monitoring

Fees Update:

- Based on feedback from the Budget Committee, the Department modified its proposal as follows:
  - 1. Maintain Current Burial Fees for low-income families at Mt. Hope Cemetery
  - 2. Request cost of service studies for:
    - Non-resident parking at beach and bay parking lots
    - Non-resident mooring and beach bars
    - Non-resident boat launch fees for Mission Bay
  - 3. Removal of two proposed fees related to special events: Balboa Park ranger traffic control and use of golf carts
  - 4. Prepare new Council Policy for use of the proposed Opportunity Fund
- Department plans to present guiding principles for the use of the future Opportunity Fund at the April or May Public Safety and Livable Neighborhoods Committee meeting; staff will bring this to the Board around the same timeframe as well
- Through spring and summer 2022, the Department will obtain feedback on the potential uses of the Opportunity Fund then bring a formal policy proposal to the Board and PSLN Committee in fall 2022
- On 2/14/22, the City Council approved the fee schedule as amended by the Budget Committee.

- This is not the official 2022 update on the PMP, which is identified for regular reporting to be presented to the Public Safety and Livable Neighborhoods Committee as well as made available on the Parks for All of Us webpage
- As part of the director's report, Mr. Field will continue to keep Board members apprised as to the status of PMP implementation

## • Council Policy 700-42 and Community Recreation Group Update

- The Department continues to monitor the ongoing efforts to update the relationship between the City and the Community Planning Groups with a planned revision to Council Policy 600-24
- After the relationship is settled and Council Policy 600-24 revised, the Department will use the same guiding principles for a revision to Council Policy 700-42 on Community Recreation Groups
- When the time is right, we will bring this matter back to the Board for additional public input and guidance

   groups and advisory committees to vet potential locations


## • DeAnza Special Study Area

- On 1/11/22, the City issued a Revised Notice of Preparation (NOP) of a Programmatic Environmental Impact Report (PEIR) and Scoping Meeting that includes study of the preferred De Anza Natural option
- o On 1/24/22, the City held a public scoping meeting
- On 3/1/22, the Mission Bay Park Committee will have an informational update on the De Anza Natural preferred option
- o On 3/17/22, staff will bring this forward to the Board as an informational item

# • City Council Items:

- Proposed curfew at 3 Pacific Beach-area parks (PB Library Grounds, Fanuel Street Park, and Bob McEvoy Fields) approved by City Council on 6/8/21;
   Coastal Commission review pending
- Proposed modifications to on-leash dog approved hours for Mission Bay Park was approved by the Environment Committee on 1/20/22 and is pending City Council consideration
