- Mr. Otsuji had recommendations regarding Action Item 102
 - There should be additional tree canopy especially where described as an area for outdoor classrooms.
 - Use of asphalt on walkaround should be reconsidered (as opposed to decomposed granite) since asphalt is hot to walk/run on
 - The traffic circulation of the parking lot area may impact how drop-offs will work. The design seems to have created conflicts between pedestrians and vehicles.
- Public speaker Zach Jones agreed with Mr. Otsuji's comments about traffic conflicts; Mr. Jones explained that he lives across from Whitman Elementary; he agreed with the design, attended every meeting, vouched for the need for traffic calming, and suggests that speed bumps are needed to reduce traffic speeds and keep pedestrians safe.

- Last week, the San Diego Parks Foundation held its annual fund raiser, the Undertow at Torrey Pines. SDPF will look into increasing sponsorships to help build its donor

Public Speaker Comment: Armando Sepulveda

"How much water is projected to be used and how much is projected to be recycled? Will there be an increased amount of sustainable vegetation at this park that are not water-intensive with good mix of native plants.? I am supportive of the project and live in condos near Rhodes Avenue. Focus on sustainability."

Consultant's Response: J.T. Barr, Schmidt Design Group:

"There is no reclaimed water access at this location; the plant palette is intended to be drought tolerant."

Public Speaker Comment: Bruce Dammann

"Will restrooms be unisex?"

Consultant's Response: J.T. Barr:

"Yes, gender neutral."

The Board members provided the following questions and comments:

- Mr. Becker requested confirmation that the park would be natural turf and not synthetic.
- Mr. Otsuji asked why there were so many parking spaces.
 - J.T. Barr responded that they had followed the consultant's guide
- Mr. Otsuji asked if they had looked at eliminating parking lot on 27th Street side. He noted that 2 parking areas are connected by service road which removed significant park space. It Seemed like there was no need for a cut-through road.
 - J.T. Barr responded that it had been noted and thanked him.
- Mr. Otsuji inquired about the location of dog park why was it placed there?
 - J.T. Barr explained that it had been located near the recreational field and children's play area.
- Mr. Otsuji asked if it would be an inclusive playground. He noted that many cities are going in that direction. He requested that design consider this for eventual construction drawings.
 - J.T. Barr stated that it had been noted and thanked him.
- Mr. Otsuji asked how maintenance would be handled
 - J.T. Barr responded that the City of San Diego Parks and Recreation Department would maintain it.
 - Director Field added that the money needed to be found for CIP design and construction first. Assuming the full project is funded for design and construction, O&M costs would come around FY 2025, about four years from now.
- Mr. Otsuji requested that they make sure that the irrigation system for trees is separate from the turf irrigation, so that trees could be preserved when the next drought comes. Need to be able to save water.
- Mr. Otsuji further commented that the plan had good design and circulation, and a good layout of activities in the park.
 - J.T. Barr remarked that maintainability would be at the forefront when they moved to construction documents.

Otay Valley Regional Park (OVRP) is a captivating stretch of ecological conservation land situated amid underserved communities and subject to harsh challenges associated with unsheltered individuals, crime, and habitat degradation. In response to prolonged vacancies, a team of rangers from around the City came together with support from their supervisors to serve this southern jewel of the Multiple Species Conservation Program Preserve. The team became the first OVRP Park Ranger Cross-Training Program, providing members with a broadened skillset and network of colleagues to approach their regular sites. Resulting in a new permanent OVRP ranger who possessed an intimate knowledge of the area. Treated as a pilot, this method could benefit the entire Park Ranger Program.
