COVID-19 Update

- Most facilities, recreational activities, and programs resumed operations by July 19, 2021, with a few exceptions
- The Delta variant has increased COVID-19 cases. City has addressed this as follows:
 - Employees are required to be vaccinated against COVID-19 by 11/2/21 (unless employee provides medical or religious exemptions)
 - All employees and members of the public must wear masks regardless of vaccination status when inside any City building and near another person
- o In-person meetings of Park Board are looking to start in calendar year 2022 due to the increase in cases related to the recent Delta variant

Board Member Name:	Summary of Comment:
Jon Becker	How will expansion of JU program dovetail into PMP? Shannon: expansion of facilities for recreation would include Play All Day sites. Jon Becker: Will this be the template for other school districts? Yes, the MOU can be applied to other school districts, along with the CP 700-35.
Dennis Otsuji	Great benefit for City and District. Can you please look at using more high schools? Examples: Lincoln and Hoover and Crawford. These three high schools were renovated and built brand new facilities. Great opportunity to share these locations with the community. These are underserved communities. We need to take 100% benefit of this, working together with SDUSD. Second, I didn't realize we have one with SD Community College. Great choice. Third, SD High School: given its location in Balboa Park, I hope there is an opportunity to have the high school benefit Balboa Park. Fourth, there are charter schools. Do we relate to charter schools in the joint use program? (Tracey Tincknell provided an overview of how charter schools work and how the Civic Center Act allows for facility license agreements. Examples – Tubman and King Chavez.)

	and around, but you will need some water added since
	some of the solids (residuals) leaving the cycle carry
	water out.
