101. <u>Reallocation of Regional Park Improvement Fund from Hall of Nations</u> <u>Foundation Repair (B-15068) to Museum of Art Elevator Modernization</u> <u>(B-10042)</u>

Ryan Barbrick, Senior Management Analyst, Grants CIP Section, Park and Recreation Department presented this item. Mr. Barbrick presented before the committee to request approval for the reallocation of \$120,000 of Regional Park Improvement Fund (RPIF) from B–15068 Hall of Nations Foundation Repair to B10042 Museum of Art Elevator Modernization. While researching funding options for an emergency project, staff discovered that the Museum of Art Elevation Modernization Project was in need of \$120,000 to complete construction of the project. It is one of three elevator modernization projects currently under way in Balboa Park. This project is an important priority of the Museum. The Hall of Nations Foundation Repair has completed construction and currently has \$137,000 in available RPIF. The action will be taken to the City Council pending approval by this committee as part of the CIP Mid–Year Budget action. The report outlined the following:

- Ms. Ocampo inquired if the Hall of Nations Fund will it not have sufficient funds now that it's being reallocated. Mr. Barbrick responded that project has completed construction and is currently in the monitoring and close out phase. He added there will be sufficient funds to close out the Hall of Nations.
- Vice Chair Kinney commented is good to know there is a surplus on a project.

A motion was made by Ms. Ocampo and seconded by Mr. Hughes to approve the recommendation as presented by staff. The motion was unanimously approved (8–1–0).

201. Year-End Updates Mission Bay Park Revenues

Mr. Andrew Field, Assistant Park and Recreation Director directed members to the spreadsheet they received which contains a list of all of the contributing lease holders in Mission Bay Park. It outlines each lease hold and how much each contributed toward the overall Mission Bay Park Lease Revenues over the past year, completing on June 30, 2016. The total revenues brought into the Mission Bay Lease Revenues is approximately \$29.6M and of that, \$20M was transferred

to the General Fund; \$2.5M to the Regional Park Improvement Fund and remaining balance to the Mission Bay Improvement Fund in FY2016. Mr. Field added this is steady as has been over the past several years and is consistent with what we have seen in the past.
