SUBJECT: A Request for "Joe Schloss Way" Naming at Morley Field

SUMMARY

Issue – Should the Balboa Park Committee recommend approval of the naming of "Joe Schloss Way" in the Morley Field area of Balboa Park?

Director's Recommendation – In accordance with Park and Recreation Board Policy No. 1001, the Department does not have a recommendation for the naming of "Joe Schloss Way."

Other Recommendations – The following groups have reviewed and considered the proposed project. Actions taken and recommendations made by these groups are listed under Discussion below.

- On February 3, 2016, the Balboa Park/Morley Field Recreation Council voted to provide a letter of support to approve the naming of the un-named park road at the Morley Field Sports Complex "Joe Schloss Way."
The motion carried 10 ayes, 0 nays, 1 abstention.
- On April 7, 2016, the Balboa Park Committee voted in support of naming the park road at the Morley Field Sports Complex "Joe Schloss Way."
The motion carried 7 ayes, 0 nays, 2 abstentions.

Fiscal Impact – The City Streets Division of Public Works will fabricate and install a street sign at the intersection of Jacaranda Place and the proposed "Joe Schloss Way" at a cost of \$240.

Environmental – This activity is categorically exempt under CEQA pursuant to State CEQA Guidelines, Section 15301, Existing Facilities.

BACKGROUND

Morley Field is located on the East Mesa of Balboa Park. The Morley Field area has been developed as a sports complex over the decades, starting with the Bud Kearns Pool in the 1930's. Morley Field currently contains the pool, tennis courts, baseball/multi-purpose fields, a velodrome, archery range, bocce courts and disc golf course, and is host to cross-country running events. The baseball/multi-purpose fields in their current configuration were developed in 1975, and are home to the North Park Little League.

There exists in the Morley Field area of Balboa Park a segment of unnamed road that lies between Jacaranda Drive and the parking lot east of the baseball/multi-purpose fields (see attachment). This segment of road is considered a park road or access drive, and does not appear in the SanGIS geographic information system database. The road is identified as a "restricted road" in the Thomas Guide map book.

The North Park Little League proposes to name this segment of park road "Joe Schloss Way" in honor of Mr. Schloss and his contribution to the community of North Park. Please see the attached request and brief biography of Mr. Schloss.

DISCUSSION

Park and Recreation Board Policy No. 1001 addresses the naming of parks and recreation facilities. The policy outlines the process for approval and suggests that naming of facilities within parks is preferable to the naming of entire parks. A copy of this policy is attached.


Per the Park and Recreation Board policy, the Balboa Park/Morley Field Recreation Council held a meeting on February 3, 2016 to consider the naming of the segment of park road as "Joe Schloss Way." The recreation council voted 10-0-1 in support of the naming. Please see the attached letter of support from the Balboa Park/Morley Field Recreation Council.



PARK AND RECREATION BOARD POLICY

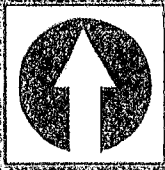
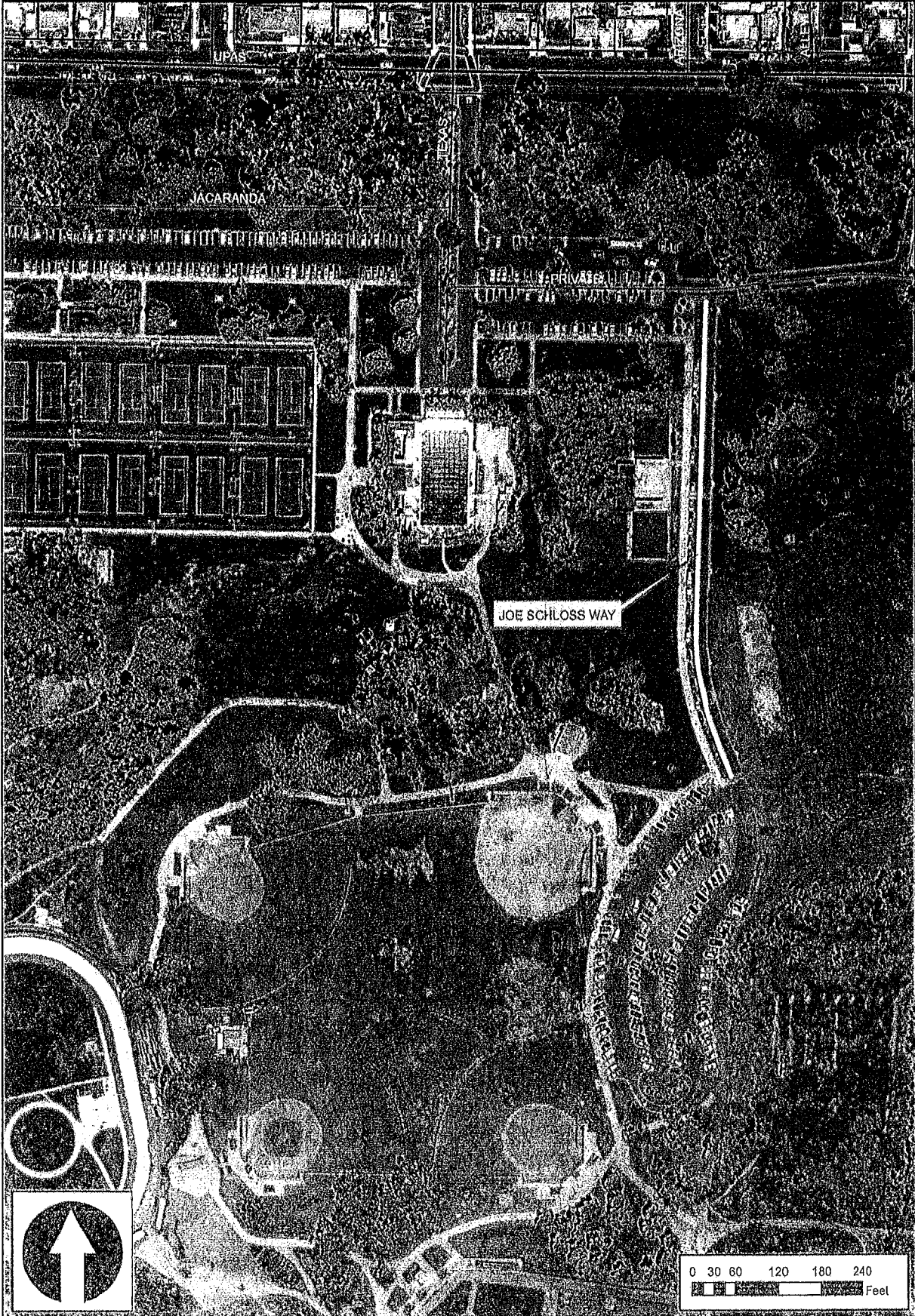
- SUBJECT:** Naming of Parks and Recreation Facilities
- BACKGROUND:** The public sometimes suggests that parks and recreation facilities be named after persons, living or dead.
- PURPOSE:** To provide a systematic procedure for the naming of parks and recreation facilities which will assist in their location by the citizenry, and to develop a method for the retention of names of historical or fiscal significance.
- POLICY:** As a general policy, parks and recreation facilities should be named to identify their locations. Especially for parks, the name of the community area, the names of nearby geographic features, the names of adjacent schools and street names should be given first consideration. However, they may also be named for individuals, living or dead, who are of historical significance to the local area or who have made major financial contributions in the opinion of the appropriate Recreation Councils and/or other advisory bodies, Board committees and the full Board. Facilities within parks, (such as buildings, gyms, courts, etc.) are more appropriate for naming after individuals than are parks.
- Renaming a facility for a person, when that facility is already named for a person, should only be undertaken with the utmost consideration. Every attempt should be made to contact the person or heirs of the person for whom the facility is currently named, to present their views verbally, or in writing, at a public hearing.
- PROCEDURE:** The Recreation Council effected by the proposed name change, shall hold a public hearing to review the request and the supporting documents and information, and shall make recommendations to the Area Committees and the Park and Recreation Board on any and all recommended changes to the renaming of existing facilities.

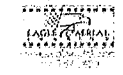



Balboa Park Committee Meeting of April 7, 2016

Excerpt from the Meeting Minutes

Action Item #203 – Naming of “Joe Schloss Way” at Morley Field – Presenter: Susan Lowery-Mendoza, District Manager, City of San Diego Park and Recreation Department

Susan Lowery-Mendoza noted the location of the un-named park road within the Morley Field Sports Complex and North Park Little's League's desire to honor Mr. Schloss who passed in November, 2015. She introduced Mr. Dan Bennett of North Park Little League who stated that during the course of Mr. Schloss' 57 years of volunteering with the organization, thousands of children were taught character along with the game of baseball. Currently, there are close to 500 boys and girls playing for North Park Little League.

Motion: It was moved and seconded (Dang/Bernal) to recommend approval of naming the road “Joe Schloss Way.”

Discussion: Mr. Steppke stated that he would support the motion, but was disappointed that there wasn't community outreach in North Park.

Motion carried (7-0-2).
