SUBJECT: Naming of the Clairemont Friendship Center to Cathy Hopper Clairemont Friendship Center.

# **SUMMARY**

<u>Issue</u> – Should the Park and Recreation Board approve the recommendation to name the Clairemont Friendship Center in memory of Cathy Hopper?

<u>Director's Recommendation</u> – The Department does not take a position on naming requests.

<u>Other Recommendations</u> – On April 20, 2016, the Greater North Clairemont Recreation Council voted unanimously (3–0–0) recommending approval to name the Clairemont Friendship Center the "Cathy Hopper Clairemont Friendship Center". Minutes are attached.

On July 6, 2016, the Community Parks I Area Committee voted unanimously (10–0–0) recommending approval to name the Clairemont Friendship Center the "Cathy Hopper Clairemont Friendship Center". Minutes are attached.

<u>Fiscal Impact</u> – None

<u>Water and Energy Conservation Status</u> – The proposed action would not have an impact on any water and energy conservation guidelines contained in Council Policy 200–14.

<u>Environmental</u> – No impact

#### BACKGROUND

The Clairemont Friendship Center is a 7,665 square foot building located at 4425 Bannock Avenue, San Diego, CA 92117. The building includes two large community rooms, six offices, three small meeting rooms, a large reception/lobby area, a full kitchen, and four restrooms. If approved, a sign would be placed on the building with the new name of the senior center. Page 2

Naming of the Clairemont Senior Center to "Cathy Hopper Clairemont Friendship Center" October 10, 2016

The request to name the senior center was initiated by Councilmember Chris Cate following her death in September 2015. The naming is to commemorate and recognize the numerous contributions and accomplishments made by Mrs. Cathy Hopper.

## **DISCUSSION**

Mrs. Cathy Hopper's numerous contributions are worthy of recognition and remembrance. She opened a storefront operation of the Clairemont Friendship Center in the Clairemont Village shopping center in 1976. She raised over \$800,000 from grants and donated these funds to the City of San Diego who built the present Center on Bannock Avenue.

The City rented the building to the outside contractor of Livewell San Diego Adult Resource Network for which Mrs. Hopper ran extensive social service programs. The many services offered included exercise and educational classes and enrichment programs.

Mrs. Hopper was an active Clairemont Community member for over 40 years. She served as the Executive Director for 31 years devoting the rest of her life to the care of seniors in this community.

Naming of Parks and Recreation Facilities

The public sometimes suggests that parks and recreation facilities be named after persons, living or dead.

To provide a systematic procedure for the naming of parks and recreation facilities which will assist in their location by the citizenry, and to develop a method for the retention of names of historical or fiscal significance.

As a general policy, parks and recreation facilities should be named to identify their locations. Especially for parks, the name of the community area, the names of nearby geographic features, the names of adjacent schools and street names should be given first consideration. However, they may also be named for individuals, living or dead, who are of historical significance to the local area or who have made major financial contributions in the opinion of the appropriate Recreation Councils and/or other advisory bodies, Board committees and the full Board. Facilities within parks, (such as buildings, gyms, courts, etc.) are more appropriate for naming after individuals than are parks.

Renaming a facility for a person, when that facility is already named for a person, should only be undertaken with the utmost consideration. Every attempt should be made to contact the person or heirs of the person for whom the facility is currently named, to present their views verbally, or in writing, at a public hearing.

The Recreation Council effected by the proposed name change, shall hold a public hearing to review the request and the supporting documents and information, and shall make recommendations to the Area Committees and the Park and Recreation Board on any and all recommended changes to the renaming of existing facilities.

The meeting was called to order by Chairperson Dennis Otsuji at 7:01 p.m.

### APPROVAL OF MINUTES

A motion was made by Mr. Frichtel and seconded by Mr. Murillo to approve the January 6, 2016 meeting minutes as written. The motion was approved 2-0 with 7 abstentions

#### ADOPTION OF AGENDA

A motion was made by Mr. Frichtel and seconded by Ms. Warren to approve the agenda as presented. The motion carried unanimously (10-0)

<u>Consent</u> At this time the Board may consider adoption of one or more items on the adoption agenda as "Consent" items.

#### **COMMUNICATIONS**

Pat Warren shared that she visited Cliburn Park in Dallas and it was amazing and very hot.

Doug Beckham announced the 8<sup>th</sup> Annual Linda Vista Community Family Reunion fundraiser on August 6, 2016 from11:00 a.m. to 7:00 p.m. at Linda Vista Recreation Center to benefit Linda Vista Recreation Center's youth programs.

<u>CHAIRPERSON'S REPORT</u> - Mr. Otsuji reported on the Mission Bay Park De Anza Revitalization Plan Special Study.

## STAFF REPORT

Mike Rodrigues, CPI Area Representative, provided an update on Park and Recreation Department water usage showing significant savings. He shared information of the free summer lunch program for children offered at many sites. Mike announced that Summer Movies in the Park are now underway, flyers are posted at each recreation center on the Park & Recreation Department website. Recreation Councils are encouraged to participate. The FY17 City Budget has been approved and Park and Recreation will see significant increases in staffing and recreation center hours at many sites. For CP-1, Lopez Ridge, San Carlos, La Jolla and Pacific Beach will be getting Assistant Recreation Center Directors and expanding weekly hours from 45 to 60. The new Pacific Highlands Ranch Community Park General Development Plan was approved at Park and Recreation Board, final design is near completion.

Debbie Marcotte, Parks Fit Program Chairperson, provided a presentation on the 2016 Park Fit San Diego Program. Highlights include the kickoff event that was held at Morley Field on June 18<sup>th</sup>; Walk, Run, Roll or Swim 30 miles between June 13 and August 13; and the Finale event to be held on August 13<sup>th</sup> at NTC Park. New this year is the Nature Exploration Area at Morley Field. We currently have over 2400 participants enrolled in the program. Thank you to all the Recreation Councils for your donation to the Parks Fit Program.

## **ACTION ITEMS**

101. Request to rename the senior center at North Clairemont Community Park to "Cathy Hopper Clairemont Friendship Center".

Carol Wright, Area Manager, requested to re-visit the renaming of the senior center at North Clairemont Community Park. The Greater North Clairemont Recreation Council approved renaming the senior center in honor of Cathy Hopper to recognize her tremendous contributions to the community.

### MOTION MOVED/SECONDED Pat Warren/Joe Frichtel

A motion was made by Ms. Warren and seconded by Mr. Frichtel to approve the renaming of the Clairemont Friendship Center to the "Cathy Hopper Clairemont Friendship Center" in honor of Cathy Hopper. The motion carried unanimously (10-0).

Carol will work with Mr. Hopper to develop and fund new signage then take the item to Park and Recreation Board for approval.

102. Request to name the bridge at Linda Vista Skate Park to "Hawk Family Bridge".

Doug Beckham, Linda Vista Recreation Council Chairperson, provided some background on the Hawk Family's involvement with the skate park design. The recommendation to name the bridge in honor the Hawk Family was approved by the Linda Vista Recreation Council. Noli Zosa, Linda Vista Planning Group, speaking on his own behalf expressed his displeasure with the naming approval process. He would like to have seen more community involvement and requested to have the naming of the skate park widely noticed and re-considered at the Linda Vista Recreation Council. He would like to see the skate park named "Linda Vista Hawk Family Skateboard Park".

Margarita Castro, LVPC supports the naming of "Hawk Family Bridge".

Janet Kaye, LV CDC read a letter she addressed to the Linda Vista Recreation Council opposing the naming of the bridge after the Hawk Family. She would like to propose naming the Linda Vista Skate Park "The Linda Vista Hawk Family Skateboard Park".

# MOTION: MOVED/SECONDED Terry Cords/Chris Pierce

A motion was made by Mr. Cords and seconded by Chris Pierce to table the item to name the bridge at Linda Vista Skate Park after the Hawk Family.

During discussion, Doug Beckham read a letter from the Tony Hawk Foundation Executive Director stating "The Hawk Family is touched that Linda Vista Recreation Council has offered to name the bridge for the family, but their contributions to the park through the Tony Hawk Foundation are the least they feel they could do for a project close to them. They would prefer to remain contributors to the project and not be acknowledged on-site". (Letter Attached).

Motion Withdrawn: During the reading of this letter, Terry Cords withdrew his motion to table the item, Chris Pierce accepted.

# MOTION: MOVED/SECONDED Terry Cords/Chris Pierce

A motion was made by Mr. Cords and seconded by Chris Pierce to approve naming the bridge at Linda Vista Skate Park to "Hawk Family Bridge". The motion carried 10-0 with 2 abstentions.

Mark Moncey will work with Doug Beckham to bring this item to the Park and Recreation Board level for consideration. Mark will be sure to notice interested parties of this meeting.

#### 103. Request to re-name Morley Green located along Linda Vista Road to "John Baca Park".

Doug Beckham, Linda Vista Recreation Council Chairperson, introduced the item. John Phillip Baca, longtime Linda Vista Resident, is a former United States Army soldier and Vietnam war veteran. He was awarded the Medal of Honor for his actions in combat.

# MOTION MOTION/SECONDED

A motion was made by Mr. Frichtel and seconded by Mr. DeLaBarre to approve renaming Morley Green as "John Baca Park". Motion carried 12-0.

### **INFORMATION ITEMS**

Joe Frichtel talked about re-naming parks. He would like to see more people involved at the Recreation Council level when these items come forward for vote. Mira Mesa Recreation Council has three park re-naming items in the works and he feels it is appropriate to rename parks for those community members that have dedicated their volunteer efforts to make these parks better places for all residents to enjoy.
