MISSION DUTIES OF THE ADVISORY BOARD

What is the mission and duties of the Park and Recreation Board and Regional Park Improvement Fund Oversight Committee, as established by the Municipal Code?

The Park and Recreation Board was chartered by the City Council under San Diego Municipal Code Section 26.30 to serve as an advisory board on matters relating to the acquisition, development, maintenance, and operation of parks, beaches, and recreation properties and facilities.

The Regional Park Oversight Committee serves the following roles under City Charter Section 55.2:

- Act in an advisory capacity to the City Council in all matters pertaining to parks, recreation, beaches, creeks, plazas, parkways, and street trees.
- Consider the annual budget for parks, recreation, beaches, creeks, plazas, parkways, and street tree purposes during the process of its preparation and make recommendations with respect thereto to the City Council and the City Administrator.
- Assist in the planning of parks, recreation, beaches, creeks, plazas, and street trees for
 the inhabitants of the City, promote and stimulate public interest therein, and to that
 end solicit to the fullest extent possible the cooperation of school authorities and other
 public and private agencies interested therein.

ASSISTANCE TO THE BOARD

Please provide an estimate of the City staff hours assisting in administering the Board.

Operations of the Board and Oversight Committee, including preparing agenda and minutes, reviewing submitted written reports and presentations for agenda items, ensuring items are placed on City webpage, and handling other logistics takes approximately 40 to 60 hours per month depending on size of agenda and what may arise. This is primarily the Parks and Recreation Department Director, Parks and Recreation Department Assistant Director, Executive Secretary, Information Systems Analyst (to set up visuals and laptop for presentations and to load staff reports and agendas onto the City webpage), and Communications Specialist (to set up audio, including microphone and recording equipment).

Not tabulated in this total are staff hours associated with preparing reports and presentations to the Board and Oversight Committee. Primary staff involved in preparing reports are from Parks and Recreation (operating and capital budget analysts, grants staff, senior planners, landscape architects, and onsite operational staff such as district managers and area managers), Public Works (project managers, senior engineers, etc.), and Planning (park designers, landscape architects, senior planners, etc.).

VOLUNTEER HOURS

Please provide an estimate of the volunteer hours by commissioners.

Board members are expected to attend meetings, review written materials in advance of the meeting, and respond to requests from staff to confirm attendance at meetings. Each meeting generally takes between one and three hours generally between 2 and 5 p.m. on the third Thursday of the month. Travel time to and from the meeting venue likely averages around an hour for each member (depending on where they live and time of day). Each member likely spends one to two hours reviewing meeting materials prior to the board or oversight committee meeting. In total, this would account for an average of about five to eight hours per month of volunteerism per member, or about 50 to 90 hours per month assuming all 11 members are seated and none are vacant.
