SUBJECT: Willie Henderson Sports Complex General Development Amendment

SUMMARY

<u>Issue</u> – Should the Parks and Recreation Board recommend approval of the General Development Plan (GDP) Amendment for Willie Henderson Sports Complex to include an indoor/outdoor soccer arena, multi-use sports courts, off-leash dog areas, fitness areas, and other park enhancements?

<u>Department Recommendation</u> – Recommend approval of the proposed General Development Plan (GDP) Amendment for Willie Henderson Sports Complex

<u>Other Recommendations</u> – The following groups have reviewed and considered the proposed project. Actions taken and recommendations made by these groups are listed under Discussion below.

Willie Henderson Sports Complex Community Recreation Group

<u>Fiscal Impact</u> – Preparation of the GDP Amendment is fully funded in the amount of \$300,000 with Development Impact Fees (DIF). The estimated total construction cost for the proposed improvements at Willie Henderson Sports Complex is \$2,496,351.00.

<u>Water and Energy Conservation Status</u> – The proposed General Development Plan Amendment for the Willie Henderson Sports Complex will comply with all water and energy conservation guidelines contained in Council Policy 200–14.

<u>Climate Action Plan (CAP) Impact</u> – The proposed General Development Plan Amendment for the Willie Henderson Sports Complex will implement Strategy 3 – Mobility and Land Use by providing accessible walkways to park amenities. The proposed General Development Plan Amendment will also implement Strategy 5 – Resiliency to the CAP with the target of achieving 35% urban tree coverage by 2035. This action allows more shade trees to be planted at Willie Henderson Sports Complex.

<u>Strategic/Tactical Equity Plan Impact</u> – The proposed General Development Plan Amendment for the Willie Henderson Sports Complex will comply with the City of San Diego Strategic Plan as an effort to Protect & Enrich Every Neighborhood.

<u>Environmental</u> - The City of San Diego conducted an environmental review which determined that the project meets the statutory exemption criteria set forth in CEQA State Guidelines, Section 15262 (Feasibility and Planning Studies) in order to approve the design services Agreement only, which include soils testing activities for geotechnical investigation/evaluation.

BACKGROUND

The project is located within the Southeastern Community of the City of San Diego in Council District 4. This project proposes to obtain an approved GDP Amendment to add: a new indoor/outdoor soccer arena, multi-purpose courts, new fitness areas and a dog park. Other proposed park improvements include: replacement play areas, new water fountains with options for dogs, new picnic areas with shade structures and improvements to the turf, parking lots, sidewalks, and irrigation and all the associated underground and above ground infrastructure, equipment and wet and dry utilities that will comply with all current regulations including accessible path of travel and stormwater.

DISCUSSION

On November 22, 2022, the first community workshop meeting for the proposed GDP Amendment was held in-person at the Willie Henderson Sports Complex Recreation Center, facilitated by the Willie Henderson Sports Complex Community Recreation Group (CRG). The first workshop was to review a list of community desired park amenities provided by the Parks & Recreation Department, collect interactive feedback from the community on proposed park amenities and associated types/styles, review a proposed conceptual site plan and collect input on additional park amenities desired by the community. At this meeting, all the meeting attendees including members of the Willie Henderson Sports Complex CRG participated in a voting exercise to determine community preferred types/styles of several park amenities including playgrounds, sports courts, outdoor fitness components, shade structures and interpretive education/art integration elements. Each attendee was given 8 voting dots to indicate preferences and the voting results are listed below:

- Playgrounds: Traditional playground and inclusive design received the most votes.

 - Natural (8 dots)
 - Modern (7 dots)

 - Inclusive playground components (7 dots)
 - Natural play elements such as boulders and logs, and misc. activities (5 dots)
 - Modern playground with clean lines, metal, and misc. activities (5 dots)
 - All of the above (3 dots)
 - Traditional playground with climbing structures, and misc. activities (2 dots)




- Sports Courts: Soccer arena received the most votes.


Outdoor Fitness Components: Stationary equipment received the most votes.


Interpretive Education/Art Integration Elements: Engraving received the most votes.


A list of additional desired park amenities was created by community members and voted for. Dog park received the most votes and was later adopted as an additional amenity to include in the GDP Amendment. Gymnasium received the second most votes and is being considered in a future GDP project by the Parks & Recreation Department. Other desired amenities on the list are either being incorporated as part of this improvements project (shade structures, artistic and colorful basketball surfacing), or being brought to the attention of the Parks & Recreation Department operation and maintenance team (more trash cans and safety), or being considered as part of the Public Art component within this park improvements project (art & mural and Willie Henderson Memorial).

On February 28, 2023, a second design workshop meeting for the proposed GDP Amendment was held in-person at the Willie Henderson Sports Complex Recreation Center, facilitated by the Willie Henderson Sports Complex Community Recreation Group (CRG). At the meeting the City Design Team presented the draft GDP Amendment design, which incorporated feedback from the first meeting. A dog park is added to the GDP Amendment as a result of the community input from the first meeting. Below is the draft proposed design to enhance Willie Henderson Sports Complex:



The proposed draft GDP Amendment site plan was voted by the Willie Henderson CRG. Vote count was 5 yes votes and 2 no votes. The yes votes carry for approval of the draft GDP Amendment.




