#### Background Recreation Center Funds

- The Department has been managing 60 Recreation Center Funds (RCF) since January 2018.
- Each RCF is a "special fund" designated for enhanced recreation programs, maintenance and events in a specific area.
- RCFs supplement basic recreation services paid for by the General Fund.
- Budgets are developed by Department staff with input from Community Recreation Groups (CRG).

- 60 Recreation Center Funds
- Budgets include Opportunity Fund allocations

### Proposed Recreation Center Fund Budgets Fiscal Year 2024


- Budgets range from \$1,500 to \$815,000
- Budgets vary based on several factors including recreation center program volume, available spaces to program, available fields and park amenities to permit, location of community events, etc
  - Example: Small center with only one room can only offer one program at any given time indoors, whereas a large center with multiple rooms and a gym can run several programs at one time, thus generating more revenue and more expenses.
- Budgets include expenses for recreation classes, camps, leagues, community events, equipment/supplies and maintenance projects

#### Vendor Recruitment Fairs

- Goal: Develop a comprehensive list of available recreation service providers and vendors, city-wide, that can meet city's procurement requirements
- Established a Pre-qualified Vendors Application with Guidelines
- Recruitment is and on-going year-round effort
- Coordinated 6 Vendor Fairs : Skyline Hills (3/29), Montgomery Waller (4/13), Linda Vista (4/25), Southcrest (5/8), Mira Mesa (5/24), and City Heights (6/1) from 11:00 a.m. to 2:00 p.m.
- Services Needed: Food, Sports, Entertainment, Fitness, Education, Youth, Ault and Senior Programs, Performers, Event Rentals, Recreation Instructors, Camps



### Back to Work SD Employ and Empower

#### Eligibility:

- 16-30 years old, and one of the following
  - Difficulty finding employment
  - Low Income
  - Unemployed and/or out of school
  - Currently or previously justice involved
  - Transitioning from foster care
  - Engaged with the mental health or substance abuse system
- Minimum Wage \$16.30/hour



Leadership, Education, and Development for Employment in Recreation

- 12 week paid academy
- Interns gain experience in a number of career opportunities including the following:
  - Hands-on experience volunteering at City events
  - Attend dedicated sessions for career goal development
  - Learning about the City job application process
  - Gain interview skills
  - Formal interview process for a Recreation Aide or Recreation Leader I position
  - 27 participants in the spring 2023 academy



### Equity in Recreation Recreation Center Funds

- Audit of Equity in Recreation Programs
  - Released November 2021
  - 5 Core Findings
  - 16 Recommendations





### Recreation Program Equity Audit Completed, In-progress & Delayed

- Completed Recommendations
  - Recommendations 14 and 16: Naming conventions for programs, and annual ActiveNet trainings for employees
- On-schedule Recommendations
  - Recommendations 3, 6, and 15: Cost of Service Study, Dept. Instructions for ActiveNet trainings, and Opportunity Fund
- Delayed Recommendations
  - Eleven recommendations will be delayed due to staffing and budget limitations



### Recreation Program Equity Audit Opportunity Fund

- Recommendation #6 Develop and implement a plan for directing resources to reduce program disparities
  - July 2022: Developed a Opportunity Fund permit user fee in Department Fee Schedule
  - April 2023: Council Policy 700-48 adopted to govern fund
  - April 2023: FY24 Opportunity Fund proposals developed, submitted, reviewed by evaluation committee
  - May/June 2023: FY24 Opportunity Fund proposed budget allocations presented to Park Board and City Council for consideration
  - July 2023: Opportunity Funds to be expended for programs, events and maintenance thru fiscal year

- Continuous active recruitments for jobs
- Monthly hiring halls for recreation aide and recreation leader
- Converted hourly positions to half-time benefited
- Maximize salary offerings in an effort to be competitive with the current labor market
- Launched an alternative work schedule
- Allow for Onsite, Remote, and Hybrid work
- Hire Pool Guard I's without prior training and certifications then train and certify them on the job
- Develop hiring halls in partnership with Personnel that include interviews, on-the-spot job offers, backgrounding, and appointments for medical clearance

### **Recommended Actions**

This item seeks authority to establish the Fiscal Year 2024 budgets for 60 Recreation Center Funds to allow for recreation program, maintenance and event expenditures.

- 1. Authorize the Chief Financial Officer to appropriate and expend Recreation Center Funds in Fiscal Year 2024 as detailed in Attachment A: Proposed Fiscal Year 2024 Recreation Center Fund Budgets.
- 2. Make available the estimated Fiscal Year 2023 Recreation Center Fund carry forward to appropriate and expend during Fiscal Year 2024
- 3. Authorize the Chief Financial Officer to appropriate the transfer of the Opportunity Funds into the identified Recreation Center Funds for Fiscal Year 2024 as detailed in Attachment B: Opportunity Fund Allocations.
- 4. Authorize the Chief Financial Officer to expend Recreation Center Funds generated from permit fees, that fall within one of the exceptions to Proposition 26, in any geographic area regardless of where collected to promote equity in Parks and Recreation Department-wide recreation programs.
