SUBJECT: Proposed Adjustment in Hours for Leashed Dogs Access at Mission Bay Park

SUMMARY

Issue – Should the Park and Recreation Board approve recommending that the San Diego City Council enact a change to the current hours that dogs are prohibited at Mission Bay Park? The San Diego City Council must amend the San Diego Municipal Code (§63.20.12, Dogs Prohibited beach and bay) in order to enact the changes to times that dogs are prohibited at Mission Bay Park.

Director's Recommendation – Staff recommends acceptance of the recommendations from the Pacific Beach Town Council and the Mission Bay Park Committee as noted below.

Other Recommendations

- On October 6, 2020, the Mission Bay Park Committee unanimously approved to support the adjustment in times that leashed dogs are not permitted at Mission Bay Park to read: Dogs are not allowed between 10:00 a.m. and 4:00 p.m. year-round. (Attachment 1). Note: The current hours that dogs are not allowed is: Winter (November 1 to March 31) from 9:00 a.m. to 4:00 p.m. and Summer (April 1 to October 31) from 9:00 a.m. to 6:00 p.m.
- On July 1, 2020, the Pacific Beach Town Council approved to petition Parks and Recreation Department to change the hours that dogs are not allowed on the beach, boardwalk, or adjacent parks to be 10 am – 3 pm during the winter and 10 am – 5 pm during summertime. (Attachment 2)

Fiscal Impact – Approximately \$10,000 (labor and materials) to revise and replace all park regulations signs related to hours that dogs are prohibited at Mission Bay Park.

Water and Energy Conservation Status – The proposed action would not have an impact on any water and energy conservation guidelines contained in Council Policy 200-14.

Environmental – The Planning Department has determined that this activity is not subject to CEQA pursuant to State CEQA Guidelines Section 15060(c)(2), as it would not result in any direct or indirect physical change in the environment.

BACKGROUND

The President of the Pacific Beach Town Council approached Parks and Recreation Department staff to request that the City for San Diego amend Municipal Code related to times that leashed dogs are prohibited at Mission Bay Park. The Mission Bay Park Committee approved the proposed change in time that dogs are prohibited at Mission Bay Park at their October 6, 2020 meeting. The new proposed time that leashed dogs are prohibited is from 10:00 a.m. to 4:00 p.m. year-round. This allows dog owners more time in the late afternoon/evening hours and an additional hour in the morning to bring their dogs to Mission Bay Park. Note: the current times that dogs are prohibited at Mission Bay Park is: 9:00 a.m. to 4:00 p.m. November 1 to March 31; and 9:00 a.m. to 6:00 p.m. April 1 to October 31. (Attachment 3).

DISCUSSION

The primary reason residents requested to increase the time for leashed dogs to access Mission Bay Park is to allow dog owners additional time during day light hours.

Only park locations within Mission Bay Park, excluding Santa Clara, will be considered for change in hours. The shoreline parks are not included. Santa Clara has a separate SD Muni Code with specific hours and locations under SDMC 63.20.12 (b) (Attachment 4), which will remain in effect.


If approved, the change in hours that leashed dogs are prohibited means law enforcement agencies, including the San Diego Police Department and Park Rangers, can only enforce the new times that dogs are prohibited. All the signs currently posted will need to be changed to reflect the new times.

The Pacific Beach Town Council and the Mission Bay Park Committee voted to recommend the new times that leash dogs are prohibited to be 10:00 a.m. to 4:00 p.m. year-round. The Park and Recreation Board is the next advisory group to consider this matter; if approved, the Department will bring this matter forward to the City Council for consideration and amendment to the Ordinance. The application of leashed dog hours at Mission Bay Park is governed by the San Diego Municipal Code in Chapter 6: §63.20.12 Public Works and Property, Public Improvement and Assessment Proceedings (Attachment 4).

ALTERNATIVES

1. Recommend the modification to the times that leashed dogs are prohibited at Mission Bay Park or;
2. Do not recommend the modification to the times that leashed dogs are prohibited at Mission Bay Park

There is new progress on the ReWild Mission Bay project. At their October 14th meeting, the Regional Water Quality Control Board will review a City of San Diego proposal to create a new alternative for ongoing De Anza planning in the northeast corner of Mission Bay. The City is proposing to spend \$1.25 million on habitat improvements to Kendall-Frost, technical studies for wetland restoration, and a new alternative that commits to planning for 80 acres of new wetland with sea level rise by 2100, what the ReWild Mission Bay project has been pushing for the last year and a half. I'd be happy to answer any questions that I can about the project, or direct you to the City contact for the project.

CHAIRPERSONS REPORT – Paul Robinson

CITY COUNCIL DISTRICT 2 OFFICE – Carrie Munson

Council Office is very busy addressing the topic of short-term rentals. CD2 drafted a MOU which provides a compromise that will go to Planning Department then City Council for approval. CD2 continues to hear complaints about excessive trash and illegal RV parking for extended periods of time throughout Mission Bay Park. CD2 supports Measure E on the upcoming ballot which will remove the 30' height limit in the Midway District to allow for development.

STAFF REPORTS

San Diego Lifeguard Service - Lt. Rick Romero

Lifeguards have been extremely busy during the end of summer leading into the Fall with large crowds flocking the beaches and bay. Ron Anderson asked about illegal watercraft rentals and Lt. Romero commented that Lifeguards have seen an uptick in illegal private watercraft rentals in Mission Bay. Their section has made many contacts to educate these groups and issued several warnings. READ has also been notified since these private rentals violate SD Muni Code impacting several Mission Bay Park Lessees and creates safety concerns.

San Diego Police Department – Officer Brandon Broaddus

Officer Broaddus reported that the Police Department stepped up in enforcement throughout the beach communities, including Mission Bay Park, in response the task force efforts. He provided statistics with numbers of citations issued. Denise Freidman commented that the recent SDPD enforcement efforts has shown an improvement in controlling the illegal fires in the Crown Point area and thanked the task force for addressing these community concerns.

Parks and Recreation Mission Bay Park

Mike Rodrigues, District Manager, reported that the West Bonita playground and comfort station project is nearing completion and a dedication will be scheduled for early November. All playgrounds in Mission Bay Park have re-opened with signage and capacities posted for COVID-19 safety requirements. Parking enforcement has resumed, and illegally parked vehicles are now being cited/towed. Mission Bay Athletic Area improvements are in final design and will visit our Committee at the next meeting. Crown Point accessibility improvements are completed. Fiesta Island continues to be a hotbed of illegally dumped items left behind for park staff to dispose of. Lastly, houses of worship and fitness facilities are now allowed to permit the park grounds for classes and gatherings with a “pending” emergency ordinance that will waive the permit fees. Note, the November MBPC meeting is scheduled on Election Day.

201. Park Ranger Araceli Dominguez with Shoreline Parks requests support for a sand fencing project at Ocean Beach Estuary with assistance from Urban Corps.

MOTION: MOVED/SECONDED

A motion was made by G. Ingolia and seconded by J. Munoz to support the project, as a concept subject to permits, for the removal of the outdated fence and install new sand fencing at the Ocean Beach Estuary with the assistance of Urban Corps to conserve and enhance the habitat and wildlife in that area. The motion carried 8-0.

202. Brian White, President, Pacific Beach Town Council requested support for the adjustment in hours for leashed dogs to access in Mission Bay Park. The requested hours for dogs **to not be permitted** in Mission Bay Park is **10:00 a.m. to 4:00 p.m.** year-round.

There were ninety-three (93) public comments supporting the time change to loosen the restrictions when dogs are permitted at Mission Bay park and there were nine (9) objections to amend the current times. Thirteen (13) public comments requested loosening the hours that dogs are not permitted at the beaches.

MOTION: MOVED/SECONDED

A motion was made by J. Munoz and seconded by S. Smith to support adjusting the times that dogs are not permitted at Mission Bay Park to read: “Dogs are not allowed

between 10:00 a.m. to 4:00 p.m. year-round". Motion carried 7-0 with one abstention (Anderson).

Santa Clara is excluded from this time charge that dogs are not permitted, and that location's current time will remain. Once these minutes are approved, staff will take this item to Park and Recreation Board for consideration as the next step in the process.

SPECIAL EVENT PERMIT REVIEW: Special Events that require road closures or will potentially impact park and/or commercial operation are brought to the Committee for a formal recommendation. They can be moved to Consent by action of the Committee.

63.0102 (b) (2) Dogs must be leashed**§63.0102 Use of Public Parks and Beaches Regulated****(a) Purpose and Intent**

It is the purpose and intent in enacting this Division to regulate and prohibit certain activities in public parks and beaches within the City of San Diego in the interests of protecting the enjoyment and safety of the public in the use of these facilities, as well as the natural resources of the City of San Diego.

(b) It is unlawful for any person within any public park or plaza or public beach or beach areas within the City of San Diego to do any of the acts enumerated in Section 63.0102(b).

(2) Loose Animals. It is unlawful to bring, leave, turn loose or allow to go free any animal, fowl, or bird of any kind in or upon any City owned park or plaza; provided, however, that Section 63.0102(b)(2) does not apply to:

(A) Horses being led, ridden, or driven upon any roads or paths, therein;

(B) Dogs when fastened to and led by a chain or line not more than eight (8) feet in length of suitable strength;

(C) Dogs which are in special areas of parks designated and posted by the Park and Recreation Director as dog off-leash areas or dog training areas and so long as the regulations of the Park and Recreation Director with respect to the use of such areas are followed.

(i) Implied Consent. The presence of a dog in a designated dog off-leash area or dog training area shall constitute implied consent of the person either owning or controlling the dog to the regulations imposed by the Park and Recreation Director.

(ii) Liability and Indemnification. The presence of a dog in a designated dog off-leash area or dog training area shall constitute a waiver of liability, on behalf of the person either owning or controlling the dog, to the City of San Diego, as well as an agreement and undertaking to protect, indemnify, defend, and hold harmless the City of San Diego for any injury or damage caused by the dog.

§63.20.12 Dogs Prohibited beach and bay

(a) Except as provided in Sections 63.20.12(b), (d), and (e), it is unlawful for any person owning or having charge, care, custody, or control of any dog, whether leashed or unleashed, to be upon any public beach, any public park adjacent to a public beach, or any sidewalk adjacent to any public beach between the hours of 9 a.m. and 6 p.m. from April 1 through October 31, and between the hours of 9 a.m. and 4 p.m. from November 1 through March 31.

SDMC 63.20.12 (b) Dogs Prohibited Santa Clara

(b) Except as provided in Sections 63.20.12(e), it is unlawful for any person owning or having charge, care, custody, or control of any dog to take, cause, permit, or allow such dog, whether leashed or unleashed, to be in Santa Clara Point Community Park, located at the 900 block of Santa Clara Place, east of Bayside Walk, in Mission Bay, between the hours of 9 a.m. and 6 p.m.
