Joint Use Program with School Districts

- Maximizes shared use of public facilities and resources
- Exclusive school use during school hours and public use when school is not in session
- Joint-use partnerships with schools fill an essential gap in addressing the City's need for more park land and additional recreational opportunities in our communities.

- Poway Unified School District
- San Diego Community College District

San Diego Unified School District

- Key partner since 1948
- One of the largest joint use programs in the country
- Currently 87 SDUSD joint use facilities
- Play All Day Program will add more joint use recreational facilities over the next 5-10 years with construction funding from Props S and Y and Measure ZZ
- MOU last updated in 2002





2002 City-District MOU

- City and SDUSD have each made significant financial contributions over \$275M for land, development and maintenance
- As the primary landowner and capital funding source, SDUSD has outpaced the City for overall financial contributions to the joint use program





2002 City-District MOU

- Contained financial "parity" terms that were complex, costly, and problematic to implement
- Parity calculations:
 - Looked at contributions within each agreement but did not consider overall contributions from the City and SDUSD
 - Did not capture the parties' desire to establish a mutually beneficial arrangement that provides for the shared use of public land and facilities to best maximize public use

Draft MOU

- Clarifies roles of City and SDUSD in developing and administering joint use
- Indicates that both parties are satisfied with the contributions of the other party
- Deletes parity concept
- Forgives any monies that may be owed by either party under the terms of the 2002 MOU





Council Policy 700-35

- Establishes guidelines for the development and operation of the City's joint use program with school districts, including:
 - Strategic vision
 - Objectives
 - Authority
 - Responsibility
 - Accountability
- Focuses new joint use proposals to bring more recreational opportunity to communities that lack park access
- Assigns P&R the role to bring annual updates to the PS&LN
 Committee to discuss the state of the joint use program





Fiscal Considerations

- This action does not authorize expenditure of funds for operations, maintenance, construction, or land acquisition.
- Each joint use agreement determines the role of the City and school district for these elements, and the fiscal impact to the City is identified in each joint use agreement brought to the City Council for its consideration.
