The City is projected to receive \$26 million in SB1 funding from the Road Maintenance and Rehabilitation Account in 2021. We see from the City staff report that this funding is going towards 2 slurry seal group projects and 4 asphalt overlay group projects. The projects vary in size from \$2 million to approximately \$6.5 million. We support the City's continuing focus on improving the road system's Overall Condition Index; as the system has visibly improved but has a long a way to go. In this time of economic uncertainty and turmoil we believe it is more important than ever for the City to quickly deliver its funded infrastructure projects on time. In fact, if possible, we urge the City to consider advancing these projects for early delivery to ensure that construction continues as the

				Here at Public Bank SD we've been watching with increasing concern as reports of the city's financial distress continue to make print.
				Economist Ellen Brown writes, "There is a way local governments can take advantage of the near-zero interest rates available to banks. They can set up their own publicly-owned banks. Besides giving them the ability to borrow much more cheaply, having their own banks will allow cities to leverage their loan funds. A \$100 million revolving fund issuing loans at 3% would gross \$3 million per year. If that same \$100 million were used to capitalize a bank, it could issue ten times that sum in loans, grossing \$30 million per year."
				This is the key: if we bank in-house, we can leverage the money the same way they do on Wall Street, only this way the profits stay here in our community.
