## **Community Partnerships**

**Captain's Advisory Board (2)** – A meeting held every other month as collaboration between Command Staff and the community to address community policing, public safety, and quality of life issues.

**City Department Meeting (7)** – Meets every other week to discuss working together on issues in the Downtown area. Meets with SDPD, City Council representatives, the City Attorney, Environmental Services (ESD), Park & Recreation, and Neighborhood Resource Team (NRT).

**Little Italy Residents Association** – Meets quarterly to discuss public safety concerns and current criminal activity that is occurring in the area.

**Safety Network Meeting (3)** – This meeting is hosted by Downtown Partnership. It meets quarterly to discuss public safety concerns and current criminal activity that is occurring on business properties.

**Safety Taskforce Meeting (6)** – This meeting is hosted by Downtown Partnership. It meets every other week to discuss public safety concerns and current criminal activity that is occurring in the area. This meeting is attended by: SDPD, Environmental Services (ESD), a Sheriff Deputy, MTS, a Deputy City Attorney, and Mental Health Services to share safety information especially regarding transients and the mentally ill.



Balboa Park Safety Meeting (3) - Meets monthly to discuss Balboa Park operations and citizen safety concerns with park rangers and museum facility managers.

Bankers Hill Community Meeting (2) - Meets monthly with residents to discuss concerns with criminal activity in the Quince Street & Spruce Street Canyons.

Barrio Logan Association Meeting (3) - Meets monthly with Barrio Logan community leaders to discuss criminal activity that is occurring in the Barrio Logan community and Chicano Park.

**Central Village Business Association Meeting (3)** – Meets monthly with local small business owners to discuss criminal activity that is occurring around local businesses in the Barrio Logan community.

Memorial Recreation Meeting (3) - Meets monthly with recreation managers and community members to discuss current community recreation events, public safety concerns, and current criminal activity that are occurring around the park and recreation center.

South Park Business Group (3) - Meets monthly with small local businesses to discuss public safety concerns and criminal activity occurring in South Park.

Greater Golden Hill Planning Committee (3) - Meets monthly with local residents and business owners to discuss safety concerns and criminal activity occurring in Golden.

Miscellaneous Meetings (14) - "As requested" meetings with community members, groups, and organization.

- Meeting with Civic San Diego to discuss developing the west side of Police Headquarters into a park setting, including the reduction of parking spaces for victims that have appointments at HQ and safety concerns.

San Ysidro Chamber of Commerce Breakfast Meeting - This meeting is put on by the Chamber for its members as training on different topics that are relevant to the businesses and community members of Southern Division. Officers attend the meeting as a resource and provide crime prevention tips and crime statistics.

**Ocean View Hills Recreation Council (2)** – The Recreation Council is a community advisory board that meets monthly allowing community input for the local city parks. The Council works with the city to organize events and activities at parks, ensures that parks are adequately maintained, and assists in the planning of new parks. Southern Division Officers attend the meeting as a resource and provide crime prevention tips and crime statistics.

Neighborhood Watch Meetings/Block Party (3) - Regular meetings held in neighborhood communities to discuss public safety and quality of life issues. Many neighborhood watch groups utilize Nextdoor.com as a conduit of communication to address crime awareness and prevention.

Otay Mesa Cargo Group Meeting - Southern Division participated in the Cargo Group meeting as a resource on issues that might arise as it relates to Cargo vehicles within Otay Mesa.

Tijuana River Valley El Nino Preparation Follow Up Meeting - Councilmember David Alvarez' staff and key stakeholders within the Tijuana River Valley attended this meeting. The meeting created a dialogue between public safety, city, county; state officials and community members to better prepare and coordinate if evacuations are necessary.

Community Meeting with Store Owners within San Ysidro - Southern Division Community Relations Officer met with community members that wished to voice their concerns regarding the increase of transients in the area of San Ysidro.

#### **Community Involvement**

The center was remodeled to accommodate more cardio vascular type exercises including two x-box game consoles specifically used to involve kids in fitness type activities.

### **Community Partnerships**

## **Community Involvement**

**Mentoring Youth for Tomorrow (48)** – A daily afterschool event (Mon-Thur). Mentoring Youth for Tomorrow (MYT) is a program that enables inner-city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with youth. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.



Teen LEAP (Leadership, Empowerment, Awareness Program) (12) - Teen LEAP is a 30-session curriculum led by STAR/PAL officers that encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, this program strives to promote awareness about community issues as well as provide young adults with the tools to address them through leadership and civic engagement. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood in Mid City Division.

**InterACTion** – InterACTion is an 18-session program that brings law enforcement officers and teaching artists from the La Jolla Playhouse together inside the classroom to address pressing issues such as crime, gang violence, self-expression and the dangers of drugs with high school teens in a unique and non-threatening way. Through a partnership with the San Diego Unified School District, the program is taught at Lincoln High School in Southeastern San Diego and Crawford High School in City Heights, and is designed to assist students in learning the necessary tools to make positive life choices, using theater as a medium to communicate about the struggles they face each day.

Junior Chargers Training Camps (4) - STAR/PAL officers, with the support of the San Diego Chargers and NFL Play 60, run a series of Junior Chargers Training Camps each year throughout the County of San Diego. Each camp gives 100 youth participants (ages 8-14) from various communities the opportunity to run football drills with public safety volunteers. At the camps, youth not only learn about the basics of football but also hear from Chargers players and law enforcement officers about the importance of a healthy lifestyle through exercise and following academic goals. In addition, this program promotes positive interaction between youth and local law enforcement officers in a team sport environment.

Padres MYT/Pro Kids Kickball - The Mentoring Youth for Tomorrow and Pro Kids Golf program youth were surprised with a visit from Padres Outfielder Alex Dickerson #1, who made an appearance at STAR/PAL as part of the Padres Caravan and talked to the youth about school, life goals, his career, the importance of homework, signed jerseys, and played a game of kick ball with them.

**Youth Development Institute Youth Leadership Conference** – Youth from STAR/PAL's Making Changes program attended a three day conference at Camp Marston in Julian, where 12 STAR/PAL youth served as camp leaders. It was filled with team building activities, a variety of workshops, making new friends, interactive presentations, a talent show which STAR/PAL youth individually participated in, and leadership skills that can be taken back to the participants' schools and community with the goal of helping them make a change, empower others, and make the world a better place. Information gathered from this camp will be a direct influence of the STAR/PAL billboard project.

Active Youth Leadership Conference – Youth from STAR/PAL's Making Changes program attended a three day Friday Night Live conference at Camp Buckhorn in Idyllwild. It was filled with team building activities such as the ropes challenge course, making new friends, speakers from around the world, interactive presentations such as distracted driving and conflict resolution, and leadership skills that can be taken back to the participants schools with the goal of helping them be the change, empower others, and make the world a better place. Due to the incredible leadership that the Making Changes students exhibited during the camp, they were asked to be student leaders and presenters at next year's camp.

**Martin Luther King Parade –** STAR/PAL officers brought youth from the Making Changes program who are involved in civic engagement to walk in the Martin Luther King Parade. The youth walked to support Dr. King and his ideals of justice and equality.

**Soccer Game with Lincoln High School Alumni** – STAR/PAL participated in a law enforcement and community soccer game with alumni from Lincoln High School. The soccer game was a fun event where students and law enforcement officers played side by side and continued to build long-standing relationships between the San Diego Police Department and the community it serves.

## **Community Outreach**

**Presentation at Juvenile Court and Community Schools (7)** – Presentations by STAR/PAL Officers for at-risk youth covering issues such as making positive life choices, improving self-esteem, and information about the law as it relates to juveniles.

Better A Block - STAR/PAL participated in the Better A Block community outreach event put on by SDPD Southeastern Division where we helped to involve the community with law enforcement officers and to connect the community with resources in their area. We provided information and access to STAR/PAL programs aimed at youth in the area.

## **Community Givebacks**

TRI-N-HARDER-4-KIDS Indoor Triathlon - STAR/PAL puts on an indoor triathlon to benefit STAR/PAL and the San Diego Police Officers Association Law Enforcement Memorial Fund in the name of fallen Officer Jeremy Henwood. The triathlon was held at the Lawrence Family Jewish Community Center in located in Northern Division where over 65 athletes competed in a 10 minute swim, 20 minute bike ride, and a 15 minute treadmill run. Law enforcement from all over the county competed alongside several community members in a fun and challenging way to benefit the youth and the Law Enforcement Memorial Fund.

Association of Corporate Counsel Black & White Ball - STAR/PAL was the beneficiary of this gala event put on by the Association of Corporate Counsel. The proceeds from the live and silent auctions directly benefitted STAR/PAL youth programs.

**Bike Rodeo-** *The STAR/PAL Bike* Rodeo is a safety-based program. Its primary intention is to convey vital information regarding personal safety for youth while riding their bicycle. The youth who participated range in age from 12 to 14. Law enforcement officers instructed 25 youth participants and community-based volunteers. They received a brief classroom session before riding their new bicycles, wearing their new helmets, in the bicycle skills class. Thanks to a generous donation from BIA Cares, youth were able to keep the bicycles and safety equipment after the rodeo.

Museum of Tolerance - STAR/PAL officers took 60 youth from the Teen LEAP program to the Museum of Tolerance where they toured the Holocaust Museum, ate lunch, and had the privilege to listen to and speak with a Holocaust survivor. The youth learned about humanity, tolerance, respect, and appreciation of our diverse society.



Circus Vargas - STAR/PAL took 30 underserved youth to the circus and coordinated another 60 underserved youth from other organizations who were also able to enjoy the experience. STAR/PAL continues to expose the youth in our programming to different and new experiences they may not otherwise have access to in the community they live in and the surrounding area. The youth were able to see amazing feats by a variety of performers (no animals are used in this circus).

My Girlfriends Closet - My Girlfriends Closet is a non-profit organization that gathers clothing throughout the year and puts on an event for girls from underserved communities. STAR/PAL employees coordinate the girls who participate in several STAR/PAL programs and take them to the event where they receive much needed clothing.

**Students Speaking Out Program** – A quarterly meeting for schools throughout the County on the benefits and uses of the Crime Stoppers program.

**Literacy First Charter School Presentation** – A presentation given to students on the day and the life of a police officer with a special guest appearance by Canine Officer Adair and his partner, Arie.

**Public Request Act Inquiries (83)** – The 2004 Public Records Act is a transparency tool that allows any member of the public access to public records. The San Diego Police Department completed 83 public records act requests for this quarter. Request are often as simple as a request for a police report or as in depth as a statistical analysis report spanning years.



**Social Media** – Social media is designed to enhance our communication outreach with the community. ## **Community Involvement**

**Inside SDPD-Police Foundation: " A Day in the Life of a SDPD Officer"** -An opportunity for the public to participate in non-bias based policing, learn principles of law and discuss use of force/human factors curriculum in a setting that encourages dialogue and interaction. Topics covered were Use of Force/Human Factors followed by demonstrations and interactive stations such as K-9, Taser, the Force Options Simulator, traffic stops and S.W.A.T. The event was attended by 55 members of the community and took place on February 27<sup>th</sup>.

**Citizen's Review Board (CRB) Training –** On March 12<sup>th</sup>, SDPD's Training Division hosted a one day event in which new CRB selectees were given training on Laws of Arrest, Use of Force/Human Factors, Defensive Tactics and Body Worn Cameras/Facial Recognition. They were also given an opportunity to use the Force Options Simulator to "experience" what officers go through in stressful situations. The event was attended by 15 CRB members.

**Community Police Engagement Training (CPET)** – The San Diego Police Department's Training Division, in conjunction with the San Diego Compassion Project and Community Assisted Support Team (CAST), have launched an initiative to reinstitute a part of basic police training that enables San Diego Police recruits/trainees to gain valuable insight from community members on how police officers are perceived, how to manage personal biases and how to bridge the gap that sometimes exists between community and police.

The program is called Community Police Engagement Training (CPET). During this quarter, the 105<sup>th</sup> Academy were in their "Observation Phases". During the phases, the trainees attended, participated in, and/or engaged in 15 community events, meetings or school events.

The bus tour for 47 new officers took place on Friday, April 1. The officers interacted with members from the Islamic Center of San Diego; the San Diego Gay, Lesbian, Bi-Sexual and Transgender Community Center; and learned from community members and officers how gang violence impacts local communities.

**Volunteer Services** – No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.

The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.



Currently, The San Diego Police Department has **115** active Crisis Interventionists, 350 RSVPs, 21 Reserve Officers, 102 VIPs, and 55 Cadets. Our RSVPs contributed 28,245 hours this quarter. Crisis Interventionists responded to 167 callouts assisting 874 people, worked 3,495 hours, and were on call and prepared to respond for an additional 2,884 hours; our Reserve Officers worked a total of 1,472.5 hours 690.5 of those hours went directly; our VIPs contributed 5,007 hours.

**Ride Along Program (231)** – The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

### **Community Outreach**

San Diego Resolution 15K Run - The Recruiting Unit interacted with runners and spectators, sharing information about the San Diego Police Department.

La Quinta High School - The Recruiting Unit gave a presentation on career opportunities as a police officer and dispatcher to students.

**Veterans Job Fair -** The Recruiting Unit participated in a job fair for veterans of the armed forces; they interacted with the public and shared information.

Lunar New Year - The Recruiting Unit set up a booth to pass out department memorabilia and interact with the community.

**Super Run 10K** – The Recruiting Unit interacted with runners and spectators, sharing information about the San Diego Police Department.

Southeastern Division Better a Block - The Recruiting Unit set up a booth to pass out department job information and interact with the community.

Chinese New Year - The Recruiting Unit set up a booth to pass out department flyers and interact with the community.

**Speaker's Bureau (13)** – The Speaker's Bureau is a shining example of community outreach. The Speakers Bureau program has been in existence for approximately twenty years. Department employees are trained to make presentations to various community groups, private businesses, and academic organizations such as the Boy Scouts, Qualcomm, and San Diego State University. Speakers provide the Department with positive visibility and citizens with important information, making them better informed and safer. Volunteer employees at each division are trained to present quality speeches on various crime prevention topics to community groups and organizations. By educating the community on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for its citizens. The topics include, but are not limited to: auto theft, burglary, domestic violence, firearm safety, graffiti vandalism, holiday safety tips, internal theft, identity theft, forgery, fraud, juveniles, landlord/tenant issues, narcotics, personal safety, Police

## **Community Partnerships**

**Alternatives to Detention (2)** – ATD is for the placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officer's location to conduct an assessment of the juvenile for placement. With parental consent, the juvenile will be placed in a home. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

**Joint Interagency Meeting (3)** – Monthly meetings presented by the Juvenile District Attorney's office. Multiple county law enforcement agencies attend this meeting in order to receive updates on laws regarding juveniles and training on various programs.

**Restorative Justice Summit (5)** – The San Diego Restorative Justice Summit was held on February 26<sup>th</sup>. Restorative justice refers to a process whereby those affected by an incident of wrongdoing come together, in a safe and controlled environment and resolve together how best to deal with its aftermath. The Juvenile Administration participated in the planning meetings for this summit and was in attendance for this event.

**Juvenile Justice Coordinating Council** – In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The JJCC is chaired by the county's chief probation officer and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.

**Interagency Safety Committee (2)** – The Interagency Safety Committee meets monthly to work on safety and quality of life issues for juveniles in the neighborhoods of City Heights. The committee is chaired by The Institute for Public Strategies and attended by representatives various community groups, San Diego Unified School District, the San Diego Police and San Diego City School's Police Department.

**Cultural Arts Alliance** – This program is designed to provide early intervention to deter juvenile offenders from further involvement in the justice system and to reduce the costs that are associated with the prosecution of the offender. The emphasis is on skill development and positive choices to assist the juvenile from further involvement in the Juvenile Justice System. The Juvenile Administration Unit has been attending meetings to assist in developing a curriculum for the diversion program.

**Rachel's Challenge** – On March 1, 2 016, The Juvenile Administration Unit attended the Rachel's Challenge anti– bullying presentation to learn more about this program. The Rachel's Challenge program is looking to establishing an office in San Diego and is looking for community partnerships. SDPD will be looking further into this program and partnership as they become established in San Diego.

**Juvenile Diversion** – The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

#### **Community Involvement**

**Junior Charger Training Camp (3)** – Juvenile Administration worked in conjunction with Star/Pal to offer youth football camps at various locations.

**Shop with a Cop (3)** – The San Diego Sheriff's Department is the host agency for this year's annual charity event. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings with other county law enforcement agencies in preparation for this event. The annual Shop with a Cop event will take place on December 3, 2016.



**Tri-N-Harder 4 Kids Triathlon** – On January 23<sup>rd</sup>, 2016, the Juvenile Administration Unit worked in conjunction with Star/Pal in the annual Tri-N-Harder-4-Kids triathlon. This charity event raised funds for Star/Pal programming and the SDPOA Law Enforcement memorial fund.

**MLK Parade -** The Juvenile Administration Unit participated in the annual MLK parade along Harbor Drive.

**School Safety Patrol event** – Juvenile Administration coordinates the School Safety Patrol for the City of San Diego. 68 elementary schools with approximately 1,700 SSP members participate in this program. On March 19, 2016, Juvenile Administration coordinated a day at Boomers amusement park for SSP members and their guests. 768 people attended this event and enjoyed unlimited access to the park.

#### **Community Givebacks**

**Bike Rodeo-** The Juvenile Administration Unit and area station Juvenile Service Team members worked in conjunction with Star/Pal and presented a Bike Ride safety program at Colina Park for 25 youths. After completing this program, 18 youth participants were given new bicycles and helmets.
