No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. The San Diego Police Department is dedicated to developing, building, and maintaining community partnerships throughout the city. Our Community Policing efforts are the foundation of those partnerships.

We accomplish our community policing strategy in a variety of ways but most can be put into four categories:

- **Community Partnerships** The meetings we have to discuss public I. safety, crime statistics, and quality of life issues.
- **Community Involvement** The events we participate in throughout the II. city to foster community relationships. Our ride-along program is an integral part of this.
- **Community Outreach** The ways we provide awareness, education, and III. information to the community about public safety, crime trends, and crime prevention.
- Community Givebacks The volunteering and charity efforts we IV. participate in inside and outside our normal work hours.

View neighborhood along with Recreation center staff attend this meeting to discuss the issues or events held at the park or recreation center. Southeastern CROs attend this meeting and discuss and try to resolve any issues related to the park such as; drug or gang related activity in the park and crime prevention tips.

MLK Recreation Center Council (3) - Meets every 3rd Thursday of the month at 12pm at MLK Recreation Center. Residents that live in the O'Farrell and Valencia Park neighborhoods along with recreation center staff attend this meeting to discuss the issues or events held at the park or recreation center. Southeastern CROs attend this meeting and discuss and try to resolve any issues related to the park such as; drug or gang related activity in the park and crime prevention tips.

Miscellaneous Meetings (3) - "As requested" meetings with community members, groups, and organization.

In April, May, and June Southeastern CROs and the Southeastern Juvenile Service Team met with a Lincoln High School Criminal Justice students to assist with a skit that was performed in June.



- In May, Southeastern CROs assisted SAY San Diego with a resident engagement meeting at the Las Serenas Apartments located at 4352 Delta Street. These apartments are a part of the Crime Free Multi Housing initiative. We discussed crime prevention within the apartments, neighbor issues, and when to call 911.
- In June, Southeastern CROs attended the "Friends of the Badge" charity luncheon. Southeastern Division was commended at this luncheon for the Community Policing Efforts for the 2nd year in a row.

Meeting with concerned citizens at 400 University – CRO Pinon met with citizens to discuss ongoing harassment and narcotic activity by homeless. CRO Pinon offered some strategies to alleviate vandalism, theft, loitering and littering associated with the large homeless population.

Community Involvement.

Tactical Combat Casualty Care (2) Presentation – CRO Surwilo is one of the instructors who assist with the facilitation of the course in attempting to get 100% of SDPD Officers trained. CRO Pinon attended TCCC course that provides the latest best practice knowledge of proper tourniquet application, when and how to apply combat gauze and or pressure bandages, airway and open injuries due to gunshot wounds or blasts.

Trolley Barn Park 25th Anniversary Neighborhood Celebration - CRO Pinon set up a recruiting booth, distributed safety information to families and displayed an SDPD vehicle for the kids. The event attracted hundreds of community members from surrounding neighborhoods such as Hillcrest, North Park, South Park, Normal Heights and Mission Hills.

Linda Vista Multi Cultural Fair - The Linda Vista Parade and Fair is held annually on the 6900 block of Linda Vista Rd. The event promotes cultural awareness and understanding within the City of San Diego. Captain Lucas, Lt. Wong and CRO Pinon participated in the parade and greeted hundreds of community members along the one mile parade route. At the fair, CRO Pinon set up a recruiting booth and distributed safety information to families and passed out SDPD stickers to the kids. The event attracted thousands of community members. Fashion Valley Mall Security Meeting/Drill Presentation –Western Division personnel met with the new security management team of Fashion Valley Mall to go over active shooter expectations and conducted a suspicious package drill with mall security.

Linda Vista Charter School Presentation – CRO Pinon and Officer Custer were interviewed by a 12th grade student. We answered approximately ten questions regarding who, what, when, where and why we wanted to be police officers.

US Navy Safety Stand Down for Coastal Riverine Squadron 3 – CRO Surwilo was a guest speaker for Riverine Squadron 3 and its 300 members to discuss summertime safety and distracted driver laws. CRO Surwilo then took numerous question regarding situations and laws some of the members had questions about which differed from their home states.

Kaiser Permanente Presentation – CRO Pinon and CRO Surwilo were invited to provide tips on defensive driving and safety tips for clinical staff during home visits. The attendees included approximately 160 registered nurses, physical, occupational, speech therapists, home health aides, social workers and volunteer chaplains. We discussed what to do during a home visit if weapons and illegal drugs are seen. Additionally, what to do if a family member becomes violent or they witness a domestic violence while in the home. San Diego Juvenile Interagency Group (2) - A monthly meeting aimed at dispersing up to date information related to juveniles and the law across San Diego law enforcement agencies.

Community Involvement

Life Skills Program (3) - A voluntary program to help youth currently being supervised by the Juvenile Gang Suppression Unit to establish skills and assist them in their transition to adulthood. The program offers an 8-week curriculum designed to educate and prepare the youth to become self-sufficient by providing them with tools to enter the work force, manage their money and finances, assist in obtaining a driver's license and/or identification card, offer tattoo removal, discuss military/college/trade school options, probation record sealing, and educate them on healthy lifestyles. The program consists of class lectures, field trips, and homework.

Mentoring Youth for Tomorrow (48) - A daily afterschool event (Mon-Thur). Mentoring Youth for Tomorrow (MYT) is a program that enables inner-city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with youth. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

Making Changes (13) - The Making Changes program is a year-round, 40-session program that brings youth, law enforcement, and volunteer mentors together for a civic engagement based curriculum, designed to educate high school teens about the importance of making positive life decisions and how these choices can impact their lives, their communities, the nation, and even the world. This program hopes to promote awareness about the importance of one's actions and the potential these actions have to make positive change. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

Teen LEAP (Leadership, Empowerment, Awareness Program) (24) - Teen LEAP is a 30-session curriculum led by STAR/PAL officers that encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, this program strives to promote awareness about community issues as well as provide young adults with the tools to address them through leadership and civic engagement. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood in Mid City Division.

Junior Chargers Training Camps (11) - STAR/PAL officers, with the support of the San Diego Chargers and NFL Play 60, run a series of Junior Chargers Training Camps each year throughout the County of San Diego. Each camp gives 100 youth participants (ages 8-14) from various communities the opportunity to run football drills with public safety volunteers. At the camps, youth not only learn about the basics of football but also hear from Chargers players and law enforcement officers about the importance of a healthy lifestyle through exercise and following academic goals. In addition, this program promotes positive interaction between youth and local law enforcement officers in a team sport environment.

Padres Baseball Clinics (5) - STAR-PAL officers, in partnership with the San Diego Padres, offer youth baseball camps at several local parks and recreation centers and school sites in underserved communities throughout greater San Diego during the spring and summer months. These two-day camps expose hundreds of boys and girls to the game of baseball while emphasizing the importance of academics, healthy choices, and fitness. In addition, this program promotes positive interaction between youth and local law enforcement officers in a team sport environment.

2nd Annual Unity Games Event – A softball game held in Southeastern Division to bring law enforcement and community members together. The softball game was a fun event where youth, adults, and law enforcement officers played side by side and continued to build long standing relationships. They ate lunch together and talked about partnerships and resources. This was a great way to use sports to further build the relationships between the San Diego Police Department and the community it serves.

San Diego Chargers Draft Fest – STAR/PAL had a booth and facilitated a youth obstacle course at this event for the community where local youth could interact in a positive, team sports environment with law enforcement officers.

STAR/PAL SDPD Officers/Probation Officer are on hand to provide information for the diversion class, to see if the juvenile qualifies due to the level of the crime and their criminal history, and to sign the juvenile up for the class after talking with a parent.

Better a Block – STAR/PAL participated in the Better A Block community outreach event put on by SDPD Southeastern Division where we helped to involve the community with law enforcement officers and to connect the community with resources in their area. We provided information and access to STAR/PAL programs aimed at youth in the area.

Community Involvement

Volunteer Services – No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.



The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.

Currently, The San Diego Police Department has 93 active Crisis Interventionists, 320 RSVPs, 28 Reserve Officers, 91 VIPs, and 50 Cadets. Our RSVPs contributed 28,493 hours this guarter. Crisis Interventionists responded to 179 callouts assisting **984** people, worked **4,001** hours, and were on call and prepared to respond for an additional 2,800 hours; our Reserve Officers worked a total of 1,484 hours 650 of those hours went directly to Patrol; our VIPs contributed 5,308 hours.

Ride Along Program (198) – The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

The topics include, but are not limited to: auto theft, burglary, domestic violence, firearm safety, graffiti vandalism, holiday safety tips, internal theft, identity theft, forgery, fraud, juveniles, landlord/tenant issues, narcotics, personal safety, Police communications, SDPD history, robbery, school safety, senior safety, sexual assault, shoplifting, stranger danger, traffic, transients and violence at work. Community Partnerships

Alternatives to Detention (1) – ATD is for the placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officer's location to conduct an assessment of the juvenile for placement. With parental consent, the juvenile will be placed in a home. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

Joint Interagency Meeting (3) – Monthly meetings presented by the Juvenile District Attorney's office. Multiple county law enforcement agencies attend this meeting in order to receive updates on laws regarding juveniles and training on various programs.

Juvenile Justice Coordinating Council (1) – In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The JJCC is chaired by the county's chief probation officer and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.

Interagency Safety Committee (2) – The Interagency Safety Committee meets monthly to work on safety and quality of life issues for juveniles in the neighborhoods of City Heights. The committee is chaired by The Institute for Public Strategies and attended by representatives various community groups, San Diego Unified School District, the San Diego Police and San Diego City School's Police Department.

Cultural Arts Alliance (3) – This program is designed to provide early intervention to deter juvenile offenders from further involvement in the justice system and to reduce the costs that are associated with the prosecution of the offender. The emphasis is on skill development and positive choices to assist the juvenile from further involvement in the Juvenile Justice System. The Juvenile Administration Unit has been attending meetings to assist in developing a curriculum for this diversion program. On June 8th, the first Art Alliance diversion class was conducted at Mid-City Division. Juvenile Administration and the Probation Dept. participated in this class.

Juvenile Diversion – The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

Community Involvement

Junior Charger Training Camp (2) – Juvenile Administration worked in conjunction with Star/Pal to offer youth football camps at various locations.

Padre Baseball Clinics (3) - Juvenile Administration worked in conjunction with Star / Pal to offer youth baseball camps at various locations.

Shop with a Cop (3) - The San Diego Sheriff's Department is the host agency for this year's annual charity event. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings with other county law enforcement agencies in preparation for this event. The annual Shop with a Cop event will take place on December 3, 2016.

School Safety Patrol Event (2) – Juvenile Administration coordinates the School Safety Patrol (SSP) for the City of San Diego. 68 elementary schools with approximately 1,700 SSP members participate in this program.

School Safety Patrol Night with the Padres - Juvenile Administration coordinated the annual SSP night at the San Diego Padres baseball game for 762 SSP members and their guests. All SSP members received special recognition prior to the game by participating in a parade on the field.



School Safety Patrol Day with Navy Seals – Southeastern Division sponsored a SSP day with the Navy Seals in Coronado. Juvenile Administration participated in this event along with 154 SSP members.

Community Outreach

Wellness Council Safety Forum (1) –On June 24, 2016, Juvenile Administration participated in the Wellness Council Safety forum in City Heights. This forum focused on the safety and wellness of youths in the neighborhood, especially around school zones.

Rachel's Challenge (1) –On April 7, 2016, The Juvenile Administration Unit participated in the Rachel's Challenge anti-bullying school assembly at Serra High School.

Bike Rodeo Safety Program -On June 9, 2016, the Juvenile Administration Unit worked in conjunction with Western Division JST and Children's Hospital and presented a Bike Rode safety program at Montgomery Middle School. Free bike helmets were provided to participants in need of one.

Bike Rodeo (2) –On May 25, 2016, the Juvenile Administration Unit worked in conjunction with Star/Pal and presented a Bike Rodeo safety program at Balboa Elementary School. 1 free bike and helmet was given away.

Community Givebacks

Children's Hospital Visit –On May 10, 2016, in conjunction with the Teddy Bear Drive, SDPD Juvenile Administration coordinated a visit to patients at Children's Hospital. Officers spent time with patients and presented them with stuffed teddy bears and other gifts.

Teddy Bear Drive (2) – The Teddy Bear Drive is an annual county wide law enforcement community event to bring stuffed animals to children being treated at Rady's Children's Hospital. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings and fund raising events throughout year. This year's 26th annual Teddy Bear Drive is scheduled for December 6, 2016.

Annual Shop with a Cop BBQ fundraiser – This year it took place at the SDSO Headquarters.



Bike Rodeo at Colina Park -The Juvenile Administration Unit and area station Juvenile Service Team members worked in conjunction with Star/Pal and presented a Bike Ride safety program at Colina Park for 25 youths. After completing this program, 18 youth participants were given new bicycles and helmets.
