INTRODUCING SDPD's SCHOOL SAFETY PATROL PROGRAM



In February of 1935, the San Diego Police Department started developing a "School Safety Patrol" (SSP) program due to the high number of accidents involving elementary school children. In 1936, the program became fully operational. The initial School Safety Patrol consisted of one police officer supervising 12 boys who guarded one crossing location. Prior to this time, there were other School Patrols in operation, but their duties consisted of holding back pedestrians until there was a sufficient break in traffic for them to safely cross the street.

The San Diego Police Department was one of the first organizations to create a program which actually allowed student crossing guards to stop traffic so children could cross after appropriate legal requirements were enacted. Most safety experts were reluctant to give elementary school children the responsibility of stopping traffic to provide safer crossings. San Diego Police Department's experience, over the past 82 years, has proved that the program is not only extremely cost effective but completely safe as well.

Students are recruited, selected and trained near the end of their 4th grade year by the San Diego Police Department and the officers of the Juvenile Service Teams. Currently the SSP operates nearly 100 crosswalks at 77 schools throughout the City of San Diego. The program consists of approximately 1,615 Elementary School students in the 5th and 6th grade.

SSP is responsible for the safe crossing of thousands of students and adults on a daily basis while walking to and from school. SSP squads consist of 3 to 6 person teams that work in the rain, heat, and cold without complaint controlling vehicle and pedestrian traffic. SSP members give up hundreds of hours before and after school in order to make their school and community a safer place.

These students are dedicated, confident and strong role models to their fellow classmates by setting an example of commitment, responsibility and safety. In addition to their time as crossing guards, the San Diego Police Department Juvenile Administration Unit organizes monthly events for the SSP members as incentives. These events include: San Diego Padres Baseball games, San Diego Gulls Hockey games, Trampoline Park trip, new release movie days, and a trip to Boomers Kid Park of San Diego where all SSP family and friends can attend.





No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. The San Diego Police Department is dedicated to developing, building, and maintaining community partnerships throughout the city. Our Community Policing efforts are the foundation of those partnerships.

We accomplish our community policing strategy in a variety of ways but most can be put into four categories:

- **Community Partnerships** The meetings we have to discuss public I. safety, crime statistics, and quality of life issues.
- **Community Involvement** The events we participate in throughout the II. city to foster community relationships. Our ride-along program is an integral part of this.
- **Community Outreach** The ways we provide awareness, education, and III. information to the community about public safety, crime trends, and crime prevention.
- Community Givebacks The volunteering and charity efforts we IV. participate in inside and outside our normal work hours.

Cortez Hill Community Meeting – Meets quarterly with local residents to discuss current events and criminal activity occurring in the Cortez Hill community.

East Village Association (2) – Meets monthly to discuss criminal activity that is occurring around local businesses.

East Village Residents Group (2) –Meets every other month to discuss criminal activity that is occurring around residential buildings in the East Village area.

Gaslamp Quarter Association (2) - Meets monthly to discuss criminal activity that is occurring around local businesses.

Gaslamp Quarter Association Special Events (2) - Meets monthly to discuss how events impact the Gaslamp area.

Little Italy Association (2) - Meets monthly to discuss business owners and residents to discuss public safety concerns and current criminal activity that is occurring.

Little Italy Residents Association – Meets quarterly to discuss public safety concerns and current criminal activity that is occurring in the area.

Safety Network Meeting (3) - This meeting is hosted by Downtown Partnership. It meets quarterly to discuss public safety concerns and current criminal activity that is occurring on business properties.

Safety Taskforce Meeting (5) – This meeting is hosted by Downtown Partnership. It meets every other week to discuss public safety concerns and current criminal activity that is occurring in the area. This meeting is attended by: SDPD, Environmental Services (ESD), a Sheriff Deputy, MTS, a Deputy City Attorney, and Mental Health Services to share safety information especially regarding transients and the mentally ill.

The findings were used to understand the problem and a follow up public meeting was held at a later date to discuss the problem, solutions and plans to keep the area clean, safe and open to everyone in the city.

Liberty Station Homeless Community Meeting –Liberty Station residents and property management have been increasingly concerned regarding homeless people using the eastern edge of the park for extended periods of the day. The homeless have been seen storing their property with them at the picnic areas, barbequing in the parks barbeques, and drinking beer. Community Relations Officer Surwilo and Pinon held a meeting to hear the community's concerns and educate them on how the division has been directing officers to provide extra foot patrol to the park area. The officers have been arresting or citing anyone committing a violation in the park and working with the City Attorney's office to obtain stay away orders. Officers have also been working closely with the Park & Rec management and grounds crew to address the issue of unattended property and trash. During the meeting the CROs explained how to best report violations and how the partnership between the police, residents and commercial management can work together to resolve the problems.

Ocean Beach Main Street Association (2) – Regular follow up meetings with staff at OBMA to discuss status of neighborhood nuisance issues related to transients, parking and other community issues.

Notes were taken and issues were addressed and the CROs conducted follow up with the citizens regarding their induvial concerns.

Hillcrest Security Follow Up Meeting – The CROs met with Hillcrest business managers, business owners and the staff of the Hillcrest Business association to discuss trespassing homeless individuals in the local area. CPTED strategies were discussed and proper notifications were made.

The training was to educate the staff on personal safety and warning signs when interviewing clients and how to maintain personal safety during these contacts.



Chief's Community Outreach Walk - On August 9th, Western Division Command Staff and Community Relations Officer, along with Executive Chief Jarvis participated in a community outreach walk in Point Loma's Liberty Station community. During the walk, numerous citizens were contacted along at their homes with the intent of building stronger relations with our community members. The outreach was well received by the community who expressed appreciation for the presence and the time spent listening to concerns.

Fashion View Condos HOA Board Meeting -CROs were invited to the Fashion View Condos HOA Board Meeting to discuss the boards concerns regarding activity within the complex and on the streets around the condos. During the meeting Officer Surwilo listened to the residents' concerns and offered suggestions and advise. After the meeting Officer Surwilo followed up on the complaints which were related to trash on city streets and was able to get crews to the area to clean the litter and provided extra patrol. The community reached back out to the division and thanked us for a job well done.

City Council Representative Ride-Along – Due to questions about the current state of homeless in the Hillcrest community and the large number of complaints coming into Council Member Chris Ward's office one of his field reps was taken on a ride along with CRO Surwilo. The complaints and concerns mainly surrounded an increase of homeless and reports of more acts of violence and extremely aggressive homeless. The Council Rep was taken to numerous locations throughout the Hillcrest area to meet and engage in conversation with the homeless to better understand the view of the homeless. During the ride numerous homeless stated they felt the streets had become more violent due to more homeless using drugs and competing for space and resources. When asked if they would like shelter all but one homeless person stated they would not be willing to except shelter.

Citizen Request for Assistance -CROs followed up for a resident on Bear Street regarding construction trucks parked in No Parking Zone. Met with foremen after verifying the trucks were only stopped at the location long enough to load and unload equipment and supplies.

Hillcrest Business Association (2) – Follow up meetings with BID Director of Hillcrest to discuss status of neighborhood nuisance issues related to transients, parking and other community issues.

Hillcrest Pre-School Extra Patrol -CROs continued extra patrol for a Pre-School suffering homeless trespassing and loitering. As part of the project CROs met with local residents offering strategies to alleviate trespassing and vandalism associated with the homeless population.

Rosecrans / Midway Drive Crime Prevention through Environmental Design-Visited numerous intersections with Council Member staff to discuss community complaints regarding aggressive solicitation and discuss possible Municipal Code verbiage to prevent loitering upon mediums which would create safer intersections for drivers.

St. Charles Church Crime Prevention through Environmental Design -CROs met with the grounds manager to discuss trespassing and theft on their property. Scripps ER Hospital Meeting - CROs participated in a meeting with Scripps Hospital security management and ER staff regarding policy and procedures with interaction and expectation between ER staff nurses and patrol officers.

Sunset Cliffs Park / Del Mar Ave Citizen Complaint (4) - CROs addressed residents' complaints regarding a constant homeless camp at the foot of Del Mar Ave overlooking Sunset Cliffs. The complaint consisted of chronic drug use, trash, homeless camping and human waste. CROs conducted extra patrol and partnered with Park & Rec, Environmental Services and the division's Quality of Life Team to address and resolve the problem.

Mesa College Parenting Presentation - Discussion to educate parents on infant/child car seat safety and the danger of leaving children inside a car during a warm day. All parents were given informational handouts referencing our safety discussion. Questions and answers were exchanged and solutions were given.

Canon St. Pocket Park Workshop – CRO Pinon participated in the design workshop for the Canon St. pocket park. The park shall be located at the west end of Ave. de Portugal.

San Diego University Class Project – Students from San Diego University meet with Western Division's CROs to answer questions regarding law enforcement and current staffing issues with the law enforcement filed and here in San Diego.

Father-Daughter Lunch -CROs attended the annual OLPA Father-Daughter Lunch. Interacting with numerous students, parents and staff answering questions and telling stories during numerous conversations.

EF Education First – The CROs provided extra patrol and would visit the security and schools staff due to recent bike thefts and provide assistance answering questions from staff and students.

Bear Drive / West Walnut Citizen Complaint -CROs investigated a resident's complaint regarding illegal construction parking at the dead-end of Bear Drive. CROs conducted extra patrol and met with the Foremen of the construction project and verified the trucks were only parked there while actively unloading supplies and equipment.

Kaiser Permanente Home Care Department – CRO Pinon met with case managers from Kaiser Permanente Home Care Department. Speaking to staff members who will be conducting field evaluation of clients. The training was to educate the staff on personal safety and warning signs when interviewing clients and how to maintain personal safety during these contacts.

Park Place Estates Neighborhood Crime Prevention through Environmental Design -CROs met with members of the HOA board to perform a CPTED survey of the large complex. CROs offered strategies to alleviate trespassing, theft and vandalism associated with the homeless population.

Pt. Loma Association Homeless Sub-committee meet and greet -Capt. Connelly, Lt Dobbs and the CROs met with Councilwomen Lori Zapf and the leadership of the newly formed Point Loma Association Homeless Sub-committee to discuss community concerns and how the committee, police and council office can partner and work to resolve concerns.

USDA Forest Service Q&A Meeting -USDA Forest Service staff requested a meeting with the Western Division's CROs regarding what to watch out for while conducting vegetation plot surveys throughout the city. The staff was concerned about their personal safety and suggestions regarding tips to prevent theft of their expensive equipment. They have about 200 48-foot radius ground plots from which to gather data spread throughout the city, and will be visiting many neighborhoods.

The Center (LGBTQ Community) -CROs met with counselors of The Center to discuss a sex trafficking case. CROs met with a victim of sex trafficking and took a police report. CROs comforted the victims and assisted with all of their needs.

Community Involvement

Community Partnerships

San Diego Juvenile Interagency Group (2) – A monthly meeting aimed at dispersing up to date information related to juveniles and the law across San Diego law enforcement agencies.

Shop with a Cop Committee (3) – A monthly meeting with agency representatives for the planning of the 2016 Shop with a Cop event. STAR/PAL is responsible for coordinating the 300+ youth participants by working with school counselors and officers from throughout the County for referrals.

Community Involvement

We Can (9) –A program where high school students are encouraged to be effective leaders within their schools and communities. Additionally, the program works to better relationships between the students and law enforcement. Topics covered include self-awareness, public speaking, consequences of substance abuse and dangers of social media.

Mentoring Youth for Tomorrow (12) – Mentoring Youth for Tomorrow (MYT) is a program that enables inner-city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with the youth. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

Making Changes (3) – The Making Changes program is a year-round, 40-session program, that brings youth, law enforcement, and volunteer mentors together for a civic engagement based curriculum. It is designed to educate high school teens about the importance of making positive life decisions and how these choices can impact their lives and their communities. This program hopes to promote awareness about the importance of one's actions and the potential these actions have to make positive change.

Teen LEAP (Leadership, Empowerment, Awareness Program) (2) – Teen LEAP is led by STAR/PAL officers and staff and encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, the program strives to promote awareness about community issues. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood of San Diego.

MAN UP Diversion Program (4) – A program for teenage boys that focuses on selfesteem, juvenile law, basic life skills including dangers of social media and substance abuse.

Life Skills (8) – A program to help youth who are currently supervised by the County Probation's Juvenile Gang Suppression Unit. It is designed to develop skills and provide the youth with the resources needed to transition to adulthood.

Girl-E (4) – This is a 6 week program for teenage girls that focuses on self-image, juvenile law, basic life skills, including the dangers of social media, human trafficking, sexually transmitted diseases, and substance abuse.

Get Elevated (8) – A program where youth are engaged with the San Diego Police Department, the Army National Guard, and Toastmasters International. Youth learn teambuilding, social responsibility, conflict resolution, goal setting, financial literacy, leadership, community service, etiquette training and civic engagement..

Community Outreach

National P.A.L. Basketball Clinic – STAR/PAL, in conjunction with the National Police Athletic League, the Retired NBA Players association and the WNBA, held a basketball clinic in Balboa Park for 60 youth from under-served communities.

National Night-Out Event – STAR/PAL hosted a National Night Out event at Colina Del Sol Park. National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie to make our neighborhoods safer, more caring places to live. National Night Out enhances the relationship between neighbors and law enforcement while bringing back a true sense of community.



STAR/PAL Annual Surf Clinic – The annual Surf Clinic brings together law enforcement officers, firefighters, & lifeguards from a variety of agencies in San Diego to teach 60 boys & girls the fundamentals of surfing while learning about water safety. Youth (9–15 years old) were selected from underserved communities to participate in the program.

Community Giveback

Eastern Division Open-House – STAR/PAL officers assisted Eastern Division with an Open House event at their facility. STAR/PAL staffed an informational boothand informed the community on on-going STAR/PAL events and programs.

Crime Stoppers – San Diego County Crime Stoppers Inc. provides three ways that the public can submit tips anonymously to report on felony crimes; they can call a tip line (888) 580–8477, submit a tip via the website or send a text tip from their phone. Crime Stoppers combats the three major problems law enforcement faces in gathering information; fear of reprisal, apathy, and a reluctance to get involved. San Diego County Crime Stoppers Inc. overcomes these challenges by providing citizens a safe way to anonymously report crime and rewards citizens for tips leading to a felony arrest.

Community Partnerships

Crime Stoppers Information Meetings (3) – An "as requested" meeting to define the role of Crime Stoppers in crime prevention strategies.

Students Speaking Out Program – A quarterly meeting for schools throughout the County on the benefits and uses of the Crime Stoppers program.

Community Involvement

In August, members of Crime Stoppers attended a community fair in the Santa Luz area.

In August, members of Crime Stoppers conducted a presentation to members of the San Diego Downtown Breakfast Rotary Club. The purpose of this presentation was to provide an overview of both the Crime Stoppers and Students Speaking Out programs to members of the club.

In September, Crime Stoppers had an information booth inside Petco Park during a San Diego Padres game.

Community Outreach

In August, members of Crime Stoppers attended two separate National Night Out events to provide community members with information on how to anonymously report crime in their neighborhoods.

Crime Free Multi-Housing Program - In 2010, the San Diego Police Department entered into a collaborative partnership with the Institute for Public Strategies (IPS) and the managers/owners of San Diego multi-housing communities dedicated to crime prevention and the Crime Free Multi-Housing Program. In 2012, Say San Diego resumed the program from IPS and to date, 247 properties have been certified. The program illustrates the success of communities, nonprofit organizations, and law enforcement working to keep illegal activity out of the city's rental properties.

Community Involvement

Crime Free Multi-Housing Final Certification (4) -Final Certification is when an apartment communities completes all 3 Phases: an 8 hour manager's class, passed the CPTED inspection, and participated in a resident engagement meeting receiving a Crime Free Multi-Housing certification certificate.

Annual Recertification (4) - Every year the properties get their recertification from their previous year certification if they choose to continue the program.

Community Outreach

Crime Prevention Through Environmental Design Inspections CPTED (19) - Rental property inspections to assess physical security and general appearance of property to deter criminal activity.

Safety Meetings (23) - Meetings held with property owners, managers and residents to discuss the Crime Free Multi-Housing Program, CPTED, reporting guidelines, and general safety information.

Social Media - Social media is designed to enhance our communication outreach with the community. The San Diego Police Department currently uses three primary forms of social media that include Facebook, Twitter and Nextdoor.com. These platforms allow the Department to provide meaningful and timely information to our public on a variety of topics including community events, notification of crime issues, news stories and major incidents occurring in the City.

Members of the San Diego Police Department Speakers Bureau are trained to provide quality presentations on various crime prevention topics to community groups and organizations. By providing outreach education on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for our communities. Members spoke at 5 events during this quarter.

Community Involvement

Volunteer Services – No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.



The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.

Currently, The San Diego Police Department has 108 active Crisis Interventionists, 306 RSVPs, 22 Reserve Officers, 75 VIPs, and 53 Cadets. Our Cadets contributed 410 hours this quarter. Our RSVPs contributed 27,444 hours this quarter. Crisis Interventionists responded to 140 callouts assisting 684 people, worked 3,133 hours, and were on call and prepared to respond for an additional 2,801 hours; our Reserve Officers worked a total of 1,396.5 hours and our VIPs contributed 2,941.5 hours.

Ride Along Program (161) – The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

Community Outreach

Community Recruiting Events (58) – The Recruiting Unit gave presentations on career opportunities as a police officer and dispatcher at 50 community events throughout the City and County.

Community Partnerships

Alternatives to Detention (2) –ATD is for the placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officers' location to assess the juvenile for placement. With parental consent, the juvenile is placed in a home. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

Joint Interagency Meeting (3) – Monthly meetings presented by the Juvenile District Attorney's office. Multiple county law enforcement agencies attend this meeting in order to receive updates on laws regarding juveniles and training on various programs.

Juvenile Justice Coordinating Council –In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The County's Chief Probation Officer chairs the JJCC and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.

Central Region Safety Environment Workgroup/Live Well San Diego – This work group concentrates on improving the health of residents, ensuring residents are protected from crime and abuse, neighborhoods are safe, communities are resilient to disasters and emergencies and cultivating opportunities for all people to grow, connect and enjoy the highest quality of life. Juvenile Administration attends monthly meetings to advise board and community members on safe practices, crime prevention, and disaster preparation.



Juvenile Diversion – The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

Community Involvement

Shop with a Cop (3) -The Oceanside and Carlsbad Police Departments are the host agencies for this year's annual charity event. The Juvenile Administration Unit coordinates our Department's efforts. The annual Shop with a Cop event will take place on December 2, 2017.

Teddy Bear Drive – The Teddy Bear Drive is an annual countywide law enforcement event to bring stuffed animals to children treated at Rady Children's Hospital. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings and fund raising events throughout year. This year's 27th annual Teddy Bear Drive is scheduled for December 5, 2017.
