The City of San Diego's Crime-free Multi-housing (CFMH) Program is a FREE program and a win-win crime prevention tool for apartment communities. The CFMH Program is successful because it approaches crime on many levels. The Police Department can't solve crime alone, and neither can management staff or residents of rental properties. However, by working together, the end result has been the most successful approach to deterring crime in rental properties.

#### There are three ways criminal activity occurs on a rental property:

- 1. The criminal lives there.
- 2. The criminal visits a friend or family member who lives there.
- 3. A criminal comes to the property and commits a crime.

The Crime-free Multi-housing Program addresses all three of these possibilities. By implementing the CFMH Program, property owners and management staff reduce the likelihood of crime and reduce the number of visitors who come to the property with criminal intent, such as to purchase or sell drugs.

Integral to the CFMH Program are the Crime Prevention Through Environmental Design (CPTED) principles that, when implemented, help to deter crime from occurring on the property, including in parking lots and the common areas.

Social Advocates for Youth (SAY) San Diego (www.saysandiego.org), a Social Services Agency, is a collaborative partner with the San Diego Police Department to administer the CFMH Program. The relationship between SDPD and SAY San Diego, under a Memorandum of Understanding, is unique and ensures successful implementation of the CFMH Program and long-term support to the management staff at apartment communities within the program. The CFMH Program consists of three phases that are implemented under the supervision of the San Diego Police Department. Property managers become certified after completing Phase I Manager Training, and the property becomes certified upon successful completion of Phase II CPTED & Phase III Resident Engagement.

<u>*Phase I Manager Training:</u>* Facilitated by a Certified Crime-free Coordinator, it is an eight-hour class that owners, managers, security and maintenance staff are invited to attend.</u>

**Phase II CPTED Inspection:** An inspection to determine if the property meets the principles of Crime Prevention Through Environmental Design.

**Phase III Resident Engagement and Full Certification:** A safety social facilitated by the Community Relations Officer (CRO) and a SAY San Diego staff member. This event provides an opportunity for residents to become familiar with the CFMH Program and to understand that they are partners in keeping themselves and the property safe. The property receives certification and a sign for the building. Certification is renewed annually.

If law enforcement, property managers and residents make a dedicated commitment to the Crime-free Multi-housing Program with the principal guideline of crime prevention, the result will be safer apartment communities.

- Community Givebacks The volunteering and charity efforts we IV. participate in inside and outside our normal work hours.



**East Village Association (2)** –Meets monthly to discuss criminal activity that is occurring around local businesses.


**Thanksgiving Dinner Giveaway Event -** Central Division Officers and Staff members distributed full Thanksgiving Dinners to members of the community.

**Neighborhood Walkthrough** –Walk through of Allied Gardens neighborhood to meet with residents and discuss their issues.







#### **Community Partnerships**

**Captain's Advisory Board Meetings-** Northwestern officers and command staff host a meeting held every month as a collaboration with the community to address community policing, public safety and quality of life issues. CAB members are selected from the community and give a well-rounded insight into Northwestern's community. Guest speakers and special presentations give the CAB members a greater understanding of the special tasks and skills the San Diego Police Department has to offer.

**Neighborhood Watch Meeting-** Meetings held in a residence and community rooms to discuss setting up a Neighborhood Watch groups and quality of life issues. Many neighborhood watch groups utilize Nextdoor.com as a conduit of communication to address crime awareness and prevention. Several neighborhoods in Northwestern Division are in the planning stages of starting new Neighborhood Watch groups.

**Qualcomm Active Shooter Response Plan Field Training Exercise** – This 3 hour exercise was a culmination of a several year partnership with members of SDPD and Qualcomm security to create a plan which facilitates San Diego Police Department's emergency response to Qualcomm's 40 buildings within Northwestern Division. FTX included approximately 40 participants and role players to give a life like exercise. Input, recommendations and first responder insight helped to mold the exercise and create the active shooter plan in place today.

**Miscellaneous Meetings (6) –** "As requested" meetings with community members, groups and organizations.

- Northwestern CRO attends four monthly community planning board meetings to keep a constant open line of communication open between active community members and the police department. During these meetings, members are able to address issues related with their specific communities.
- Northwestern investigators attended the Impact Meeting at the Sheriff's North County Coastal Station and discussed regional issues such as car prowls, burglaries, or other series-related events. Detectives have been able to link several North County cases together due to the information shared in these meetings.

- Northwestern officers attended a citizens' meeting and discussed crime prevention and home protection. Information was given out to several residences in the Northwestern Division to better help citizens protect their homes from burglary.
- Muslim Community Center of Greater San Diego hosted an open house which was attended by San Diego Police Officers and local community members. MCC families were able to interact with law enforcement officers and feel more comfortable for future interactions.



The objectives of the Council are to provide a forum for discussion of community issues, take a stand on community issues as authorized by the membership, communicate community views to the appropriate organizations, and sponsor programs that benefit Clairemont.

**University City Community Association (UCCA) (3)** –A non-profit organization which provides and promotes the civic, cultural, social, educational and recreational development/ improvement in University City and provides a forum where the interests of residents may be expressed.



**University City Planning Group** (3) - There has been long-standing citizen involvement in planning in the City of San Diego. The City Council adopted policies in the 1960s and 1970s that established and recognized community planning groups as formal mechanisms for community input in the land use decision-making processes. 





**Francis Parker High School Crosswalk and Student Drop Off Meeting** –CRO's and JST attended the Francis Parker High School Crosswalk and Student Drop Off Meeting. The school staff raised concerns regarding students crossing Linda Vista Road and the manner in which parents were dropping off students. Suggestions were made by the CRO and JST officers which have been implemented resulting in improvements to the drop off and pick up procedure.

**Hillcrest Security Follow Up Meeting** – The CROs met with Hillcrest business managers, business owners and the staff of the Hillcrest Business association to discuss trespassing homeless individuals in the local area. CPTED strategies were discussed and proper notifications were made.

**Linda Vista Bayside Community Center Meeting** –CROs met with supervisors of the Bayside Community Center to discuss concerns from the citizens of the Linda Vista Community.

**Sports Arena Village Meeting** –Meeting between CROs with property management and business tenants regarding property issues caused by homeless loitering, altercations and thefts. The CROs provided suggestions to address all of the concerns and conducted follow extra patrol resulting in improvements to the problem.

**Meeting between Western Division, USD and Impact Linda Vista Initiative** – Lt. Bautista and CRO's met with local leaders seeking to bring USD faculty and students together with community partners like Western Division to develop innovative and sustainable collaborations in Linda Vista.

**Ocean Beach Code Violation Meeting –** CRO's met with a concerned citizen regarding multiple code violations in the Ocean Beach Business District. The CRO's took notes and all issues were resolved with assistance of our Code Enforcement Division.

Linda Vista Bayside Community Center Meeting - Supervisors of the Bayside Community Center met with Western Division's CROs to discuss concerns from the citizens of the Linda Vista Community.

Kearny Neighborhood Schools Committee -CROs met with the Chair of the Kearny Neighborhood Schools Committee to discuss crime as it relates to the students living in the Linda Vista Community.

Neighborhood Parking Concerns Meeting (4) – Western Division CROs assisted several citizens throughout Western Division with 72 hour parked vehicle violations. The vehicles were properly marked and towed at the citizen's request.

Mission Hills Neighborhood Watch Meeting -CRO's met with residents to discuss Neighborhood Watch and provide crime prevention tips related to vehicle breakins, residential burglary and homeless trespassing.

**The Center (LGBTQ Community) (2)** – CROs met with counselors of The Center to discuss community concerns and foster communication between the Center and the police.

Scripps ER Hospital Meeting – Command Staff and the CROs participated in a meeting with Scripps Hospital security management and ER staff regarding policy and procedures with interaction and expectation between ER staff nurses and patrol officers.

Crime Free Multi Housing Meeting –CROs met with residents of the Loft condominium community and awarded them with a Crime Free Multi Housing Certificate of completion. CROs discussed crime prevention and how to report illegal activity and report suspicious behavior they may observe at the location.

YMCA Community Needs Assessment Meeting -CRO's met with representatives of the YMCA to discuss community needs for Point Loma. The YMCA is seeking ideas to develop programs for people of all ages in Ocean Beach.

Liberty Station Neighborhood Watch Meeting - Community members requested assistance forming a new Neighborhood Watch Association for the area around Liberty Station. The meeting with the CRO's had approximately 30 citizens in attendance who had concerns with recent crime trends and homeless in the general area.

Hillcrest Business Association (2) - Follow up meetings with BID Director of Hillcrest to discuss status of neighborhood nuisance issues related to transients, parking and other community issues.

### **Community Involvement**

Ocean Beach Elementary Crosswalk safety Demonstration – CRO's attended the Ocean Beach Elementary Crosswalk Safety Demonstration hosted by parent volunteers to highlight Traffic Awareness. This peaceful demonstration's goal was to help promote driver and pedestrian child safety in the area of the Ocean Beach **Elementary School.** 

Linda Vista Park Dedication to John Baca- Lt. Bautista attended the dedication of a monument and park in Linda Vista to a local Vietnam War hero named John Baca.

Ocean Beach Christmas Parade – Command Staff represented the San Diego Police Department and western division in Ocean Beach's Annual Christmas Parade.

San Diego School Safety Patrol Gulls Hockey Night – CRO and JST officers from Western Division attended the San Diego School Safety Patrol night at the Gulls Hokey game.

DEA Drug Take Back at Western Division - CRO Pinon and CRO Surwilo participated in the Drug Enforcement Agency's (DEA) National Prescription Drug Take Back Day at Western Division. Community members were given the opportunity to get rid of unwanted and expired prescription drugs. At Western Division we collected the third highest amount of prescription drugs in San Diego County.

First Quarter Honors – CRO's and JST officers attended Saint Vincent Elementary School's First Quarter Honors Award Assembly. The school invited the officers due to the long standing partnership with both its Safety patrol Program and in classroom community policing lesson plans.

San Diego County Federation of Republican Women -SD County Federation of Republican Women hosted radio talk show commentator Larry Elder and requested a police presence due to safety concerns and possible protestors. The CROs provided a presence. The attendees where extremely supportive of the CROs and expressed their appreciation for all of our nations police officers.

Presentation by USD professor and students - University of San Diego Professor Ivanic and marketing students presented their final research project to Western Division Command Staff and SDPD recruiting Department. The information gathered from the presentation was beneficial to our SDPD recruiting team.

Ocean Beach Christmas Tree cut down and delivery - Numerous Officers' from Western Division's patrol and Traffic Division's Motor Unit assisted with traffic control for the Ocean Beach Christmas tree delivery. The 45' tall tree was cut down at a local resident's home and trucked to the foot of Newport Ave and stood up on the beach. This is a partnership between the police department, the Ocean Beach Main Street Association and the Ocean Beach Town Council. After the tree is delivered children from the local Ocean Beach elementary schools come down to decorate the tree with their handmade ornaments.

Special Olympics Red Robin Tip-A-Cop -CRO's attended the annual Tip-A-Cop fundraiser hosted at the Red Robin in Northern Division. The event raised thousands of dollars benefiting local athletes competing in the next Special Olympic Games.

**San Diego County Crime Stoppers 5k** –Western Division administrative and patrol staff signed up to support the Annual San Diego County Crime Stoppers 5k. The division signed up and raised the most money of any other division and placed well in the 5k.

2017 Ocean Beach Awards Dinner - Western Division Command Staff and CRO's attended the Award's Dinner hosted at the OB Surf Lodge. The Ocean Beach Town Council and local elected officials were present to recognize outstanding community members and volunteers who have gone above and beyond in their service to Ocean Beach.

National Coffee with the Cops - Hosted by the Meshuggah Schack in Mission Hills the Command Staff, Patrol Sergeants, Detectives, Patrol Officers and CRO's shared a cup of coffee with citizens in the community. During this time we took questions from citizens regarding community safety and resident concerns.

Appreciation Luncheon – The Branch Church served lunch at Western Division to the police officers to show their appreciation.

Point Loma Community Annual Walk to School Day - Western Division JST and CRO Officers escorted students, parents, teachers and volunteers from Pete's Coffee shop to a local elementary school, promoting safe routes to school.

Linda Vista Library - Lt. Bautista attended the Linda Vista 75<sup>th</sup> Anniversary Celebration. The event was well attended by many members of the Linda Vista Community.

## **Community Outreach**

**Safety Patrol Training (2)** –CRO's held training for students participating with their school's Safety Patrol Program.

City Council District 3 Coffee & Conversation – Western Division Command Staff attended Council Member Ward's hosted Coffee & Conversation event. After a brief introduction command Staff answer questions and interacted with numerous citizens of the community to discuss quality of life issues, community policing and general concerns.

Adult Education Child Safety Talk (2) – At Pepper Grove Park, Western Division CROs conducted an Infant Car Seat, Toddler Hot Car Death Prevention and Child Safety Presentation to the adult students of Mesa College regarding child safety and general personal and vehicle safety tips.

Rady Children's Hospital Safe Routes to School (3) - CRO's joined Rady Children's Hospital, city engineers, community members and school staff to walk around Chesterton Elementary to discuss safety concerns and how we can address them together.

City Council Member Riverbed Escort – Due to the current state of the homeless crisis in the city of San Diego and the Hepatitis A breakout Council Member Lori Zapf requested Western Division CRO's escort her and her staff through the riverbed to homeless campsites. The event was to allow Council Member Zapf to see first had how bad the riverbed encamp issue is and to film a PSA for a local High School film class project. Council Member Zapf was taken to numerous locations throughout the riverbed area and shown the magnitude of the problem and large amount of trash and debris left by the homeless.



**US Navy Safety Stand Down for Fleet ASW Training Center Presentation** –CRO Pinon was a guest speaker at the US Navy Fleet ASW Training Center. The presentation was attended by approximately 300 Navy Officers. Officer Pinon discussed holiday related crime prevention, DUI laws and answered questions regarding how to interact with police when pulled over and traffic safety.

**Hillcrest Mission Valley Lions Presentation -**CRO's were invited as guest speakers to explain and provide examples on when to call the emergency line 9-1-1 versus calling the non-emergency line 619 531-2000.

**Washington Elementary STEAM Magnet Presentation** – CRO's and City Attorney were invited to speak with a group of 5<sup>th</sup> graders to discuss a career in law enforcement.

**EF Education First** – The CRO's met with six new Education First security Officers to answer questions regarding how to report crimes. CRO's provided EF with crime tips to help reduce the amount of bike thefts around their school.

**Citizen Request for Assistance Outreach** – Due to complaints from businesses CROs followed up along Hancock Street regarding trailers parked along the curb for extended periods of time. All parents were given informational handouts referencing our safety discussion. Questions and answers were exchanged and solutions were given.

**EF Education First Outreach** – The CROs provided extra patrol and would visit the security and schools staff to foster relationships and communication. The CRO's also meet with the new security team to answer questions and create a working partnership.

## **Community Partnership**

## **Community Partnerships**

**Shop with a Cop Committee (3)** – A monthly meeting with countywide agency representatives for the planning of the 2017 Shop with a Cop event. STAR/PAL is responsible for working with school counselors and officers from throughout the county to identify the 300+ youth that participate in the program.

### **Community Involvement**

**We Can (5)** – A program where high school students are encouraged to be effective leaders within their schools and communities. Additionally, the program works to better relationships between the students and law enforcement. Topics covered include self-awareness, public speaking, consequences of substance abuse and dangers of social media.

**Mentoring Youth for Tomorrow (34)** – Mentoring Youth for Tomorrow (MYT) is a program that enables inner-city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with the youth. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

**Making Changes (15)** – The Making Changes program is a year-round, 40-session program, that brings youth, law enforcement, and volunteer mentors together for a civic engagement based curriculum. It is designed to educate high school teens about the importance of making positive life decisions and how these choices can impact their lives and their communities. This program hopes to promote awareness about the importance of one's actions and the potential these actions have to make positive change. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

**Teen LEAP (Leadership, Empowerment, Awareness Program) (16)** – Teen LEAP is led by STAR/PAL officers and staff and encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, the program strives to promote awareness about community issues. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood of San Diego.

**InterACTion (5)** – InterACTion is a 10-session program that brings law enforcement officers and teaching artists from the La Jolla Playhouse together inside the classroom to address pressing issues such as crime, gang violence, self-expression, and the dangers of drugs with high school teens in a unique and non-threatening way. Through a partnership with the San Diego Unified School District, the program is currently taught at Crawford High School in City Heights, and is designed to assist students in learning the necessary tools to make positive life choices, using theater as a medium to communicate about the struggles they face each day.

## **Community Outreach**

**Light the Night 5K** – STAR/PAL staffed an informational booth at the annual Light the Night Against Crime 5K event. Staff members interacted with the public and provided information about our programs.

**STAR/PAL Open House** – STAR/PAL hosted an open house at our U.S. Bank's Center to Serve Youth in Colina Del Sol Recreation Center. It was an opportunity to spotlight our programs to community members and service providers.

**Shop With A Cop Event** – STAR/PAL staff assisted the Oceanside and Carlsbad Police Departments with the annual event that benefits youth from underserved communities. Our officers coordinated the transportation for the children involved in the program.

## **Community Giveback**

**Southeastern Division Better a Block Event** – STAR/PAL officers assisted Southeastern Division with the event in the 5300 block of Redwood Street This is a family friendly community block party where neighbors can enjoy food, entertainment, community resources, kids zone, and visit with police representatives.

**North Park Observatory Holiday Event** – STAR/PAL staff assisted the North Park Observatory with a holiday feeding event.

**Crime Stoppers** – San Diego County Crime Stoppers Inc. provides three ways that the public can submit tips anonymously to report on felony crimes; they can call a tip line (888) 580–8477, submit a tip via the website or send a text tip from their phone. Crime Stoppers combats the three major problems law enforcement faces in gathering information; fear of reprisal, apathy, and a reluctance to get involved. San Diego County Crime Stoppers Inc. overcomes these challenges by providing citizens a safe way to anonymously report crime and rewards citizens for tips leading to a felony arrest.

## **Community Partnerships**

In October, Crime Stoppers partnered with Chick-Fil-A for a teddy bear drive to benefit children at Rady's Hospital.

**Crime Stoppers Information Meetings (3)** – An "as requested" meeting to define the role of Crime Stoppers in crime prevention strategies.

**Students Speaking Out Program** – A quarterly meeting for schools throughout the County on the benefits and uses of both the Crime Stoppers and Students Speaking Out Programs.

## **Community Involvement**

In October, Crime Stoppers had an information booth at the San Diego Firefighters 5K run and the Day of the Dead 5K run at Embarcadero Park.

In November, Crime Stoppers hosted its 31<sup>st</sup> Annual Light the Night 5K run/walk at Liberty Station.

## **Community Outreach**

**ACE Dinner** - Crime Stoppers attended the ACE dinner, which is a support organization for families who have lost friends/family members to violent acts.



**Speaker's Bureau (18)** – The Speaker's Bureau is a shining example of community outreach. The Speakers Bureau program has been in existence for approximately twenty years. Department employees are trained to make presentations to various community groups, private businesses, and academic organizations such as the Boy Scouts, Qualcomm, and San Diego State University.

Speakers provide the Department with positive visibility and citizens with important information, making them better informed and safer. Volunteer employees at each division are trained to present quality speeches on various crime prevention topics to community groups and organizations. By educating the community on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for its citizens. The topics include, but are not limited to: auto theft, burglary, domestic violence, firearm safety, graffiti vandalism, holiday safety tips, internal theft, identity theft, forgery, fraud, juveniles, landlord/tenant issues, narcotics, personal safety, Senior safety, sexual assault, shoplifting, stranger danger, traffic, transients and violence at work.

**Crime Free Multi-Housing Program** – In 2010, the San Diego Police Department entered into a collaborative partnership with the Institute for Public Strategies (IPS) and the managers/owners of San Diego multi-housing communities dedicated to crime prevention and the Crime Free Multi-Housing Program. In 2012, Say San Diego resumed the program from IPS and to date, **247** properties have been certified. The program illustrates the success of communities, nonprofit organizations, and law enforcement working to keep illegal activity out of the city's rental properties.

## **Community Involvement**

**Crime Free Multi-Housing Final Certification (9)** -Final Certification is when an apartment communities completes all 3 Phases: an 8 hour manager's class, passed the CPTED inspection, and participated in a resident engagement meeting receiving a Crime Free Multi-Housing certification certificate.

**Annual Recertification (3)** –Every year the properties get their recertification from their previous year certification if they choose to continue the program.

## **Community Outreach**

**Crime Prevention Through Environmental Design Inspections CPTED (5)** – Rental property inspections to assess physical security and general appearance of property to deter criminal activity.

Safety Meetings (20) - Meetings held with property owners, managers and residents to discuss the Crime Free Multi-Housing Program, CPTED, reporting guidelines, and general safety information.

Social Media - Social media is designed to enhance our communication outreach with the community. The San Diego Police Department currently uses three primary forms of social media that include Facebook, Twitter and Nextdoor.com. These platforms allow the Department to provide meaningful and timely information to our public on a variety of topics including community events, notification of crime issues, news stories and major incidents occurring in the City.

Members of the San Diego Police Department Speakers Bureau are trained to provide quality presentations on various crime prevention topics to community groups and organizations. By providing outreach education on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for our communities. Members spoke at 5 events during this quarter.

## **Community Involvement**

**Volunteer Services** – No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.

The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.

Currently, The San Diego Police Department has 99 active Crisis Interventionists, 304 RSVPs, 17 Reserve Officers, 70 VIPs, and 53 Cadets. Our Cadets contributed 410 hours this quarter. Our RSVPs contributed 23,012 hours this quarter. Crisis Interventionists responded to 170 callouts assisting 898 people, worked 3,914.5 hours, and were on call and prepared to respond for an additional 2,989.5 hours; our Reserve Officers worked a total of 1,712 hours and our VIPs contributed 3,628 hours.

**Ride Along Program (136)** – The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

## **Community Outreach**

**Community Recruiting Events (66)** – The Recruiting Unit gave presentations on career opportunities as a police officer and dispatcher at 50 community events throughout the City and County.

## **Community Partnerships**

**San Diego Juvenile Interagency Group (3)** – A monthly meeting aimed at dispersing up to date information related to juveniles and the law across San Diego law enforcement agencies.

**Alternatives to Detention** – ATD is for the placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officers' location to conduct an assessment of the juvenile for placement. With parental consent, the juvenile is placed in a home. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

**Joint Interagency Meeting (3)** – Monthly meetings presented by the Juvenile District Attorney's office. Multiple county law enforcement agencies attend this meeting in order to receive updates on laws regarding juveniles and training on various programs.

**Juvenile Justice Coordinating Council** – In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The JJCC is chaired by the county's chief probation officer and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.

**Central Region Safety Environment Workgroup/Live Well San Diego** – This work group concentrates on improving the health of residents, ensuring residents are protected from crime and abuse, neighborhoods are safe, communities are resilient to disasters and emergencies and cultivating opportunities for all people to grow, connect and enjoy the highest quality of life. Juvenile Administration attends monthly meetings to advise board and community members on safe practices, crime prevention, and disaster preparation.



**Juvenile Diversion** – The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

### **Community Involvement**

**Shop with a Cop (2)** – The Carlsbad and Oceanside Police Departments are the host agencies for this year's annual charity event. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings with other county law enforcement agencies in preparation for this event. The annual Shop with a Cop event will took place on December 2, 2017.

**Teddy Bear Drive** – The Teddy Bear Drive is an annual countywide law enforcement event designed to bring stuffed animals to children admitted at Rady Children's Hospital. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings and fund raising events throughout year. This year's event took place on December 5, 2017.

**School Safety Patrol** – Juvenile Administration coordinates the School Safety Patrol for the City of San Diego. Seventy–nine elementary schools with approximately 1,800 SSP members participate in this program. We hosted the annual Holiday Party and Awards ceremony on December 9, 2017.
