- III. **Community Outreach** – The ways we provide awareness, education, and information to the community about public safety, crime trends, and crime prevention.
- IV. **Community Givebacks** – The volunteering and charity efforts we participate in inside and outside our normal work hours.

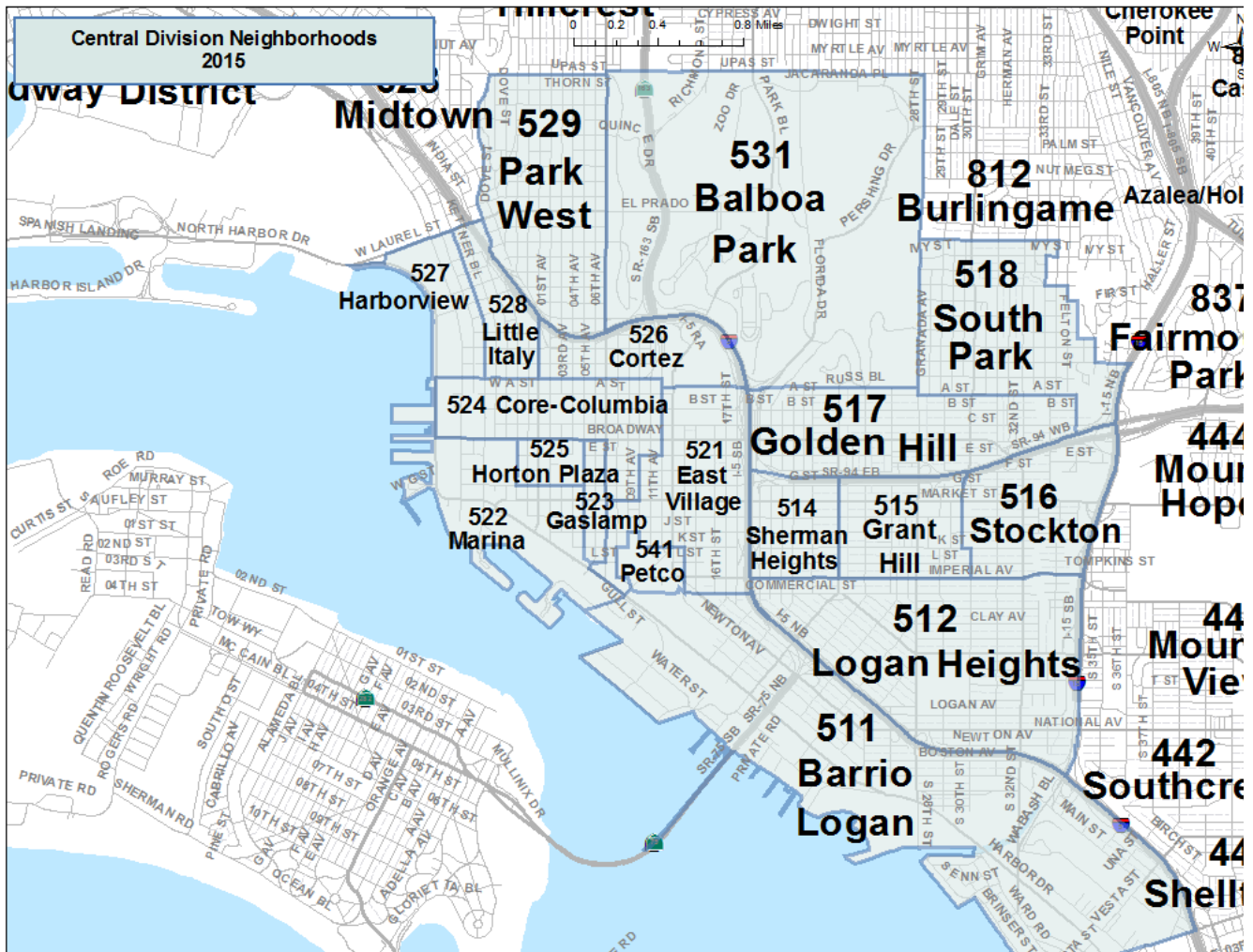

**East Village Association (4)** –Meets monthly to discuss criminal activity that is occurring around local businesses.

**East Village Residents Group (2)** –Meets every other month to discuss criminal activity that is occurring around residential buildings in the East Village area.





**Gaslamp Quarter Association (4)** –Meets monthly to discuss criminal activity that is occurring around local businesses.

**Gaslamp Quarter Association Special Events (4)** –Meets monthly to discuss how events impact the Gaslamp area.

**Little Italy Association (4)** –Meets monthly to discuss business owners and residents to discuss public safety concerns and current criminal activity that is occurring.

**Community Graffiti Cleanup** –Coordinated and assisted community members in Barrio Logan with painting over graffiti in the community.

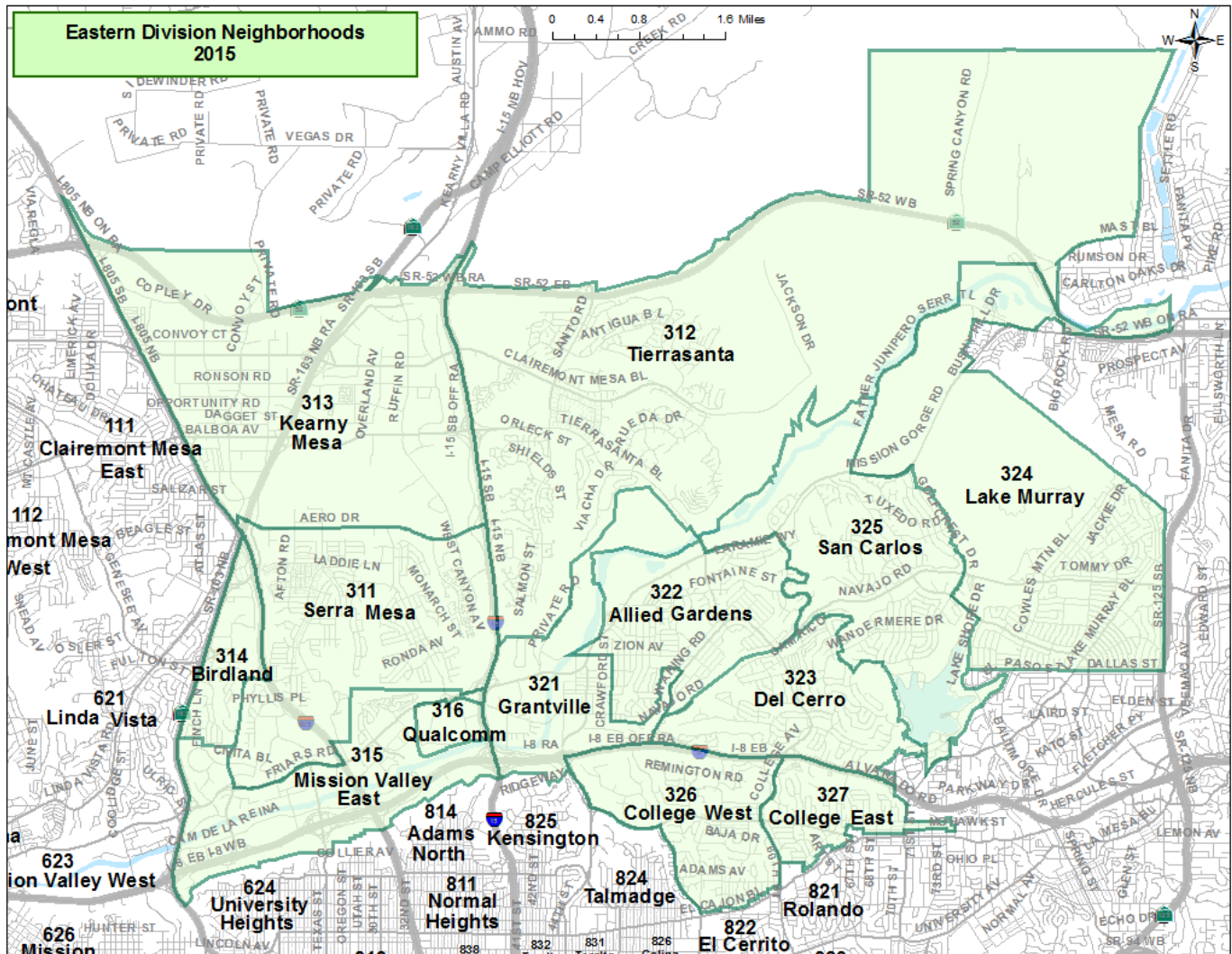

**Allied Gardens Book Club** –Spoke with group regarding crime prevention.

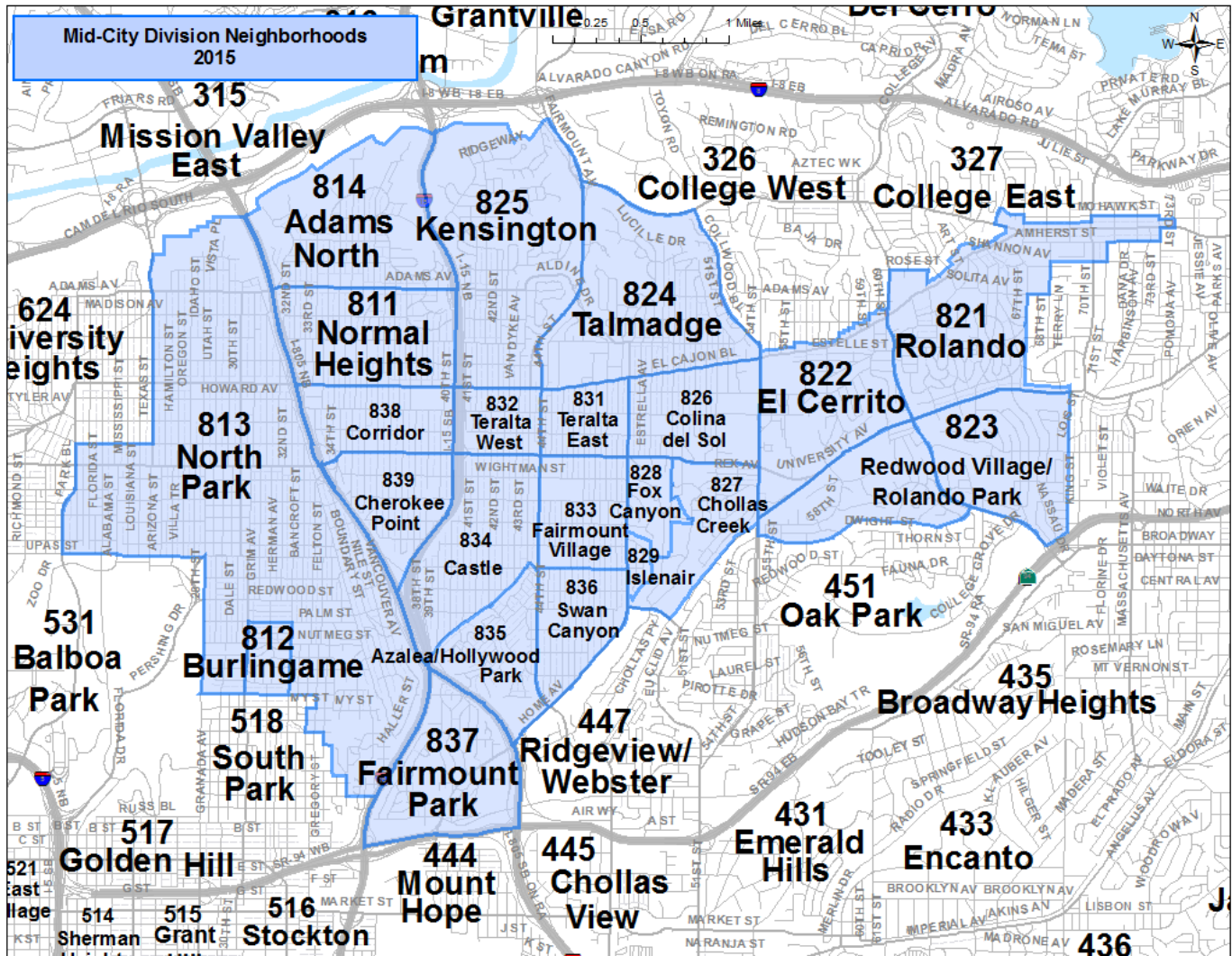

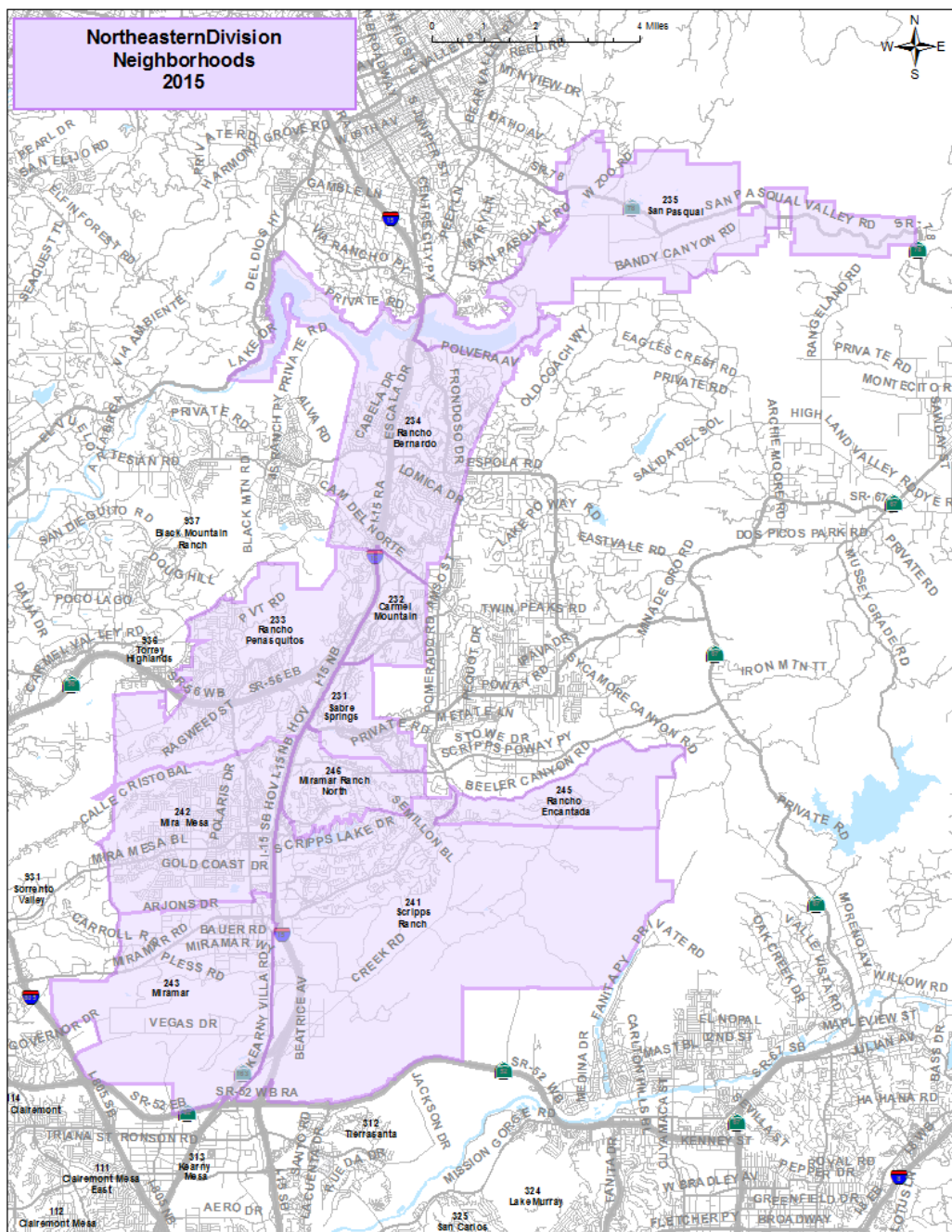

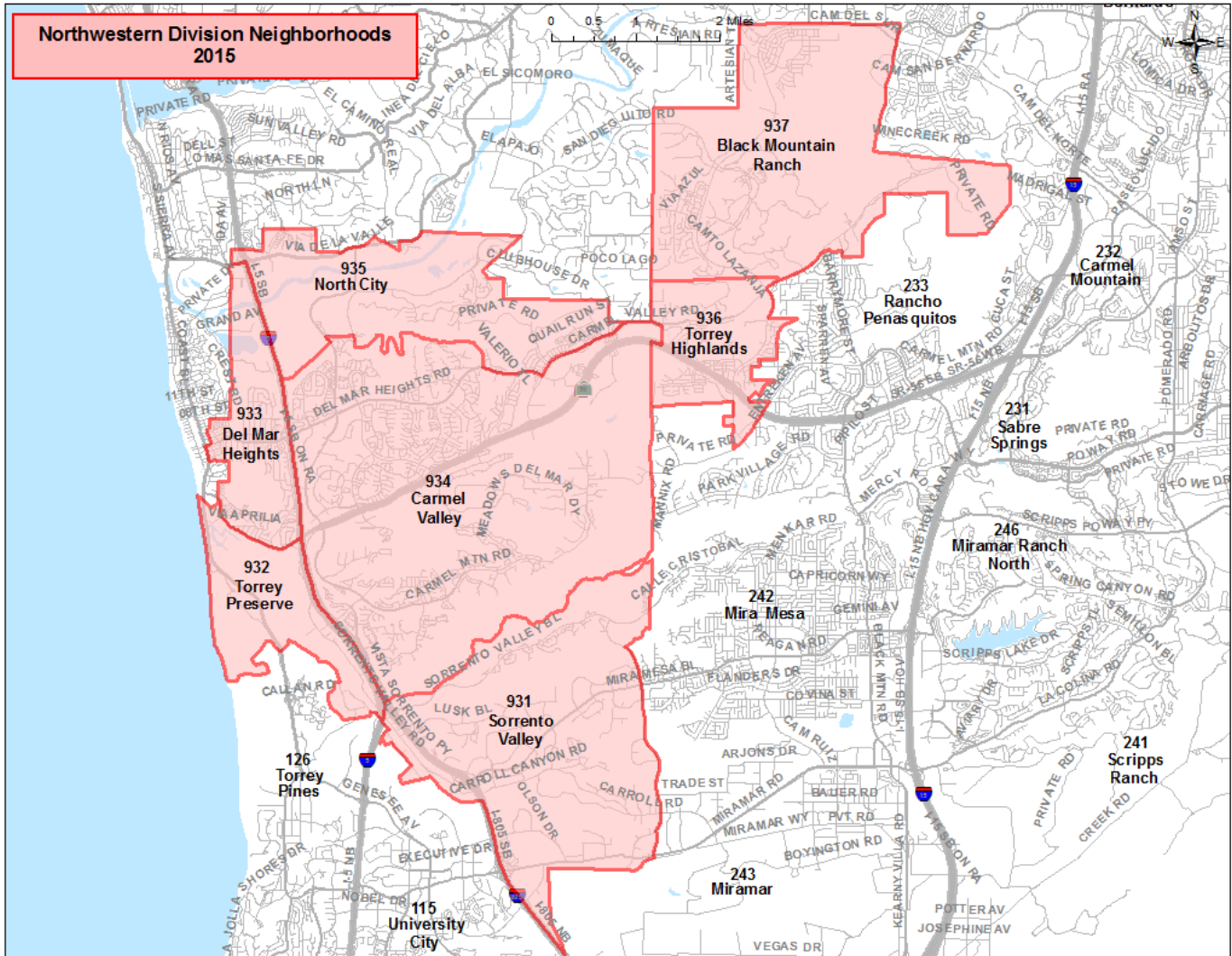

## Community Partnerships

**Captain's Advisory Board Meetings** –Northwestern officers and command staff host a meeting held every month as a collaboration with the community to address community policing, public safety and quality of life issues.

**Neighborhood Watch Meeting** –Meetings held in a residence and community rooms to discuss setting up a Neighborhood Watch groups and quality of life issues. Many neighborhood watch groups utilize Nextdoor.com as a conduit of communication to address crime awareness and prevention. Several neighborhoods in Northwestern Division are in the planning stages of starting new Neighborhood Watch groups.

**Miscellaneous Meetings (7)** –“As requested” meetings with community members, groups and organizations.

- Northwestern Command Staff and CRO met with Qualcomm Security Directors to discuss and plan for any future law enforcement interaction on the Qualcomm Campus. Qualcomm had a major layoff scheduled and wanted to discuss SDPD support during the difficult times for several Qualcomm employees. Qualcomm populates the majority of Sorrento Valley with 39 buildings and thousands of employees. Like any other major corporation, Qualcomm manages a series of public safety and personal issues on a regular basis. The continuing partnership between Northwestern Division and Qualcomm security team these issues are handled in a professional and expedited manner.
- Northwestern CRO attends four monthly community planning board meetings to keep a constant open line of communication open between active community members and the police department. During these meeting, members are able to address issues related with their specific communities.
- Northwestern investigators attended the Impact Meeting at the Sheriff's North County Coastal Station and Poway Station to discuss regional issues such as car prowls, burglaries, or other series-related events.
- Northwestern officers attended a citizens' meeting and discussed crime prevention and home protection. Information was given out to several residences in the Northwestern Division to better help citizens protect their homes from burglary.



- CRO Philips regularly speaks with City Council representatives who represent communities within Northwestern's jurisdiction. CRO Philips is able to address concerns and problems with a public safety nexus voiced directly to the City Councils office. Working together with the same message, issues in each community can be quickly resolved and that resolution can be directly contacted back to the community.
- CRO Philips attended the O'Gara Coach Car show in Sorrento Valley. The car event has a long standing history in the dealership and has historically been shut down due to unsafe driving in the area. Under new management O'Gara revamped the event and has been working closely with SDPD to make the event a success. With the support of SDPD Traffic Division and Northwestern there has been no problems surrounding the event. CRO Philips worked a recruiting booth and had great response for the crowd.
- CRO Philips helped coordinate and manage the Scripps La Jolla Hospital Trauma Awareness event. The event was hosted by Scripps and had dozens of booths with a variety of sponsors and attendees. The event was successful and well received, Scripps has expectations to grow the event in the future.

### Community Involvement

Northwestern Command staff and officers attended the Santa Luz Summer Celebration. The community hosts the event with an attendance of approximately 6,000 people. San Diego Police K-9 unit and SWAT officers were in attendance in addition to a SDPD Northwestern booth. ABLE conducted a flyover for the crowd during the event. The event is well attended and a highlight of the community. Several community bonds have been created during this event in the past with law enforcement and will continue as the event grows. The community has raised funds in the past to help purchase two San Diego Police dogs and they are committed to continuing to assist in the future.

Northwestern Division participated in a county wide prescription take back event with the DEA. Several boxes of unused prescription medications were surrendered to be safely disposed.

Northwestern CRO and JST Officers worked in partnership with several high schools in the division to provide a safe and secure environment for several events leading up to graduation. Two officers were staffed at several high schools during their graduation ceremonies and they were all concluded without incident.



Northwestern CRO assisted Qualcomm security team with a voluntary seminar for employees on the topic of workplace violence and suicide prevention. The seminar was appreciated by all those who attended and there is continued interest for future events.

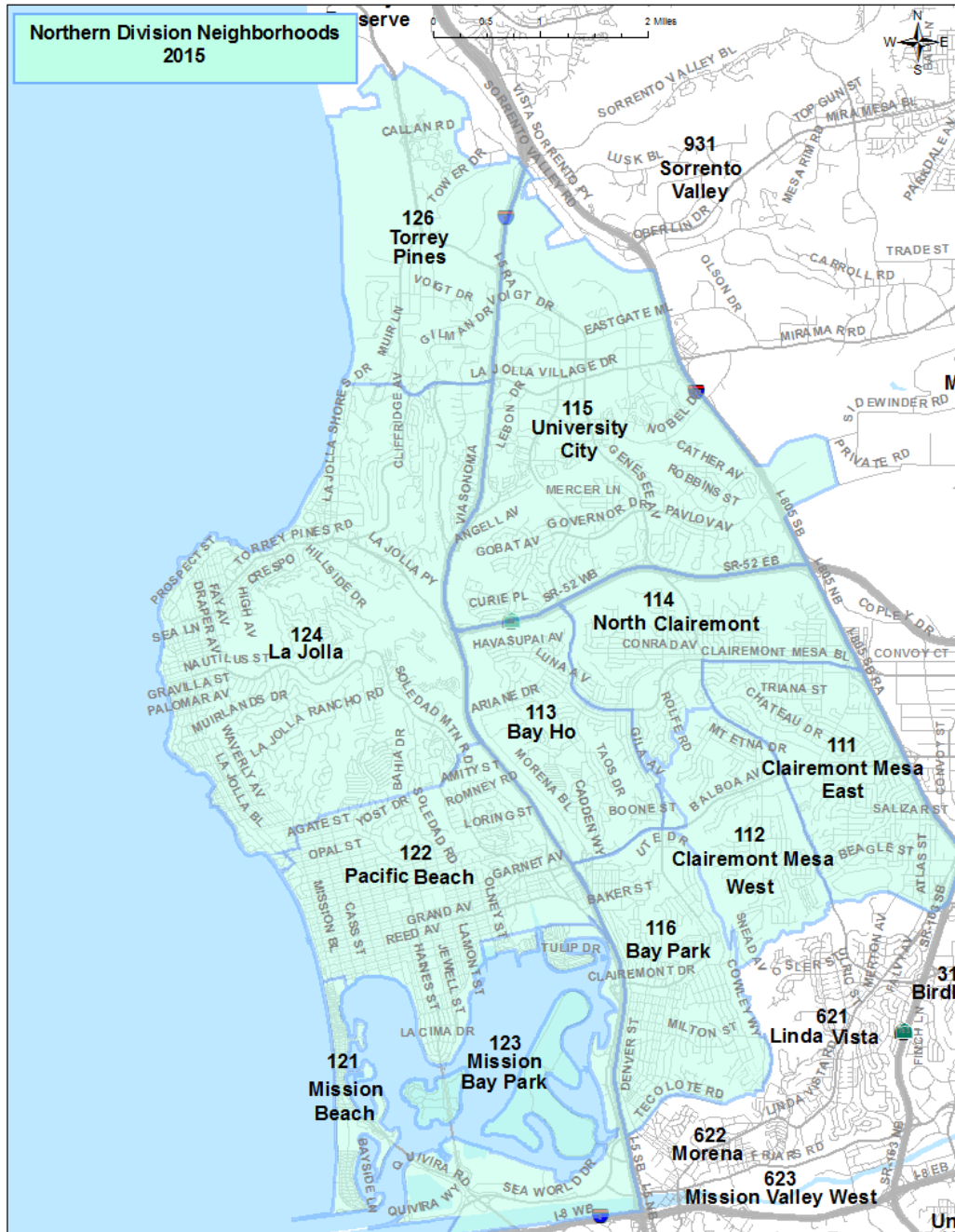

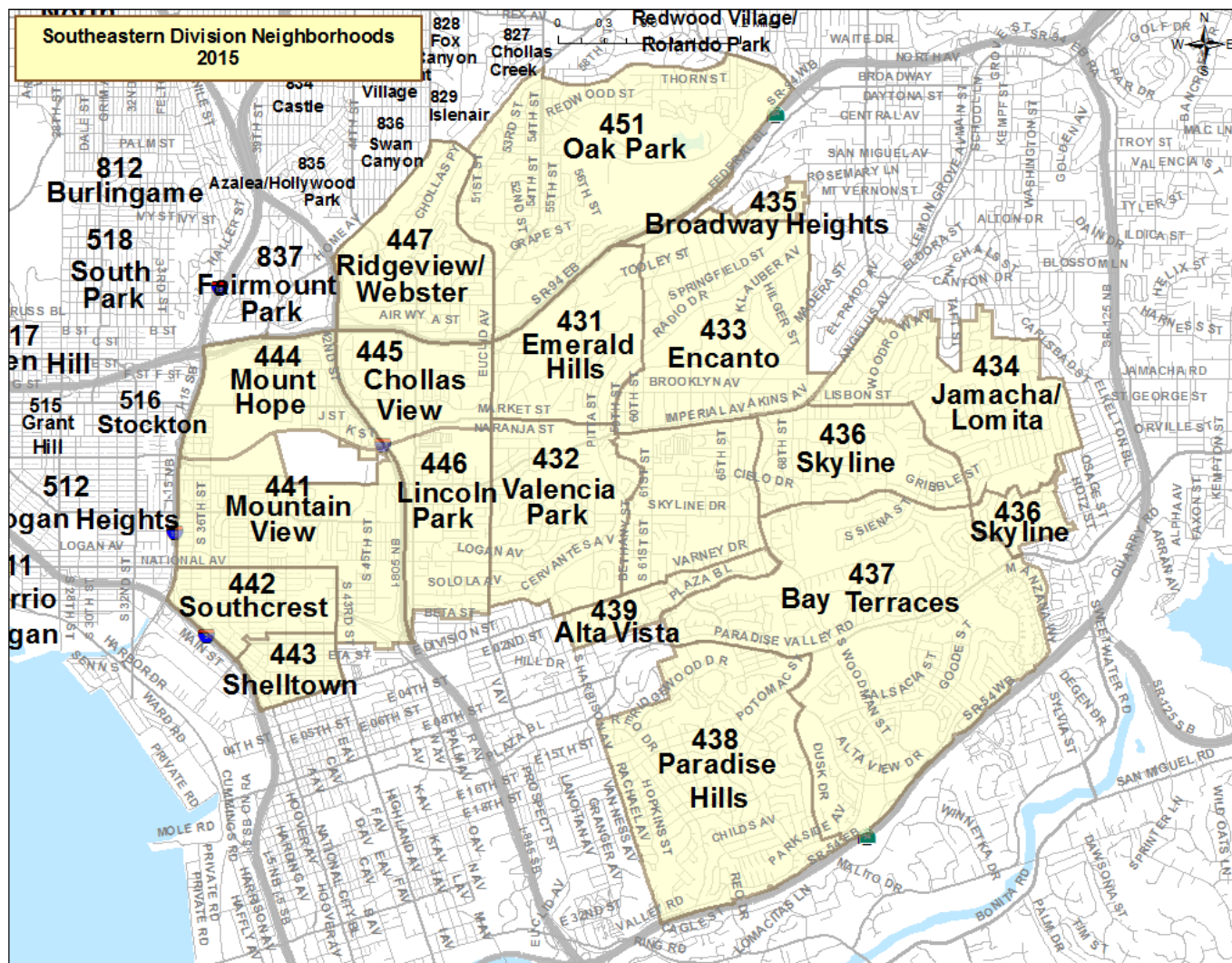
**Coffee With A Cop** -Brings the community and police together to discuss current issues and learn more about each other.

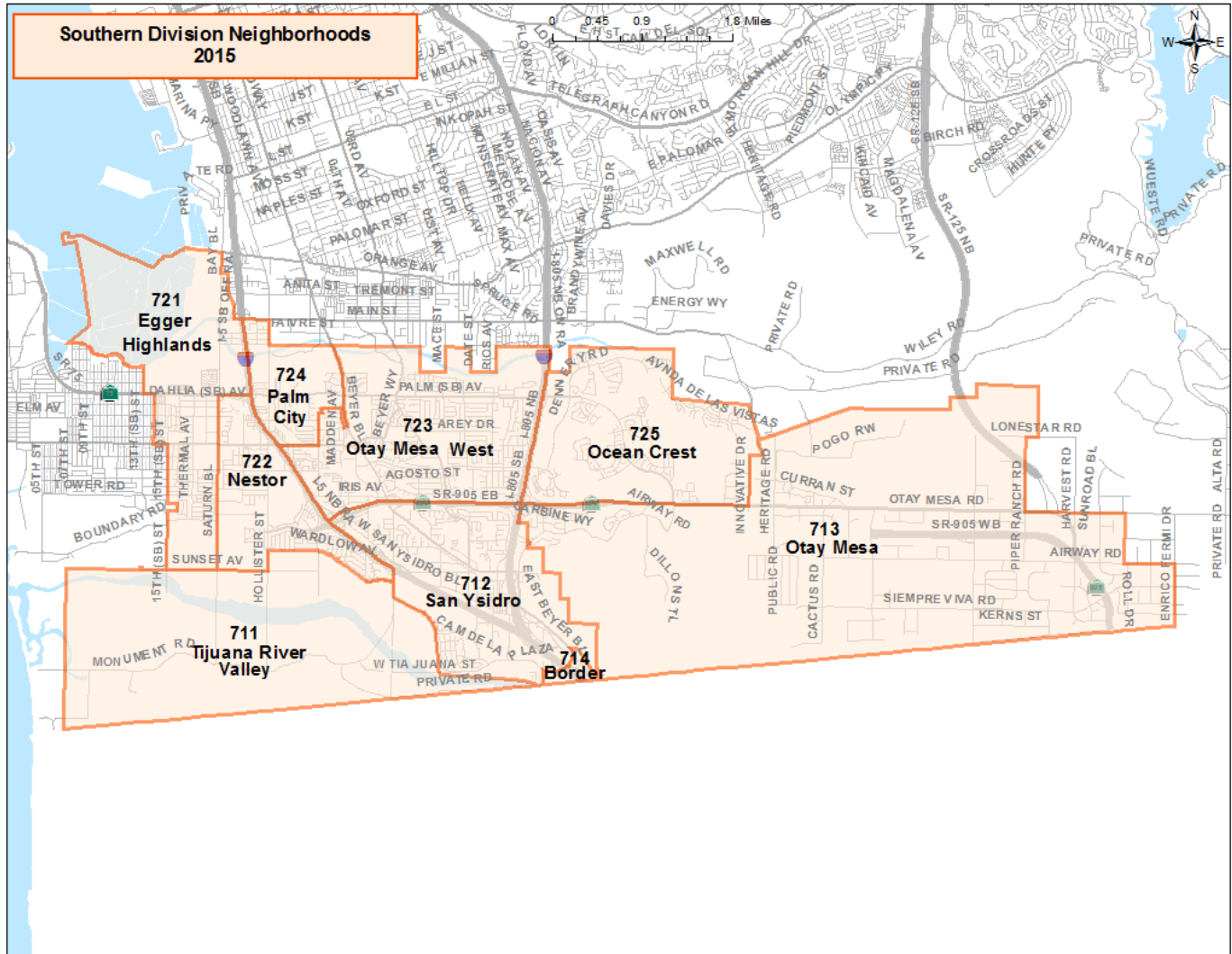

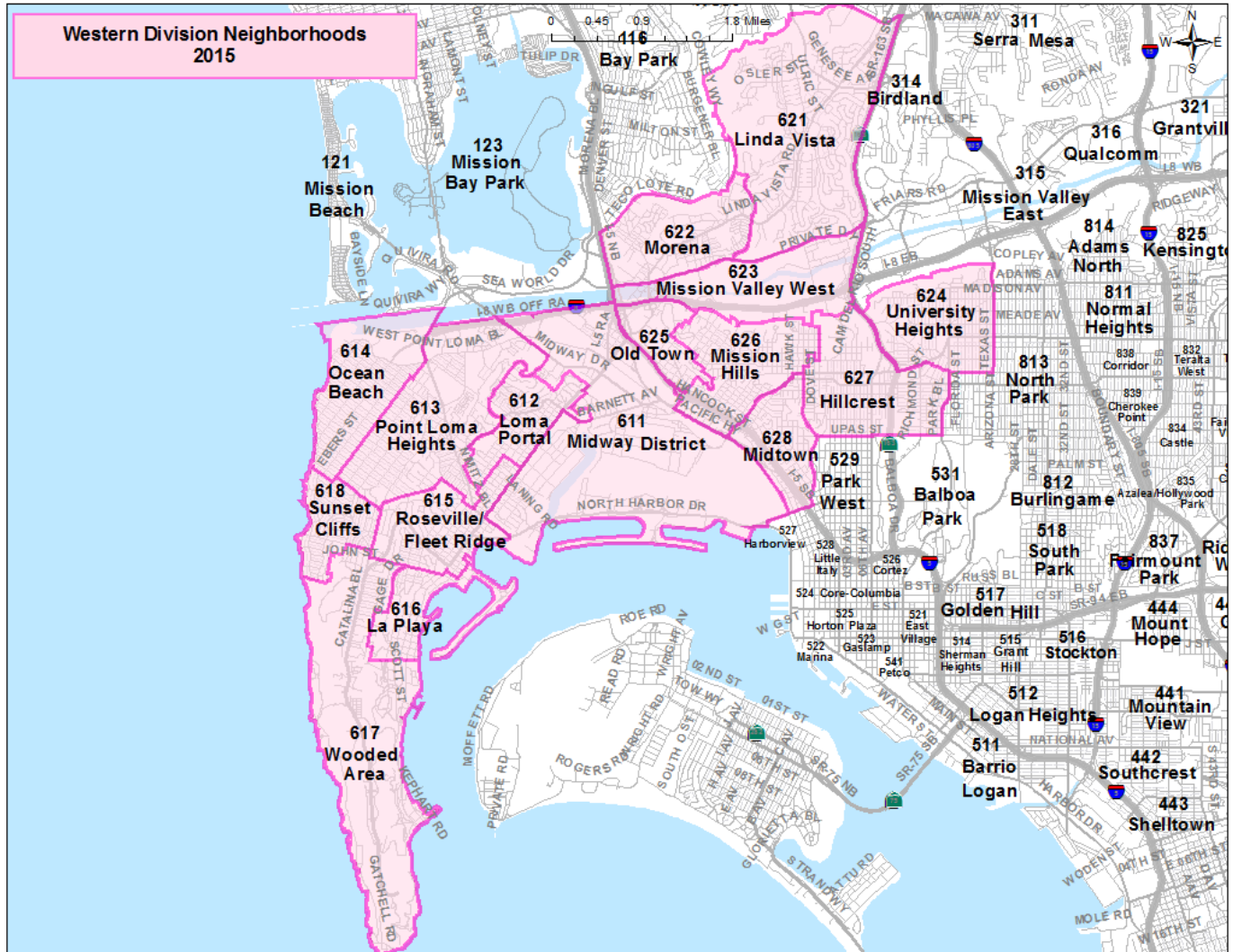

At Western Division we collected one of the highest amounts of prescription drugs in San Diego County.

**Hillcrest Security Follow Up Meeting** –The CROs met with Hillcrest business managers, business owners and the staff of the Hillcrest Business association to discuss trespassing homeless individuals in the local area. CPTED strategies were discussed and proper notifications were made.

**Neighborhood Parking Concerns (5)** –Western Division CROs assisted several citizens throughout Western Division with 72 hour parked vehicle violations. The vehicles were properly marked and towed at the citizen's request.

**Linda Vista Multi Cultural Parade & Fair** –The Linda Vista Parade and Fair is held annually on the 6900 block of Linda Vista Rd. The event promotes cultural awareness and understanding within the City of San Diego. Western Division Command Staff and CRO's participated in the parade and greeted hundreds of community members along the one mile parade route. The event attracted thousands of community members. There were numerous cultural exhibits, varied ethnic foods and artistic performances.

**Personal Safety discussion for State Council on Developmental Disabilities** –CRO's were invited to speak to teens and young adult disabled members of the community about personal safety and interacting with Police Officers.

**Shirley Ann Place Resident Follow Up** –A resident of Shirley Ann Place reached out to Western Division CRO's requesting assistance and follow up to address vehicles being parked long term on the street.

**Lower Sunset Cliffs Neighborhood Watch Meeting** –CRO's spoke at the Lower Sunset Cliffs Neighborhood Watch Meeting to discuss crime prevention tips and answer questions. Most questions were regarding recent high profile crimes which had recent occurred within the neighborhood, high volume of vehicle traffic to watch the sunsets and late night parties in the Sunset Cliffs Natural Park.



**St Vincent's Talent Show** –Outreach and support of the students at St Vincent's was shown by the division's JST officers who were invited to attend the schools talent show.

**Captain's Community Outreach Walk** -Western Captain Tai and CRO's went on a walking tour in the business district of Hillcrest. An issue consistently brought up was the problems caused by aggressive panhandling and drug use by the local homeless. The command will develop ways to further address the issue.

**End of Year Awards Ceremony at Grant Elementary School** –JST Officer Amber Banning and retired JST Officer Tim Zetterlund awarded a letters of thanks and appreciation to the students who participated in the schools Safety Patrol Program (SSP). Students each morning and afternoon staffed the crosswalk intersection and controlled traffic to allow children and parents to cross the busy intersection safely. The students conducted their duties resulting in no traffic accidents involving pedestrians or vehicles while performing their duties.

Staff requested CROs attend one of our meetings to speak on how to deal with the homeless and measures for us on how to be safe.

**Pennsylvania Ave Neighborhood Crime Meeting** –CRO's spoke numerous Pennsylvania Ave residents to discuss crime prevention tips and answer questions. Most questions were regarding narcotic dealing and the homeless population's criminal behavior within the community.

**Hillcrest Business Improvement District Meeting** –CRO's checked in with the Hillcrest BID Executive Director regarding the crime related issues and the partnership between the BID and the Police Department.

**UCSD Hospital Protests (4)** –Due to planned staff and security protests at UCSD Hospital the CRO's and patrol staff conducted extra patrol to ensure a safe and peaceful protest.

**The Center Meeting (2)** –CRO's met with the LGBT Latino Center Staff and community members to answer questions and assist with reports.

**3 year Anniversary Phase III Resident Engagement Meeting** –San Diego SAY attended the Crime Free Multi Housing anniversary meeting with residents and manager on Maryland Street.

**Ocean Beach Main Street Association (3)** –The CROs conducted regular follow up discussion with staff at OBMA to discuss status of neighborhood nuisance issues related to transients, parking and other community issues.

**Mission Hills BID Meeting** –CROs met with the Executive Director of the Mission Hills BID to discuss a future fund raising event to assist Western Division purchase equipment for the division.

**Captain's Community Outreach Walk** –Captain Tai and Western Division CRO's went on a walking tour in the business district of Old Town. The contacts were entirely positive with business and community members. Conversation centered on the homeless loitering in the area and late evening crime.

**Hillcrest Security Follow Up Meeting** –The CROs met with Hillcrest Business Association director and the staff to discuss homeless individuals loitering and panhandling in the local area.

**Linda Vista Bayside Community Center Meeting (3)** –The CROs conducted regular follow up discussion with staff of the Bayside Community Center to discuss concerns from the citizens of the Linda Vista Community.

**Neighborhood Parking Concerns (6)** –Western Division CROs assisted several citizens throughout Western Division with 72 hour parked vehicle violations. The vehicles were properly marked and towed at the citizen's request.

**Citizen Request for Assistance** –CROs followed up for a resident concerning Robb Field in Ocean Beach regarding homeless camping in RV's, using narcotic in public, dumping trash and disturbances in the dirt parking lot.

**Citizen Request for Assistance** –Continued follow up by Western Division CRO's to the open space along Golden Gate Street concerning homeless encampments. Citizens have expressed concerned the occupants might create a fire hazard due to the use of an open flame to cook and trash being thrown around the camp site. Western Division CRO's continue to provide extra patrol at the location.

**Citizen Request for Assistance** –Due to complaints from businesses CROs followed up along Sports Arena Blvd regarding trailers parked along the curb for extended periods of time. The CROs made contact with the occupants and educated them regarding vehicle habitation and Neighborhood Parking Protection Ordinance which addresses overnight campers on city streets. The occupants departed the streets for local RV camp grounds.

**Hillcrest Pre-School Extra Patrol (4)** –CROs continued extra patrol for a Pre-School suffering homeless trespassing and loitering. As part of the project CROs met with local residents offering strategies to alleviate trespassing and vandalism associated with the homeless population.

**Nipoma Place Neighborhood Watch Meeting** –The Western Division CRO's spoke at the Nipoma Place Neighborhood Watch Meeting. The CRO's discussed the importance of Neighborhood Watch, how it works and discussed crime prevention tips. The CRO's also answered question regarding homeless criminal behavior in the local area and the activities over look on Nipoma Place.





**The Center (LGBTQ Community) (2)** –CROs met with counselors of The Center to discuss community concerns and foster communication between the Center and the police.

**Ocean Beach Main Street (OBMA) 4<sup>th</sup> of July Pre Planning Meeting (2)** –CRO's met with OBMA staff to discuss set up and staffing of the Western Division 4<sup>th</sup> of July command post. The meeting discussed logistical set up, partnership and staffing.

## **Community Partnerships**

**Shop with a Cop Committee (3)** – A monthly meeting with countywide agency representatives for the planning of the 2018 Shop with a Cop event. STAR/PAL is responsible for working with school counselors and officers from throughout the county to identify the 300+ youth that participate in the program.

## **Community Involvement**

**InterACTION (10)** – InterACTION is a 10-session program that brings law enforcement officers and teaching artists from the La Jolla Playhouse together inside the classroom to address pressing issues such as crime, gang violence, self-expression, and the dangers of drugs with high school teens in a unique and non-threatening way. Through a partnership with the San Diego Unified School District, the program is currently taught at Crawford High School in City Heights, and is designed to assist students in learning the necessary tools to make positive life choices, using theater as a medium to communicate about the struggles they face each day.

**Life Skills (16)** – Life skills is an 8-session program designed to help youth transition to adulthood by providing tools to enter the work force, manage their money and finances, implement a healthy lifestyle and introduce basic CPR information. The youth create a life plan designed to map their goals and paths to achieve them. They are also introduced to the role of a police officer and have an opportunity to ask officers questions.

**Mentoring Youth for Tomorrow (42)** – Mentoring Youth for Tomorrow (MYT) is a program that enables inner-city youth the opportunity to take part in a mentoring program with volunteers, law enforcement officers, and students from SDSU and UCSD. It includes homework assistance, athletic activities, educational field trips, and recreational opportunities, all with positive mentorship that includes law enforcement officers working directly with the youth. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

**Making Changes (17)** – The Making Changes program is a year-round program, that brings youth, law enforcement, and volunteer mentors together for a civic engagement based curriculum. It is designed to educate high school teens about the importance of making positive life decisions and how these choices can impact their lives and their communities. This program hopes to promote awareness about the importance of one's actions and the potential these actions have to make positive change. This program is held on-site at the STAR/PAL Center to serve youth in Mid-City Division.

**Teen LEAP (Leadership, Empowerment, Awareness Program) (12)** – Teen LEAP is led by STAR/PAL officers and staff and encourages youth participants to develop as effective leaders within their schools and communities. By engaging teens in new experiences including volunteering at retirement homes, community revitalization projects, and various outdoor excursions, the program strives to promote awareness about community issues. This program is currently taught on campus at Gompers Preparatory Academy in Southeastern Division and Crawford High School located in the Colina Del Sol neighborhood of San Diego.

**We Can (8)** – A program where high school students are encouraged to be effective leaders within their schools and communities. Additionally, the program works to better relationships between the students and law enforcement. Topics covered include self-awareness, public speaking, consequences of substance abuse and dangers of social media.

**Chargers Camp (3)** – STAR/PAL and the Los Angeles Chargers collaborated to host these camps. The camps are part of the NFL Play 60 program, which is a national youth health and fitness campaign, focused on increasing the wellness of young fans by encouraging them to be active for at least 60 minutes a day. Each camp has 100 youth participants.

**Padres Clinic (4)** – STAR/PAL and San Diego Padres host 2-day baseball clinics. These camps are designed to promote an active lifestyle and positive interaction with local law enforcement in a team sport environment. On day one, youth participants participate in baseball drills. Volunteers from throughout the county volunteer to provide instructions on baseball skills with a specific emphasis on beginner to intermediate levels. 60 youth participants are at each clinic. On day two, they attend a San Diego Padres baseball game at Petco Park.





## **Community Outreach**

**Student Attendance Review Board (SARB)** – STAR/PAL officers participated in reviewing absences with school administrators from Gompers Preparatory Academy and devise a plan to improve grades and attendance on April 13, May 11 and June 8.

**Colina Park Clean-up** – STAR/PAL recruited volunteers, organized resources, and hosted a clean-up in the park. Volunteers included STAR/PAL youth participants, collaborative partners from other PAL (Police Activities League) organizations, military members and citizens from the community.

**Somali Bantu Association of America** – STAR/PAL presented information on STAR/PAL and answered law enforcement questions to teenagers participating in a course through the Somali Bantu Association of America. Weeks after the presentation, adult members of the organization came to STAR/PAL to tour the facility and seek more information on STAR/PAL. The tour of STAR/PAL occurred on May 8, 2018.

**Crawford High Scholl Senior Projects (2)** – STAR/PAL was invited to participate in Crawford's senior projects participations as a judge. Seniors presented an overview of their years spent at the high school and were graded on a number of factors including presentation of the project as well as content. The judges were comprised of an officer, community member, teacher and a school alumni. This event occurred on May 23, 2018.

**Central Division Block Party** – STAR/PAL hosted a booth at Central Division's community outreach event hosted on June 2, 2018.

**Horse in the Sun Banquet (2)** – STAR/PAL was an honoree at the Horse in the Sun banquet held on June 2, 2018, for their work at an annual horse camp held in Pine Valley, Ca.

**Crime Stoppers** - San Diego County Crime Stoppers Inc. provides three ways that the public can submit tips anonymously to report on felony crimes; they can call a tip line (888) 580-8477, submit a tip via the website or send a text tip from their phone. Crime Stoppers combats the three major problems law enforcement faces in gathering information; fear of reprisal, apathy, and a reluctance to get involved. San Diego County Crime Stoppers Inc. overcomes these challenges by providing citizens a safe way to anonymously report crime and rewards citizens for tips leading to a felony arrest.

## **Community Partnerships**

**Crime Stoppers Information Meetings (3)** -An “as requested” meeting to define the role of Crime Stoppers in crime prevention strategies.

**Students Speaking Out Program** -A quarterly meeting for schools throughout the County on the benefits and uses of both the Crime Stoppers and Students Speaking Out Programs.

**Students Speaking Out Program** -In addition to quarterly meetings, we also presented at informational meetings to various other schools including Sweetwater Unified, Coronado Unified, Poway Unified, Grossmont Unified, and the Learning Choice Academy Charter Schools.

## **Community Outreach**

**Crime Stoppers Enough is Enough Luncheon**- In April, Crime Stoppers hosted its annual luncheon, which honors local law enforcement personnel throughout the county and also raises money to fund the Felony Reward and Students Speaking Out programs.

**San Diego District Attorney’s School Safety Summit**- In April, Crime Stoppers presented the Students Speaking Out program to several hundred school district and law enforcement representatives from throughout the county.



**Wednesday Club**– In May, Crime Stoppers presented information about its program and the Students Speaking Out program to members of the Wednesday Club of Rancho Bernardo. This presentation was to educate the members on the uses of each program and to show how they keep their community safer.

**Speaker's Bureau (5)** –The Speaker's Bureau is a shining example of community outreach. The Speakers Bureau program has been in existence for approximately twenty years. Department employees are trained to make presentations to various community groups, private businesses, and academic organizations such as the Boy Scouts, Qualcomm, and San Diego State University. Speakers provide the Department with positive visibility and citizens with important information, making them better informed and safer. Volunteer employees at each division are trained to present quality speeches on various crime prevention topics to community groups and organizations. By educating the community on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for its citizens. The topics include, but are not limited to: auto theft, burglary, domestic violence, firearm safety, graffiti vandalism, holiday safety tips, internal theft, identity theft, forgery, fraud, juveniles, landlord/tenant issues, narcotics, personal safety, Police communications, SDPD history, robbery, school safety, senior safety, sexual assault, shoplifting, stranger danger, traffic, transients and violence at work.

**Crime Free Multi-Housing Program** –In 2010, the San Diego Police Department entered into a collaborative partnership with the Institute for Public Strategies (IPS) and the managers/owners of San Diego multi-housing communities dedicated to crime prevention and the Crime Free Multi-Housing Program. In 2012, Say San Diego resumed the program from IPS and to date, **247** properties have been certified. The program illustrates the success of communities, non-profit organizations, and law enforcement working to keep illegal activity out of the city's rental properties.

### Community Involvement

**Crime Free Multi-Housing Final Certification (9)** –Final Certification is when an apartment communities completes all 3 Phases: an 8 hour manager's class, passed the CPTED inspection, and participated in a resident engagement meeting receiving a Crime Free Multi-Housing certification certificate.

**Annual Recertification (6)** –Every year the properties get their recertification from their previous year certification if they choose to continue the program.

## **Community Outreach**

**Crime Prevention Through Environmental Design Inspections CPTED (12)** – Rental property inspections to assess physical security and general appearance of property to deter criminal activity.

**Safety Meetings (18)** – Meetings held with property owners, managers and residents to discuss the Crime Free Multi-Housing Program, CPTED, reporting guidelines, and general safety information.

**Social Media** – Social media is designed to enhance our communication outreach with the community. The San Diego Police Department currently uses three primary forms of social media that include Facebook, Twitter and Nextdoor.com. These platforms allow the Department to provide meaningful and timely information to our public on a variety of topics including community events, notification of crime issues, news stories and major incidents occurring in the City.

Members of the San Diego Police Department Speakers Bureau are trained to provide quality presentations on various crime prevention topics to community groups and organizations. By providing outreach education on crime prevention techniques we can reduce the number of crimes in San Diego and increase the quality of life for our communities. Members spoke at 5 events during this quarter.

## Community Involvement

**Volunteer Services** -No police department is large enough to keep a community safe on its own. Effective crime prevention requires the active support of citizens and a partnership between police and the community. Community policing is an important foundation of the San Diego Police Department. What makes San Diego's approach to community policing unique is the extent to which the police department has made volunteers an integral component of its program.

The San Diego Police Department is viewed as a leading force in law enforcement innovations occurring across North America. The Department's adult and youth volunteer workforce has approximately 700 members. These volunteers play a vital role in the department's vision to engage the community in a problem solving partnership that will reduce crime and positively affect the quality of life in all communities.

The San Diego Police Department has used volunteers for a wide variety of job assignments for many years. Programs throughout the Department are considered models in volunteerism in the public sector. Volunteers are essential to Department operations. They help provide a level of customer service that could not be achieved by the Department's staff alone. Volunteers represent all segments of society. The variety of functions performed by this police department affords opportunities for people with varied interests and skills. The San Diego Police Department's Volunteers in Policing (VIP) program offers a unique opportunity for citizen volunteers to become actively involved in providing efficient, effective, and responsive service to our community.

The use of volunteers includes Crisis Interventionists, Retired Senior Volunteer Patrols, Volunteers in Policing, Reserve Officers, Police Cadets, and various support staff positions that enhance the organization's effectiveness. This is a result of two decades of change in policing philosophy that has heralded San Diego as a pioneer in many areas of law enforcement.





The San Diego Police Department has a significant resource available in the San Diego community: individuals who are ready, willing, and able to serve as volunteers. In a time of limited financial resources and increasing demands for services, it is important that volunteer opportunities continue to be identified and this resource increasingly utilized.

Currently, The San Diego Police Department has 79 active Crisis Interventionists, 251 RSVPs, 14 Reserve Officers, 61 VIPs, and 42 Cadets. Our Cadets contributed 827 hours this quarter. Our RSVPs contributed 24,214 hours this quarter. Crisis Interventionists responded to 172 callouts assisting 814 people, worked 3,208 hours, and were on call and prepared to respond for an additional 3,193 hours; our Reserve Officers worked a total of 1,387 hours and our VIPs contributed 3,506 hours.

**Ride Along Program** -The Ride Along Program is a powerful community involvement tool that enables an officer to showcase to citizens who live, work, or go to school in the officer's area of responsibility the daily duties of a police officer. It enables citizens to get a first-hand look at policing and to better understand the role of the police. It increases the opportunity for more effective problem solving, and it enhances mutual understanding and cooperation and leads to an improved police/community relationship.

### Community Outreach

**Community Recruiting Events (92)** -The Recruiting Unit gave presentations on career opportunities as a police officer and dispatcher at 50 community events throughout the City and County.

**Community Partnerships**

**San Diego Juvenile Interagency Group (3)** –A monthly meeting aimed at dispersing up to date information related to juveniles and the law across San Diego law enforcement agencies.

**Alternatives to Detention (1)** –ATD is for the placement of juvenile misdemeanor offenders into an alternative location other than Juvenile Hall (i.e. cool bed). Representatives are available to respond to the officers' location to conduct an assessment of the juvenile for placement. With parental consent, the juvenile is placed in a home. Juvenile Administration and JST Officers attend these meetings to discuss juvenile issues, placements and laws.

**Juvenile Justice Coordinating Council** –In an effort to ensure coordination and collaboration among the various local agencies serving at-risk youth and young offenders, the JJCPA legislation requires the county Juvenile Justice Coordinating Council (JJCC) to develop and modify the plan. The JJCC is chaired by the county's chief probation officer and its members include representatives of law enforcement and criminal justice agencies, the board of supervisors, social services, education, mental health, and community-based organizations. The JJCC meets periodically to review program progress and evaluation data.

**Juvenile Diversion** –The Juvenile Administration unit works in an ongoing effort with multiple Community Based Organizations. It is designed to bring the latest and most updated Diversion programs to the San Diego Police Department. Diversion is set up for low level offenders to be an alternative to the juvenile justice system.

**Community Involvement**

**Shop with a Cop (3)** –The California Highway Patrol and Chula Vista Police Department are the host agencies for this year's annual charity event. SDPD's Juvenile Administration Unit is representing our department during monthly planning meetings with other county law enforcement agencies in preparation for this event. The annual Shop with a Cop event will take place in December 2018.



**Teddy Bear Drive (3)** –The Teddy Bear Drive is an annual countywide law enforcement event designed to bring stuffed animals to children admitted at Rady Children’s Hospital. SDPD’s Juvenile Administration Unit is representing our department during monthly planning meetings and fund raising events throughout year.

**School Safety Patrol** –Juvenile Administration coordinates the School Safety Patrol for the City of San Diego. Seventy-nine elementary schools with approximately 1,800 SSP members participate in this program.

### **Community Outreach**

**School visits (6)** –Juvenile Administration officers conduct school visits and SSP inspections regarding the safe crossing of thousands of students and adults at elementary schools throughout the city.
