RESOLUTION CONSIDERING THE PROTESTS, APPROVING THE MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED ACTIVITIES, IN THE MATTER OF THE DOWNTOWN PROPERTY AND BUSINESS IMPROVEMENT DISTRICT


WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of the Downtown Property and Business Improvement District [PBID], under Resolution of Intention No. R-292718, adopted on February 1, 2000, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The assessment ballots returned in favor of the levy of the assessment for the PBID are greater than those returned in opposition.
2. The assessments described in Document No. RR- 292717-1, on file in the office of the City Clerk and on file in the office of Community and Economic Development, are hereby confirmed and approved.
3. The assessment district map for the Downtown Property and Business Improvement District, described in Document No. L-21 is hereby approved.

4. The activities described in said Resolution of Intention are hereby ordered to be performed and provided.



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and directed to execute, for and on behalf of the City, an agreement with the Downtown San Diego Partnership, for the administration of contracts for goods and services for the downtown Property & Business Improvement District, for a period of five years in accordance with California Streets & Highways Code section 36622, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-292797.

BE IT FURTHER RESOLVED that the expenditure of an amount not to exceed \$ 350,000 from Fund 70401 is hereby authorized, solely and exclusively for the purpose of providing funds for administration services with the Downtown San Diego partnership beginning July 1, 2000.
