REGISTRATION

- * Registration is taken on a first come, first serve, basis, online or in person. Phone or mail registration is not accepted.
- * When classes fill to capacity, waiting lists are formed. Classes *may* be expanded to accomodate additional students.
- * If classes do not meet minimum enrollment, they will be cancelled and a refund will be issued.
- * **PAYMENT METHOD**
 - Payment is required at the time of registration.
 - Payment methods taken at the Center are credit card or electronic check.
 - Online class registration from home requires credit card payment.
 - Credit cards accepted are VISA, MasterCard, American Express and Discover.
 - A fee will be charged for all returned checks.
 - Financial assistance is available. Please submit the application to the Recreation Center office one week prior to the start of registration.
 - Class fees are not prorated/discounted after the beginning of the scheduled session.

REFUND POLICY

Written refund applications must be submitted, using the Application for Miscellaneous Refund Form (COM-6), in person at the facility where the program occurs. Refunds will be processed in accordance with the following policy:

☐ **A 3.56% processing fee will be deducted from all refunds**

- No refund or transfer for non-attendance at any class
- No credits to account
- No refunds for costumes or equipment
- Activity fees less than \$10.00 will not be refunded

Classes:

Refund is based on the date that the written application is submitted.

- 96.5% refund – 3 or more calendar days prior to the first day of the class
- 75% refund - less than 3 calendar days prior to the first day of class
- No refund for requests submitted more than 24 hours after the first day of class

Camps: Refund is based on the date that the written application is submitted.

- 96.5% refund - 10 or more calendar days prior to the first day of camp
- 50% refund – less than 10 calendar days prior to the first day of camp
- No refund or transfer for requests less than 48 hours prior to the first day of camp .

THERAPEUTIC RECREATION SERVICES

All classes or programs can accommodate individuals with disabilities. Requests for this service must be made at least three weeks prior to the first day of the program. RECREATION CENTER & PARK INFORMATION

GYMNASIUM USAGE

A monthly gym schedule is available online for all free play activities. Times are subject to change without prior notification. **Drinks, food, and black soled shoes are prohibited from the gymnasium, no exceptions!** Open play schedule is available online at the beginning of each month.

OPEN BASKETBALL

Free play basketball is available both inside and outside on a first come, first serve basis until full court games are ready to play. See gym schedule for indoor free play hours. All ages are welcome.

OPEN VOLLEYBALL

Participants are required to set-up and break down nets and poles. See gym schedule for indoor free play hours. All ages are welcome.

OPEN BADMINTON & PICKLEBALL

Participants are required to set-up and break down nets and poles. See gym schedule for indoor free play badminton and pickleball hours. All ages are welcome.

No organized play, practice or instruction is allowed in the gymnasium without an approved permit.

FIELD USAGE

The Rancho Bernardo Fields are permitted to user groups who have approved insurance and a paid permit. Lights will be available for user groups with the same requirements. Youth groups will have priority before 6:00pm, and adult groups will have priority after 6:00pm. For availability & permitting call the Rancho Bernardo Recreation Center at (858) 538-8129.

AED

For patrons in cardiac arrest, an Automated External Defibrillator (AED) is located inside the building at Rancho Bernardo Recreation Center.



CONTRACTUAL PROGRAM OR, RENTAL PROGRAM

Rancho Bernardo Recreation Center will soon offer a variety of programs for youth & adults in the near future which are provided through the means of two different sources; Contractual programs and rental programs. Contractual programs consist of independent contractors that have been approved Through Parks & Recreation. Rental programs are commercial companies that rent out the facility to offer privately run programs and activities for the community. Please see below for specified requirements:

Requirements for Independent Contractors:

All contractors, sub-contractors and volunteers must be finger-printed through the City of San Diego Live Scan Process.

Contractors must submit a business license and proof of insurance. City staff handles all registration for the program. Contractors must provide Worker's compensation coverage for all their employees.

Requirements for Permit Holders/Rental Programs:

Must provide proof of insurance.

Must provide own advertisement for program.

Handles all registration for their programs.

Rental programs are NOT required to submit proof of fingerprinting for their coaches, volunteers and/or instructors.

Distributing registration and program information is the responsibility of each individual businesses. **Please contact them directly for all program inquiries.**

VOLUNTEER OPPORTUNITIES

Volunteers assist the City's workforce in enhancing services to the public by performing tasks beyond the capacity and scope of current City employees, including fundraising efforts. Volunteers are found supporting special populations; help with the success of various environmental, library, neighborhood youth and adult programs; and assist with parks and beach beautification projects. The City's volunteers represent the City's diversity; including seniors, minorities, students, professionals, families, active and non-active military, faith-based or community groups, to name a few.

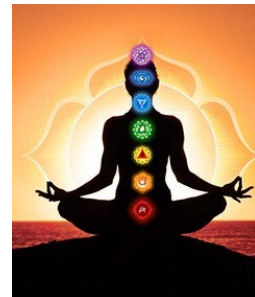
