2) Canyonside Assistant Recreation Center Director- Becky Lowndes reported that the Canyonside fields are still currently closed for rest/maintenance. Fields 1-5 will open for full use beginning Saturday, February 1st. Fields 6-9 will be dirt only at that time and will open fully on Tuesday, February 18th. Canyonside and Black Mountain Ranch will alternate in seasonal rest/maintenance closures; Canyonside will close in the Winter while BMR will close in the summer. The playground and parking lot project is well under way; the playground is almost complete and ready for inspections. The parking lot project is still under active construction and an opening date has not been established. Canyonside will be offering two new in-house programs this Spring: Lego Club on

Thursdays, and Mad Scientist Club on Tuesdays. The Second Annual Father Daughter Dance will be held at the Black Mountain Middle School on Friday, February 14th from 6:30 – 9:00pm; tickets are \$10 each.

- 3) **Hilltop Recreation Center Director** - Rex Cabanas reported that the Winter Wonderland Event was a great success; the rain deterred a lot of people but there were roughly 1,500 people at the event. The snow hill was much more organized and safe; staff received a lot of compliments on the layout. Staff have already discussed ways to improve the layout next year. The set-up of the hay bales was time-consuming; staff could use assistance in the future. The lights around the walking path at Hilltop Community Park went off due to some problems with the rain; city electricians have been working on repairs.
