2. Discussion Items

A. Sidewalk Vending Ordinance

- The City of San Diego's Sidewalk Vending Ordinance took effect on June 22, 2022.
- Multiple City Departments are involved in the implementation of the ordinance including Parks & Recreation, Office of the City Treasurer, and Development Services.
- Economic Development has contracted with the Logan Heights CDC and City Heights CDC to provide outreach, education, and technical assistance services to vendors.
- The Parks and Recreation Department reported on the success of their enforcement efforts in Balboa Park and referring vendors to community partners for technical assistance.
- Aspects of the Sidewalk Vending Ordinance will need to receive approval from the California Coastal Commission before they can be fully implemented. However, Parks and Recreation will be able to enforce elements of the ordinance such as leaving items on beaches overnight and blocking the public right of way.
- The Office of the City Treasurer is responsible for processing applications and issuing sidewalk vending permits. All vendors will also be required to have a City of San Diego Business Tax Certificate, Photo ID, as well as a State of California Seller's Permit.
- Vendors selling food items will also be required to have a Food Handler's Card and Health Permit issued by the County of San Diego.
- City Heights will engage with over 100 vendors in Council Districts 1,2, and 9 over the next two weeks with resources and workshops in collaboration with the Cook Alliance and Promotorias.
- B. LGBTQ+ Businesses in San Diego

Eddie Reynoso, Executive Director, Equality Business Alliance

- June 28, 2022 marks the 53rd Anniversary of the Stonewall Rights that started the LGBTQ+ Civil Rights Movement.
- The Equality Business Alliance is one of the fastest growing LGBTQ+ organizations I the country, and the largest in San Diego County with over 600 members.
- Eddie Reynoso highlighted the challenges facing LGBTQ+ business owners including 1/3 of LGBTQ+ business owners reporting they have lost 50% of their business due to the pandemic. Additionally, 35% of LGBTQ+ small business owners reported not being able to access COVID small business relief programs.
- Despite challenges related to the pandemic, Eddie Reynoso highlighted a number of successes the Equality Business Alliance has had including: becoming a founding member of the California LGBTQ Chamber of Commerce Alliance, planning a San Diego LGBTQ Economic Business Summit, and working to establish a bi-national regional chamber of commerce.
- Eddie Reynoso also covered the underinvestment by Federal agencies in minority businesses including LGBTQ+ owned `businesses.
- Eddie Reynoso advocated for the City of San Diego recognizing LGBTQ+ business enterprise certification from the National LGBT Chamber in procurement decisions and creating a plan to pass Proposition 209 standards in order to increase LGBTQ+ contract procurements at the municipal level.

3. Administrative Items

- A. Development Services Department Technical Advisory Committee Report
 - No report.
- B. Economic Development Department Staff Report
 - BID/MAD/PBIDs budgets have all been approved by Council ahead of the next fiscal year. This is an improvement from previous years when these budgets have not all been approved until after the new fiscal year has started.

- BID budgets were approved by Council on May 23. EDD be working on the 4th amendments and back up documents by July 1.
- This year EDD received an additional \$180k with a focus on those MAD administrators serving underserved communities. This will allow those MAD administrators to address the challenges that get in the way of providing mad services, such as excessive litter and health and safety issues.
- The North Park Special Enhancement District formation went to Economic Development and Intergovernmental Relations Committee on May 18. Ballots will be counted at Council on August 1 at 2:00 p.m. and will then take a vote on the approval of the formation.
- The Small Business Enhancement Program (SBEP) has been fully funded at \$2M for FY23, which is a substantial increase from previous years. This is the requirement of Council Policy 900-12.
