In exchange for use of a Wi-Fi Hotspot from the San Diego Public Library (Library), providing access to the Internet from your home, through the Wi-Fi Kit Due Date set forth above, you agree to the terms and conditions set forth in this Wi-Fi Kit Use Agreement (Agreement). The Wi-Fi Kit includes a device to create a Wi-Fi network (Hotspot), a charging cord, and a charger. By signing this Agreement and accepting the Wi-Fi Kit, you understand and agree that your use of the Wi-Fi Kit is subject to the following terms and conditions:

- ❖ I agree to view the Library's Wi-Fi Kit user video before Wi-Fi Kit check out.
- ❖ I agree to return the Kit in person to the **same** Library from which it was checked out by the due date. I understand it may not be renewed or returned in the bookdrop.
- ❖ If the Wi-Fi Kit is lost or not returned within 30 days after being due, I will be charged a fee of \$80 for the Hotspot, charging cord, charger and case; the service will be terminated and the Wi-Fi Kit will become unusable; and my library card privileges will be blocked until all items are returned in working order or the fine is paid.
- ❖ I understand that when accessing the Internet through the Hotspot, I am accessing the Internet through AT&T's network and not the Library's network. My use of the Hotspot is subject to AT&T's Acceptable Use Policy, Privacy Policy, and Terms of Use, all are available on AT&T's website (<https://www.att.com/legal/terms.aup.html>).
- ❖ I understand that the Library is not responsible for any files, data, or personal information accessed/transmitted using the Wi-Fi Kit.
- ❖ I understand that the Hotspot uses AT&T's content filter. It is meant to restrict access to questionable websites. I understand, however, that no filter can protect against all objectionable sites, and it is my responsibility to monitor and determine what is appropriate for myself.
- ❖ I understand the Wi-Fi Kit and its contents remains the Library's property at all times.
- ❖ I agree I will **never** loan out any items in the Wi-Fi Kit to other individuals.
- ❖ I agree to know where all items in the Wi-Fi Kit are at all times. I will agree to not disassemble or attempt to repair the Hotspot.
- ❖ I agree to take care of the Hotspot and will use reasonable efforts to avoid damaging the Hotspot. If any item in the kit is lost, stolen, or damaged, I agree to notify the library where it was checked out. I understand that the Library may choose not to repair or replace the Wi-Fi Kit at its sole discretion.
- ❖ I agree to return the Kit and all parts and packaging to the library in good working condition. I must remain present as the Library staff checks in the Wi-Fi Kit.
- ❖ I understand that the Library may decide not to allow me additional periods of use of the Wi-Fi Kit
- ❖ I agree that the Library, its funders and other third parties selected by the Library may use any and all information collected about the usage of the Wi-Fi Kit that I have borrowed to research, track and analyze the results and the effectiveness of the Wi-Fi Kit program. By borrowing the Wi-Fi Kit, I consent to the Library contacting me about my use and my Wi-Fi Kit experience.
