#### **Significant Events & Statistics for CY 23 to date** (Continuing 250% Increase in Illicit Maritime Activity over Last 2 Years along MBL with No Significant Increase in Mission Support)

#### <u>Command Advisory Staff</u>: Public Affairs & Distinguished Visitors / Community Engagements:

- Hosted 65 events for strategic partnerships and community engagements to include: DOD's Joint Civilian Orientation Conference,
- multiple foreign delegations (Israel, South Korea, Germany, Austria, Peru), Drug Control Policy execs, and 10 recruiting events
- San Diego is designated as America's largest Coast Guard City.

### Joint Harbor Operations Center (JHOC):

A premier example of DHS cooperation with Federal, State, and local maritime stakeholders. Provides Command & Control capability for region with physical collocation of CG, BP, SD Harbor Police, and California National Guard Counter-Drug Program.

#### Sector Intelligence:

Generated 220 Field Intelligence Reports (most of any Sector), provided 52 in-chop briefs to visiting cutters/crews, provided critical analytic to the ReCoM Intelligence Group, analyzing over 2,777 sighting reports to improve Maritime Domain Awareness.

### **Emergency Management Force Readiness:**

- Led Area Maritime Security Committee oversight of \$1.6M in grants awarded to the San Diego region for four security enhancements to safeguard facilities and the Tier-1 Strategic Port of San Diego.
- Certified 24 new ICS qualifications and executed 12 different exercises covering Mass Migration/Mass Rescue Operations, various natural disasters, oil spills, and the Unmanned Surface Vessel threat.
- Managed 143 Reservists and oversaw the activation of 30 members in support of four different national emergencies.

#### **Prevention**:

- Conducted 114 Foreign Vessel Exams, 10 Facility Safety and MTSA Inspections, and supervised 15 Explosive Load Outs.
- Conducted 1076 Domestic Vessel inspections, incl Tier 1 SPVs.
- Approved 115 Marine Event Permits; published 6 Safety/Security Zones & Special Local Regulations including SEAR 2 Big Bay Boom Marine event; largest fireworks display on west coast.
- Conducted 140 Marine Casualty Investigations, issued 03 LOW (in lieu of S&R), 3 NOVs, & 40 Suspension & Revocation activities; conducted preliminary investigations for 22 illegal charters.
- Completed three investigations into illegal discharge of oily bilge water on deep draft vessels resulting in two felony convictions, \$1.1M fine and 1 year in prison for one case. Two other cases have ongoing criminal investigations.

### Prevention (Cont.):

- Illegal charter Operation Afternoon Delight: 30 weekends of support, 120 patrol hours. Prosecuted 60+ boardings from STA SD resulting in 7 enforcement actions against operators.
- Administered Alternate Compliance Program for three NASSCO-built MSC vessels scheduled to deliver in CY22/early CY23; valued at \$2 Billion.

#### Response:

- Prosecuted 219 SAR cases: 182 lives saved, 482 lives assisted, ~\$563K in property saved, and \$3.17M in property assisted.
- Supported CCR ReCoMs to seize 1,200 lbs of narcotics (street value of \$10M) & apprehend 2,100 undocumented non-citizens/smugglers.
- Daily Maritime Boundary Line Operations: (WMECs, WPBs, FRCs, Station, SBT, MSRT-W, MSSTs), including patrols by SBT in Eastern AOR w/ National Park Service and state LE partners.
- IMD responded to 204 cases, yielding 11 Federalized cases (\$87k project costs) and 10,128 gallons of pollutants removed.
- Led 15 multi-day ReCoM operations to combat Transnational Crime Organizations in the CCR; 10% increase in apprehensions and 110% increase in deterred smuggling vessels.
- The Southern California Maritime Domain Awareness Innovation Cell: groundbreaking initiative to fuse together DHS, tech industry and academia; resulting in 50 mission enhancing technology tests.

### Logistics & Engineering:

- Facilities Engineering maintained a 154,000 square foot campus on 28 acres across three sites to include pre-World War 2 buildings.
- Naval Engineering provided troubleshooting and repairs to six subunits & visiting cutters, supported PACAREA AUF deployments and conducted surface unit inspections incl RFO, TSTA and SMART.
- Aviation Engineering maintained aircraft while crewing every operational mission with the same personnel. 32,000 hrs of labor produced fleet-leading flight hours flown amongst equivalent units. Was the only aviation unit to support critical USCG fast roping and aerial gunnery capabilities.
- Produced the Military Times Coast Guard Member of the Year, AST1 Josh Carlson, who was meritoriously advanced at CGHQ by the Commandant for his heroic rescues and outstanding performance.
