## SIDE LETTER AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND

 CALIFORNIA TEAMSTERS LOCAL 911 ESTABLISHING JUNETEENTH AS A CITY HOLIDAYPursuant to the provisions of the Meyers-Milias-Brown Act (MMBA) and Council Policy 300-06, this Side Letter Agreement (Agreement) is entered into between the City of San Diego (City) and the California Teamsters Local 911 (Local 911) to amend Article 45 of the Memorandum of Understanding (MOU) between the City and Local 911 approved by San Diego Resolution R-314186 dated June 23, 2022. The City and Local 911 are collectively referred to as the "Parties."

Juneteenth commemorates June 19, 1865 as the date enslaved Black Americans in Galveston, Texas finally received news of their freedom more than two years after the Emancipation Proclamation was issued by President Abraham Lincoln on January 1, 1863.

President Joe Biden signed Senate Bill 475 on June 17, 2021, establishing Juneteenth as a federal holiday, and Governor Gavin Newsom signed Assembly Bill 1655 on September 29, 2022, establishing Juneteenth as a state holiday.

The City recognizes the significance of Juneteenth to a City that strongly upholds diversity, equality, and freedom among employees and constituents. Therefore, Mayor Todd Gloria recommends establishing Juneteenth as a City holiday effective June 19, 2023.

The Parties agree to the following:

1. The Parties have satisfied all obligations under the MMBA, Council Policy 300-06, and other applicable law and regulations to meet and confer in good faith on the subject of this Agreement.
2. The Parties agree to amend sections A(1) and A(2) of Article 45 of the MOU as follows:
"A. Fixed Holidays.
3. Fixed Holidays will be:
a. January 1;
b. Third Monday in January, known as "Dr. Martin Luther King Jr.'s Birthday;";
c. Third Monday in February, known as "Presidents' Day;";
d. March 31, known as "Cesar Chavez Day;";
e. Last Monday in May, known as "Memorial Day;";
f. June 19, known as "Juneteenth";
fg. July 4;
gh. First Monday in September known as "Labor Day;";
hi. November 11, known as "Veteran's ${ }^{-}$Day;";
ij. Fourth Thursday in November, known as "Thanksgiving Day;";
jk. December 25; and
kl. Every day appointed by City Council for a public fast, thanksgiving or holiday.
4. If January 1, March 31, June 19, July 4, November 11, or December 25 falls upon a Sunday, the Monday following is the City-observed holiday. If any of the

dates listed in this section fall on a Saturday, the preceding Friday is the Cityobserved holiday."
3. The City will take all necessary actions to amend San Diego Municipal Code section 21.0104 and Personnel Manual Index Code H-2 to establish Juneteenth as a City holiday.
4. Unless expressly covered in this Agreement, all wages, hours and other terms and conditions of employment presently enjoyed by Local 911-represented employees, whether stated in an MOU, Personnel Regulation, Administrative Regulation or in any other enforceable document, remain in full force and effect.
5. This Agreement is not binding on the Parties until it is approved by a two -thirds vote of the City Council, in accordance with San Diego Charter section 11.2.
