An Amendment to the City's Municipal Code and Local Coastal Program to Include Regulations for Home Share and Short Term Residential Occupancy and Approve the Establishment of a Fee to Provide Full Cost Recovery for Permitting and Enforcement Costs.

Proposal 1 Short Term Residential Occupancy (O-2018-60); or Proposal 2 Short Term Residential Occupancy (O-2018-61 Cor. Copy) (Rev.12/8/17)

Proposed code amendments to the City's Municipal Code (Chapter 5, Article 6, Division 00; Chapter 9, Article 8, Division 6; Chapter 11, Article 3, Division 1; Chapter 12, Article 3; Chapter 12, Article 6, Division 2; Chapter 12, Article 6, Division 3; Chapter 12, Article 9, Division 2; Chapter 12, Article 9, Division 7; Chapter 13, Article 1, Division 2; Chapter 13, Article 1, Division 3; Chapter 13, Article 1, Division 4; Chapter 13, Article 1, Division 5; Chapter 13, Article 1, Division 6; Chapter 13, Article 2, Division 15; Chapter 14, Article 1, Division 3; Chapter 14, Article 1, Division 6; Chapter 14, Article 2, Division 5; Chapter 15, Article 1, Division 1; Chapter 15, Article 4, Division 4; Chapter 15, Article 5, Division 2; Chapter 15, Article 6, Division 3; Chapter 15, Article 7, Division 4; Chapter 15, Article 9, Division 4; Chapter 15, Article 10, Division 3) and Local Coastal Program relating to home share and short term residential occupancy uses will be presented.

Ordinances will be introduced that create two separate uses, home share and short term residential occupancy (whole home use). The ordinances amend the Municipal Code to include home share and short term residential occupancy and repeal boarder and lodger accommodations

uses. Proposal 2 repeals bed and breakfast use. The amendments include requirements for property ownership. Additionally, the amendments outline zones where short term residential occupancy uses are permitted, permitted with limited use regulations, permitted with neighborhood use regulations, and when companion units may be used for short term residential occupancy. Additionally, the amendments create requirements for an annual permit and a posted public notice, establish minimum consecutive days and maximum number of days per year allowed for short term occupancy, and create an occupant notice requirement that includes the procedure for contacting the responsible person and notifies occupants of regulations regarding parking, trash, safety, noise, and occupancy limits. The proposed home share regulations include zones where home share is permitted and those zones with limited use regulations and when companion units may be used for home share. Additionally, the amendments create requirements for an annual permit and posted public notice, and create an occupancy notice that includes the procedure for contacting the responsible person residing in the dwelling unit during the residential occupancy and notifies occupants of regulations regarding parking, trash, safety, noise, and occupancy limits.
