SUBJECT:	Short-Term Residential Occupancy Lottery – Tier 3 and Tier 4 Good Actor Prioritization Clarification

On January 7, 2022, the Office of the City Treasurer issued a Short-Term Residential Occupancy (STRO) memo for Tier 3 and Tier 4 licenses to City Council that incorporates prioritization of *good actors*. Subsequent to the issuance of the memo, our office has received various inquiries from STRO hosts regarding the assignment of priority points, specifically as it relates to how calendar year and previous periods are defined. This memo clarifies our original intent to assign the highest priority points to Hosts actively participating in the industry and who satisfy the criteria of a *good actor*, as defined by City Council.

The previous memo provides criteria points that are assigned based on a calendar year. A calendar year is typically defined as twelve (12) consecutive months commencing on January 1 through December 31. However, given that full certification from the California Coastal Commission is not anticipated until this coming fall, using only prior calendar years ignores the most recent, relevant activity. To ensure that all activity immediately preceding the application period is considered and the intent of the original memo is fulfilled, the table below replaces "calendar year" with "previous year." Previous year, as used for purposes of priority point eligibility, is defined as the previous twelve (12) month period. The table is also updated to clarify that the preceding period(s) will be evaluated consecutively.

A maximum of 10 priority points will be granted to eligible applicants who meet the criteria below as follows:

Criteria	Priority Weight Point
Hosts in compliance with Transient Occupancy Tax (TOT) registration requirement as of STRO Ordinance First Reading (February 23, 2021).	1
Hosts with verifiable proof of more than 90 days of booking activity during the previous consecutive ( <b>maximum of 3 points</b> ):	
a. One (1) to two (2) year(s); <u>or</u>	1
b. More than two (2) years but less than five (5) years; <u>or</u>	2
c. Five (5) years or more.	3

Hosts with verifiable proof of payment of Transient Occupancy Tax (TOT) during the previous consecutive ( <u>maximum of 3</u> <u>points</u> ):	
a. One (1) to two (2) year(s); or	1
b. More than two (2) years but less than five (5) years; <u>or</u>	2
c. Five (5) years or more.	3
Hosts operating during the previous two (2) years and have no verifiable code violations during the previous two (2) years.	3
Maximum Weight Possible	10

As an example, if the license application period opens in September 2022, the previous year will be September 1, 2021 through August 31, 2022.

The intent of priority points is to improve the probability for *good actors* while still providing newcomers an opportunity to obtain a license. The assignment of priority points will not guarantee a license.
