How to Submit STRO Host Quarterly Reports for Tier 3 & Tier 4



Important: Hosts with a Tier 1 or Tier 2 License are not required to submit quarterly reports.

The Application period for Tier 4 has closed. The application period for Tier 1, 2 & 3 are open. It is unlawful to operate a STRO without a STRO License on or after May 1st, 2023.

The first required quarterly report for calendar year 2023 quarter two (May - June) for Tier 3 and Tier 4 hosts is due no later than Monday, July 31, 2023. Additional information on how to submit the host quarterly reporting can be found in the <u>Host Operating Requirements</u> section on the <u>STRO Website</u>.
