Honored Mayor and Friend:

SUBJECT: A \$25,000 SWIMMING POOL AS ONE UNEMPLOYMENT PROJECT

This is a project which has within itself the possibility of reaching and serving more people, young and old, of both sexes, to a far greater extent than any recreation item in our City program. Only one-tenth of our people use beaches for swimming. Only a very small percent of our 25,000 school children have access to existing pools.

WHO IS INTERESTED?

The parents of thousands of young people are interested. Scores of Parent-Teacher Association groups, several civic groups and many improvement clubs, have expressed interest and a desire for such equipment. A group headed by Ed. Fletcher and the Northeast San Diego combined communities are very anxhous for swimming facilities. The Playground Commission has recognized the lack of a municipal pool to be our greatest weakness compared with cities of like size. The Mission Valley Swimming "Puddle" opened temporarily this last summer, and often had a daily attendance of 1,000 people and averaged over 125 per day for seven weeks.

LOCATION - COST - SUPERVISION -- MOSTLY COMMON LABOR

There would be no controversy about location if we would use the north end of Balboa Park as per the Nolan Plan. The necessity of a large auto parking area makes this the best location by far. Much of the cost of construction would be for common labor for excavating and trenching for mains, etc. Twenty-five to Thirty thousand dollars would build a 100 x 50 pool--filtration system included, and adequate dressing rooms. The Playground and Recreation Department could develop more complete facilities gradually and it is logical under our new Charter for this Department to have complete

supervision of all City recreational facilities.

POPULARITY OF NEW POOL WOULD EXCEED THAT OF GOLF COURSES

When I make this statement, it is unprejudiced (because I personally like golf better). I have observed and listened for three years, having very frequent contact with parents and young people in schools and Parent Teacher organizations, and there is absolutely nothing which would enjoy such popular approval.

I, therefore, alone, without a big stir of public support, submit this proposition on its merit for your earnest consideration as a very timely and valuable project of interest to City Officials and citizens.
