### ADVISAL AND CONSENT

With your consent, a Police Detective/Officer with the City of San Diego Police Department would like to collect from you a saliva sample for the purpose of DNA analysis. The saliva sample will be collected from the inner cheek with a sterile cotton swab. You have the right to refuse to consent and not have your body searched without a search warrant. You also have the right to privately consult with an attorney, parent, or legal guardian prior to providing consent. Your sample will not be searched, analyzed, or compared to DNA samples or profiles in the investigation of crimes other than the investigation(s) for which it is taken, unless permitted by court order. If you consent and a sample is taken, you have the right to request expungement of your sample.

I, \_\_\_\_\_, have been informed of my constitutional right not to have a search made of my body without a search warrant, of my right to refuse consent to such a search, and of my right to consult with an attorney, parent, or legal guardian prior to providing consent to such a search.

I hereby authorize Detective/Officer: \_\_\_\_\_, a Police Detective/Officer of the City of San Diego, California, to conduct a limited search of my body, to include the collection of saliva for the purpose of DNA analysis. The Detective/Officer is authorized by me to collect said saliva. I have been informed of my right to request expungement of the sample collected, and have received the DNA Expungement Application Form.

This written permission is being given by me to the above named Detective/Officer voluntarily and without coercion, threats or promises of any kind.

**The Advisal was read to the subject juvenile and the juvenile’s attorney, parent or legal guardian prior to the juvenile’s consent. The attorney, parent or legal guardian was allowed to privately consult with the juvenile, and, after that consultation, concurred with the juvenile’s decision to consent.**
