### **USE OF THE NEW STANDARDIZED AUTO THEFT REPORTING ADDENDUM**

**This Training Bulletin supersedes and incorporates Training Bulletin 21-02 for renewal purposes without substantive change.**

#### **I. PURPOSE**

The purpose of this bulletin is to provide information and direction on the newly implemented Auto Theft Reporting Addendum (Addendum).

#### **II. BACKGROUND**

The lack of detailed documentation in auto theft investigations has historically caused difficulties prosecuting auto theft cases. In many cases vehicles that are reported stolen can quickly be disproven (owner forgot where they parked, vehicle was illegally parked or repossessed, a family member has the vehicle, etc.). Before the vehicle is entered into the Stolen Vehicle System a set of standardized questions will be required to be asked by the investigating officer. The Department is implementing a standardized Addendum questionnaire.

The new Addendum provides a Department wide standardized investigative process and set of questions for officers conducting auto theft investigations. The Addendum also eliminates the use of division-specific templates.

#### **III. PROCEDURE**

During the preliminary investigation, the officer will interview the victim and witness(s) about the auto theft. During the interview, the investigating officer will use the questions on the Addendum. The investigating officer will then use the Addendum to document the victim/witness(s) responses.

If the victim answers yes to any of the first four questions, the vehicle may not be considered stolen. The investigating officer must contact their respective divisional auto theft detective or area investigative unit supervisor for guidance.

**SYNOPSIS:** *(Be sure to include elements of the crime, e.g.: did the suspect take the vehicle without permission with the intent to temporarily or permanently deprive)*
