    assembled. Also check out my proposal for lobbying reform that will
    stop lobbyists from build careers on testifying at bodies like this one

- without disclosing that they're getting paid stop the lobbyists pretending to be "part-time community volunteers"! Call me at 858-210-7999. Love to hear from you!
- Jeffrey Burges, neighborhood on Mira Montana, leading the fight against the Villa Montana development proposed for two homes on a lot split for two 4000+ sq ft lots. They support a 6000, or a 5000 w/ granny flat, but three stories each on this lot split is pretty nonconforming. (Troy did advise the PRC special meeting for October 15 will be regarding this project, Susan posted special agenda in chat.)
- Durango development is also three stories, PRC is aware of this.
- Judy Strang reported the Planning Commission meeting last week (October 1) disregarded the CPC's recommendation on the CEQA appeal process being dropped from 10 days to 5 days. Suggestion to share the concern with the city council as the Planning Commission is not elected, nor are all districts represented.
- Joe LaCava joined later in the meeting, and we adjusted to allow his comments in this section of our agenda. Grass roots community funding for his campaign. Joe saw a map of short-term full-home rentals for our area and there are a lot. Short-term vacation rentals had a big hearing and Joe attended. City staff has been asked to come back with more information which means this item will go to the next council, post-election.

- D. Modifications to the agenda (none): Motion to Approve the Agenda passed unanimously, 10-0.

# **ACTION ITEMS (Note: no projects to review this meeting):**

- 1. Action to approve past meeting minutes, Thursday, September 10, 2020 Motion to approve passed, 7-0.
- Discussion of moving meeting to better coordinate with larger CPC meeting, so we can discuss. Third Thursday considered, but formal CPC agenda not issued in that time frame. We will wait until after the election to confirm our representatives can attend, and that Wally/CPC can give us agenda items, or expected agenda by that time. No conflicts with

members in attendance or with Miller Saltzman (who will be unimpacted by election). Will lock at a future meeting, thinking January would be a good start.

- 3. Board member recruitment, need to increase, fill the open seats (2), great place to launch a political career. Pratima Gupta asked about outreach efforts. Susan pointed out (see above grid) we have 2 vacancies, 4 members whose terms will be up, and with the pandemic we may well find it easiest to simply fill the seats again with one-year appointments. The two current empty ones can be filled at any time, as long as the proposed member attends 3 meetings. Please reach out to Troy for more information.
- 4. SANDAG Rail Realignment Sub Committee Eduardo and Jim are working on getting someone in to present an updated rail alignment so we can knowledgeable discuss this very important issue. Liz also mentioned the petitions available online regarding the proposed fencing of the railroad tracks.
- 5. Local Traffic Issues, concerns for various issues, looking for updates on DM Heights, Mango, and a concern for the narrowing of Carmel Valley Rd WB as you get to Pointe Del Mar where bicyclists can be crowded off the road. Carmel Valley was just re-slurried in the last two weeks and new painting is about to happen. Moriah is going to try and get the TPCPB plans to confirm. Jim would like a little more feedback from traffic as regards the process—things do tend to go into a black hole. Moriah let us know that the City is well aware of some short or "closed ticket" responses in Get It Done and it is under discussion. Traffic is in the middle of a traffic calming/stop sign/parking restrictions (Mango: less parking, more red zone space to get a second drive lane. Portofino Circle North: possible stop sign, after traffic calming measures were rejected—different study.) There should be some responses mid-October. Slurry seal/restriping causing safety concerns. Will be complete October 23.
