<u>Total Estimated Cost of Proposed Action and Funding Source:</u>

There are no expenditures being authorized with this action.

Council District(s) Affected: 3.

Proposed Actions:

This action is an amendment to the North Park Community Plan and General Plan, and a rezone from RS-1-7 (Residential-Single Unit) to RM-3-7 (Residential-Multiple Unit). During the 2016 North Park Community Plan Update process, 3.53 acres of land located along the east side of Florida Street (from Upas Street to Cypress Avenue) was redesignated from Residential Medium-High (30 to 45 dwelling units

per acre) to Residential Low (5 to 9 dwelling units per acre) and downzoned to RS-1-7 (Residential-Single Unit).
