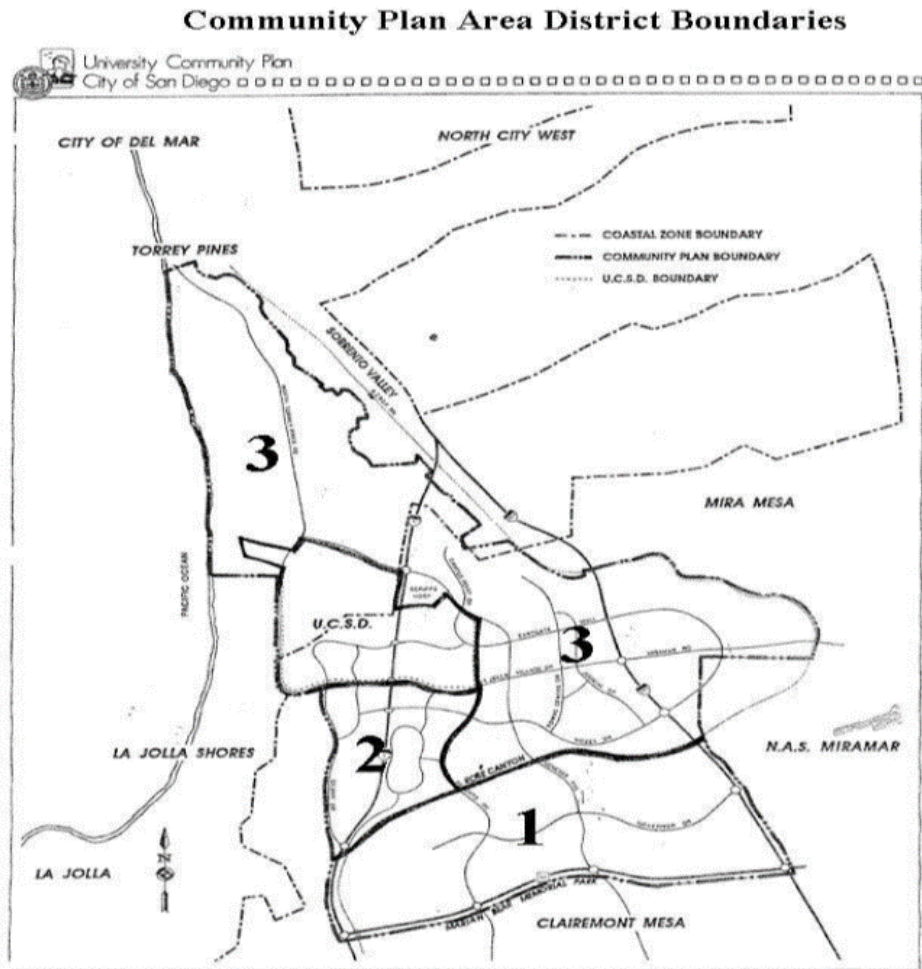
UNIVERSITY COMMUNITY PLAN UPDATE SUBCOMMITTEE (CPUS)

What does a subcommittee do?

- Subcommittee of the University Community Planning Group (UCPG)
- Serve as a liaison to the various community stakeholders
- Provide the city with feedback
- Advisory recommendations to the UCPG throughout the CPU process

ELIGIBILITY

Who will be on the subcommittee?



- 19 members total
- 10 members from planning group
 - 1 member from each residential and business district (6 total)
 - 1 UCSD member from each: Faculty/Staff, Student, Administration
 - 1 MCAS Miramar member
- 6 members from community
 - Application required
 - If more than 3 applications from each category, selection by lottery
- 3 members from community/business organizations
 - Friends of Rose Canyon
 - University City Community Association
 - Biocom

Who can join the subcommittee as a community member?

At least 18 years of age and affiliated with the University community as a:

- Property owner or designee
- Resident
- Local business person, owner, operator or designee

❖ *One application per individual*



Subcommittee Members

- Subcommittee will hold 6 meetings per year (tentative, e.g. every other month)
- Meetings will be open to public (subject to the Brown Act)
- Complete online Community Orientation Workshop training



University Planning Group

- October 2018
 - Vote to form a Community Plan Update Subcommittee
 - Appoint 10 board members to the Subcommittee

Community Members

- October 2018
 - Submit an application to join the Subcommittee
 - Attend the October University Community Planning Group meeting

Subcommittee Meetings

- First meeting – November 2018 (Tentative)
