A. Discussion: PDOs & Ministerial Concerns - Info (6:07 -6:pm)

Informational discussion on the Planned District Ordinances (PDO) formerly used in zoning, and potential relevance to current concerns with projects processed as ministerial (City staff decision, no community input) decisions. Discussion leads: Pat Sexton, Peter Hill

Hill, Presenter: PDOs were controlling until the CPU in 2016. PDOs had style palates. What do we feel could be changed? We aren't asking to pull things from ministerial, we are asking to bring them back to LDC.

Steppke remembers PDOs as having density specs, not styles.

Vidales: They were a reaction to short-comings of the 1986 Community Plan.

Steppke: PDOs were a reaction to City of Villages guiding density and how to group things together.

Hill: What can we get into the LDC that's relevant to the whole City to focus on the facades? How were facades regulated through PDOs and how can we get that back into LDC?

CPs are a vision document, not code.

Vidales: Cite the community Plan

Gebrelassie: Look at both sides of the project and see if it fits into surroundings.

Pat: Elizabeth Ocampo said that for something like this to take effect is PDOs need to be reimplemented in North Park.

In the old CP, zones were established, and each zone had a style in which you have to build.

Vidales: Go through the code to change the way that remodels are getting taken advantage of. When there is a remodel it should be discretionary.

Stayner: Until there is a specific problem identified, there is no solution to ask for.

Steppke: There has to be a community push or sentiment, and that's going to be difficult to gain that support from North Park.

Hill: We need examples of projects that are causing the problems. Need to find PDOs to see what style guides were given.
