- 1. New Joint Use Dog Park Park Planner Shannon Scoggins shared a presentation on the proposed Ed Center Temporary Off Leash Dog Park. A review of questions and answers:
 - Shannon Scoggins reported the City will have a license agreement with SDUSD to use the Ed Center turf area for the new temporary off leash dog park.
 - Melinda Pajak stated she is a responsible dog owner and encourages off leash dog areas to be grass.
 - Sol Schumer asked why the long path entrance on the north side of the off-leash dog park? Why can't the entrance be on the south side? Shannon Scoggins responded when the slope survey was conducted, the north side has less of a slope then the south side, but her team would survey the area again.
