**Old Trolley Barn Neighborhood Park** – Michele reported that the collection of debris in Old Trolley Barn Neighborhood Park has been cleared out. Ernie Bonn stated to use Goo-Gone for superficial repairs on plexiglass, not other chemicals. Ernie Bonn still needs to get a key to replace plexiglass- will arrange with Michele. 4. Approval of North Park and Presidio Recreation FY24 Budgets – Michele reported that the budgets shouldn't have been sent to other CRGs. Ernie Bonn asked if any additional money was needed. Michele reported that maintenance will be handled by the City and that there is no need for additional money from the Community Recreation Group.
