Weather-Based Irrigation Controller Rebate Application

Weather-Based Irrigation Controllers will have to be picked up during the event.

- Funding for rebate program is limited and available on a first-come, first served basis. Program requirements are subject to change without prior notification. You must be present at the event to receive a controller.
- Rebates are available to customers within the City of San Diego Public Utilities Department service area. Renters may be eligible for rebates with written consent of property owner. Renter's name must be on water bill.
- Pictures of the current controller or manual irrigation must be emailed after installation to waterconservationrebates@sandiego.gov.
- Rebate checks will be sent to the customer of record approximately 12 weeks after application is deemed complete if a controller is purchased from the vendor.
- The City of San Diego is not responsible for any taxes, fees, or tariffs that may be imposed that result from a rebate-related device purchase or work performed. You may receive a Form 1099 from the City for the rebate you receive. Please consult with a tax advisor for questions regarding potential tax implications of the rebate. [W-9 Information.](#)

Applicant Agreement

I, the undersigned, understand that this is a limited first-come, first served program, that rebates are given only for projects which have applications that are approved, and the City of San Diego Public Utilities Department (Public Utilities) can deny any application that does not meet program requirements (which may change without notification). I have voluntarily determined to participate in the City of San Diego's Outdoor Conservation Rebate Program and understand that no rebate will exceed the cost of the item purchased or exceed the stated maximum total dollar amount per customer rebate. I understand that my Public Utilities account must be in good standing to receive a rebate check. I agree that all work performed will comply with applicable State and local laws, ordinances, and regulations. If this application is approved, I agree that Public Utilities Water Conservation staff may conduct a post-installation site visit at my property, and verify that the project has been completed according to program requirements.

I understand that proper installation of the controller is my responsibility, as is determination of the adequacy and compatibility of the adjacent landscape and surrounding area. I understand that with a post-installation visit, Public Utilities makes no determination with respect to choice, quality or suitability of workmanship, materials or equipment. I acknowledge that installation of a weather based irrigation controller may not result in lower water bills, and that rebates do not apply to sales tax charges. If a rebate for a weather based controller has been issued in the last five years, I agree to return the device or to pay Public Utilities the rebate value.

I understand that project site shall be available for future monitoring (up to three years) by Public Utilities. Addresses to project sites participating in the rebate program will be available to the public. Customer names will not be made public nor associated with the site addresses. I understand that Public Utilities is not responsible for items lost or destroyed in the mail/transit or email. I understand I may receive a form 1099 from the City for my rebate.

If this application is approved by Public Utilities, I agree to defend, indemnify, and hold harmless the City of San Diego, their agents, officers and employees against any and all loss, liability, expense, claims, suits and damages, arising out of or resulting from the Program and/or installation of the irrigation controller. I have read, understand, and agree to the terms and conditions of this application and the rebate for which I am applying.
