The score for citywide Trust for November was 69. Among all nine divisions, trust was highest for the Northeastern Division (77) and lowest for the Southeastern Division (60).

The score for citywide Safety for November was 70. Among all nine divisions, safety was highest for the Northwestern Division (76) and lowest for the Central Division (60).

Citywide, the top concern was Streets & Traffic (24%), followed by Homelessness (22%) and Theft, Burglaries & Break-Ins (21%).
